i) Conner Matthew Neely, age 17 of Redlands, who designed and installed a garden for the kindergarten students at Simpson Elementary school in Rialto for his Eagle Scout project.

ii) Derek William Cranfill, age 17 of Redlands, whose Eagle Scout project was to locate all veteran gravesites in Hillside Memorial Park. This was done by walking the cemetery and identifying headstones. GPS coordinates, headstone photos and relevant information about the veteran were collected on the spot and directly input into a database at the City of Redlands. This project took a year to complete.

iii) Patrick Bruce Cranfill, age 17 of Redlands, whose Eagle Scout project was refurbishing trash can receptacles at a local city park by replacing rotten wood frames and old hardware with new Trex-like wood planks and new hardware.

I believe we will receive a report of this Court of Honor from Brother Doyle PCC for the next issue of the Stoneman Dispatch in January.

After a short business meeting for the Camp and the Charter presentation, the Department Commander installed the Officers of the new Baker Camp 31.

In 2011 when General Stoneman Camp 18 was presented its Charter, the Brothers of Generals Sedgwick-Granger Camp 17 of Orange County presented Camp 18 with a check in the amount \$300.00 dollars to get the camp started with a small bank account. At the Stoneman October Camp meeting, the Brothers voted to pay that start-up fund forward and present Baker Camp 31 with a check in the amount of \$300.

This camp formation is the culmination of efforts by the members dating back to its first organizational meeting on 10/6/18. The initial camp organizer, Michael Gravitt was instrumental in laying the foundation for the camp. Unfortunately, in early 2019, Michael was forced to step down and the camp was close to becoming nothing more than a dream. Camp 25 member, and SVR 6th Military District Chief of Staff Dr. Wayne L. Eder who lives in the Henderson area stepped in as Camp Organizer and began working closely with Department staff to make everything work. An organizational meeting was held on June 6, 2019, bylaws approved, officer's elected, and payment for the charter submitted. Now, a little over one year after the initial meeting, Camp 31 is official.

Death of last Union soldiers ends Organization

The newspaper obituary pages today all too often list the deaths of the few remaining members of the Greatest Generation, especially the men who once wore military uniforms and saved the world in World War II.

Ironically, when those seniors were just young men fighting in Europe and in the Pacific, the rolls of another group of aged soldiers were also quickly declining.

Just days before the end of fighting in World War II, residents in Pomona lamented the death of 99year-old Johnson Knight, the last remaining local resident who had fought in the Civil War.

The Pomona Progress-Bulletin on April 27, 1945, announced Knight's death from the night before, noting that it also closed the door on an organization known as the Grand Army of the Republic.

For almost six decades, the National GAR, with chapters in Pomona, San Bernardino and Ontario, had been where old Union veterans could get together, assist their fellow soldiers, and march every year in the annual Decoration Day parade in each city.

Knight at the time of his death was the commander and the only member of the Vicksburg Post No. 61 of the GAR, according to the article.

Two years earlier, the death of William C. Clark, 97, the last member of San Bernardino's Cornman Post No. 57 of the GAR was mourned. In 1937, the passing of Alois Podrasnik, 92, closed the roster of Civil War vets in Ontario Post No. 124.

All three were local leaders of the organization, founded in Springfield, Illinois shortly after the end of the Civil War. At its height, about 1890, there were more than 400,000 former Union soldiers in Posts through-out the Nation.

Both the San Bernardino and Pomona Posts were formed in 1884, while members of both assembled in 1886 to institute the Ontario Post. Most Posts had associated with it the Women's Relief Corps, a type of auxiliary that supported its activities.

The most prominent role taken by the GAR was the creation of what today is Memorial Day. It was originally designated as Decoration Day to decorate the graves of those who fought for the Union during the Civil War.

Many northern cities held parades on that date

usually highlighted by lines of Civil War veterans marching along, resplendent with their long beards and coats with medals and remembrances of their war time achievements.

But as years passed, the number of marchers dwindled. In 1933 only two of six members of the Cornman Post were able to walk the block long route in San Bernardino. In Pomona, in 1938, the few GAR members remaining only watched from a viewing stand.

The GAR and its affiliates helped create statues and monuments to the achievements of their members. On Decoration Day 1908, a memorial to Union Veterans and the GAR was created at what was then the entrance to Bellevue Cemetery in Ontario. It was sponsored by the Women's Relief Corps which held a number of events to raise money.

The rock memorial included a cannon as well as a copper Civil War Infantryman statue that has since been removed. The statue, victimized by vandals, was pulled off many years ago but will soon be part of the Civil War exhibit opened in the mausoleum at the cemetery.

In October 1930, Podrasnik of San Antonio Heights, reportedly the last remaining former Union officer living in Southern California, suggested to the GAR veterans in Ontario and Pomona that a "Last Man's Club" be created.

There were 12 original members, from Pomona, Ontario, Chino, Upland and San Antonio Heights, who agreed to meet each year and toast the members who had passed in the previous 12 months. The last surviving member would finally drink a toast to them all, using a special bottle of wine provided by Podrasnik.

By 1937 only Podrasnik and Pomona's David Ballinger remained to dine together on May 5. Four months later, Podrasnik died.

Ballinger, a veteran of the Battle of Gettysburg, was immediately asked when he would drink the longawaited toast but he shockingly announced he would decline because he felt strongly that consuming liquor was wrong. News reports said that the final toast might be done "by proxy" but when or by whom is not known.

In the GAR's later years, associated groups with historical or genealogical interests to the Posts were formed and still exist as the Sons of Union Veterans of the Civil War and the Daughters of Union Veterans of the Civil War. On Memorial Day in 1953, Volume 10, No. 5, November, 2019

the Sons of Union Veterans helped clean up and repair the memorial at Bellevue in Ontario and held a rededication ceremony there.

Meanwhile, just about the last remaining hint that the GAR existed can be found in our oldest cemeteries where small metal stakes with "GAR" inside a star were originally placed next to the gravestones. After many decades, most of those stakes with the GAR star are missing, the victim of the elements, vandals or perhaps careless lawn mowing.
