

Town Hall Meeting with President Lincoln Report by Brother Steve Doyle, PCC

On February 12th, I attended the Zoom, "Town Hall Meeting with Abraham Lincoln", put on by the Department of Columbia (Alaska, Washington, and Oregon). The setting was 1865, the end of the war is at hand, and President Lincoln (played by Steve Hogate), answered questions from the 18 participants. As you can imagine this Town Hall Meeting was somewhat surreal. I mean, how many times to you get to sit down and talk to Abraham Lincoln! I tried to write down as many of the questions and answers as I could and here are the ones I was able to recollect (I would have failed Stenography class...!)

The first question that was asked was, "How did you choose to have Andrew Johnson as your Vice President?" President Lincoln answered by saying that the, "Ceded States are no long our Enemy" and that it was only, "rabble-rousers" who had claimed that, "States Rights" was the cause of the conflict!

When asked if he thought that there was anything that could have prevented the Civil War, he reminded us that the Union had offered a cash bounty for every slave that was owned, but that the offer was refused. He added that, "American Slavery is our "Original Sin."

When asked about what reparations should be given to Union Soldiers, he said that the Department of War would take care of our Union Veterans, their widows, and their orphans. When asked further about what aid would be given to Confederate veterans he responded, "the Federal Government has no responsibility to those who tried to overthrow it." He added that the reconstruction of the Southern economies would take time and money. He also hoped that the freed slaves would be able to participate in improving the Southern economies. He also commented that the, "Revenue Act of 1862" would continue to help regarding these issues, "but that will end sometime in the future." (Doing a google search regarding the, "Revenue Act of 1862", I discovered that taxes were collected by the, "Office of the Commissioner of Internal Revenue", which later became the IRS. We all know how that turned out . . .)

When asked how the Mormons in the West would be treated after the war, he quoted James Madison, who said that we are a country of Religious Freedom, "from Hindu




Photo above: President Abraham Lincoln as portrayed by Mr. Steve Hogate on a Zoom Town Hall meeting

to Mohammedan." Likewise regarding Native Americans who had fought for the Confederacy, he was hopeful that they would just go back to their reservations.

When asked about what Mr. Lincoln's thoughts were about what efforts should be made regarding reconstructing the South, he said that he was hoping for a "True Peace" and that Louisiana had already taken an Oath of Allegiance to the Union and had been allowed to send representatives to Congress. He also reiterated that there should be, "Malice towards None and Charity to All." His concern was also that, if there is a "Harsh Peace", then Southerners might be harsher towards freed slaves.


When asked about "revenge" towards the leaders of the Insurrection and especially what we should do with Jefferson Davis, Mr. Lincoln related a story about the Irishman who came to a bar and ordered just a coffee. He asked the barkeep what he would do if he slipped a little rum into his coffee. The barkeep answered that the act would, "just slip away unbeknownst to me". Mr. Lincoln said that he would hope that Mr. Davis would do the same: "Just slip away unbeknownst to me." He went on to say that Grant refused to take prisoners and told the Confederate soldiers to, "Just go on home."

Mr. Lincoln was also queried on what types of punishments should be meted out towards some of the atrocities committed during the war by the Confederacy. He specifically addressed the issue of the Anderson Prison Camp, and said that, "Trials should be considered regarding those who were in charge of the camp." He also touched on the fact that, "Those who had executed Black Union prisoners of war should also be held accountable for their actions."

On a similar topic, Mr. Lincoln addressed a question regarding postwar Missouri and Kansas raiders and outlaws using the, "rebel flag of convenience" to conduct their illegal activities. He reminded us that, "we still have an Army, and they will be helping U.S. Marshals and Sheriffs" to deal with these criminals.

When I asked Mr. Lincoln what he felt what was the greatest mistake he made during his presidency, he quipped, "Running for President." I also asked him what he felt was his greatest accomplishment. He responded in typical political fashion: "Even with perfect knowledge we make errors; like the flow of the Mississippi River, I have not been in control of Events. They have controlled me!"

I was fortunate to ask him another question: "What are your plans after your second term, Mr. President?" His answer was not only poignant, but prophetic: "Mary and I want to take a train ride to California to see this great country of ours. We would also like to visit the Holy Land. And then take the Last Train Ride Home." As we all know, he was assassinated and are sure he visited the, "Holy Land" in Heaven. His "Last Train Ride" was when the Presidential Mourning Train brought him home to Springfield.


Eagle Scout Commendation

Passing of Union Soldier Widow Helen Jackson

After many years of being a resident of a Nursing Home in Mansfield, Missouri, Helen Viola Jackson, the last documented widow of a Civil War soldier passed away on 16 December 2020 at the age of 101 years.

Helen Jackson married Private James Bolin, Company F,

14th Missouri Cavalry on 4 September 1936. He was 93 years old; she was 17. Her father had volunteered her to stop by Bolin's house each day and assist him with chores as she headed home from school. Bolin did not believe in accepting charity and, after a period of time, asked Helen for her hand in marriage in order to provide for her future by leaving her his Union pension. She accepted and Bolin recorded the wedding in his personal Bible. Bolin died in June 1939 and Helen never remarried; she never applied for the pension.

Graves Registration Report 2020 by Camp 18 Graves Registration Officer Michael Emett

The following is submitted to Stoneman Camp 18 for their approval and inclusion in the Department report for 2020. Due to the recent COVID 19 debacle, I did the opposite as suggested by health officials and government employees (elected and unelected) and visited 26 states plus Washington DC this past year. Although much was closed up, I did have less restricted access to many sites, including cemeteries. I also visited national cemeteries in Gettysburg PA; Shiloh, TN. and Vicksburg MS. Surprisingly, these cemeteries are under reported. I have chosen to select Gettysburg as my focus until completed, hopefully, sometime in 2021. I register Confederates as well as Union soldiers, particularly as we have entered times of uncertainty towards our historic past. American soldiers, regardless of the side on which they chose to fight, is a moot point. They were American soldiers and their "last full measure of devotion" deserves recognition.

736 soldiers registered on the SUVCW web site;

643 Union soldiers;93 Confederate,6 US Navy,7 US Colored Troops,1 Galvanized Yankee.

Pennsylvania graves: 258 California graves: 215 Iowa graves: 91 Miscellaneous states: 172 graves

- Brigadier General David Vickers,

- James W. Bodley; Superintendent Gettysburg National Cemetery 1918-1930,
- George Shaw; helped carry President Lincoln's body from Ford's Theater.

135th Annual Encampment Virtual meeting

The Department of California & Pacific, Sons of Union Veterans of the Civil War, held its 135th annual Encampment meeting on Saturday, 20 March 2021 through Zoom virtual communications. The meeting began at 9:00 a.m. with a Memorial service for our Brothers who have answered the final muster call, followed by the actual business meeting that concluded at 12:15 p.m.

There was as many as 49 Brothers attending the 3 hour and 15 minute meeting. Stoneman Camp 18 had 7 delegates present at the meeting, which was the camp with the second most attendants following only Sheridan Camp 4 which had 9 delegates attending. 11 of the 14 Camps in the Department were represented.

Final comments from the CinC covered the tax exempt status of the Camps and Departments and policy on monument preservation.
