The Daughters of Union Veterans of the Civil War, 1861-1865 chartered a new Tent in Northern Nevada.

The historic Buckland Station at Weeks, Nevada was an appropriate location for the newly organized Johana Shine Tent No. 96, DUVCW to celebrate the institution of their new Tent, initiation of new members and the installation of the new officers.

On February 16, 2014, fifteen of the twenty-three new members were in attendance, with the National President Carole Morton and Department President Susan Zimmer directing the ceremony. The members of the Gen. Wm. Passmore Carlin Camp No. 25, SUVCW were participated in the ceremony as Honor Guards.

All members of the DUVCW must be a direct lineal descendant of honorably discharged soldiers, sailors and marines who served in the Union Army or Navy during the Rebellion of 1861-1865, including those who died or were killed during their term of service.

The DUVCW's objectives are to perpetuate the memory, deeds and loyalty of those ancestors who sacrificed so much in the struggle to preserve the Union and establish freedom for everyone, to cherish, maintain and extend the institutions of American Freedom, to foster true patriotism and love of country.

Tents are to be named after an Army Nurse from the Civil War. The members chose Johana Shine, a combat field Army Nurse who was attached to Sherman's army during the march to the sea. She was born in 1836 and died in a tragic accident as her burning barn collapsed onto her as she was trying to save her horses in 1900. She is buried in Austin, Nevada.
