Ormsby Park Poor Farm Cemetery Plot-Carson City Nevada Resting Place For Two Civil War Soldiers







Records of the two Civil War veterans buried in isolated plot southeast of the Ormsby County Poor Farm.

"JOHN THOROUGHMAN

Born in Ohio 1838. Enlisted at Dayton, NV June 23, 1863, inducted at Fort Churchill, mustered out Camp Douglas, Utah Territory, June 25, 1866. Admitted to Ormsby County Poor Farm prior to February 1907. Left of his own free will February 2, 1907. Admitted March 12, 1907, left May 3, 1907. Admitted December 16,1909, died December 19, 1909.

JAMES JOHNSON

Born in Cuyhoga County, Ohio, 1836. Enlisted March 17, 1865 at Marysville, CA, Co. A 4th Reg Cal Inf Vol. Mustered out November 30,1866 at the Presidio. Moved to CC about 1870, worked on various ranches in the Carson City vicinity. Applied for and received a pension April 13, 1907. Admitted to Poor Farm February 1909, gave age as 73. Left of his own free will March 11, 1909. Admitted June 5, 1909, left September 15, 1909. Admitted January 6, 1910, died April 13, 1910.

Both these men paid \$10.00 per month while at the Farm.

The graves are located south of Clear Creek, which places them in Douglas County

Commanders Corner

Being Editor and Publisher of this News-Letter is about as easy as holding onto a greased hog, thank goodness for my Webster,s Spelling Corrector and computer with scanner and printer.

The Ormsby Park Poor Farm Cemetery Plot has the distinction of only two graves but the two graves are the resting place of two Civil War Veterans, John Thoroughman, Co. B, Nev. Cav. and James Johnson, Co. A, 4 CAL. Inf.

After taking photographs of the grave markers a sudden breeze come out of nowhere on a calm sunny day as if the spirits of these two Civil War Veterans knew I was paying them a visit. Closing my eyes, trying to imagine the lives these men lived, I found myself talking to them as if the three of us were sitting around a camp fire resting our tired bodies after a long day of scouting the desert wilderness in 1865.

Little is known about these two men other than both were born in Ohio, their military record, and being in the Ormsby Poor Farm when they died. Camp 25 Secretary/Treasurer, Jeffrey Vaillant, did a little more research on both men. Brother Jeffrey found a John Thoroughman in the 1880 Eureka County, Eureka Township census and two notes at the Ancestry World Tree. In 1880 he is a 46 year old male born in Ohio in about 1834 who is single living in the Charles N. Fiske household. It appears that the Fiske household was a hotel. The father of John was born in KY and his mother in Ohio.

James Johnson had a Civil War pension Application No. 1277354 and his CW Certificate No. 1041004 with E. S. Baily acting as his attorney to make the pension application. James is listed in the 1890 Veterans Schedule living in Nye County, Reveille Township. There are 72 listings in Ohio for marriages by the name James Johnson; however his pension application lists no wife, who may have died before his application.

During my research about these two men I did manage to obtain the death record of both from the Carson City Department of Records and a Letter of Record dated Oct. 16, 1955.

I figured my imagination was getting the best of me while sitting around the camp fire with the two Civil War Veterans so I said, so long for now gents, I will be back.

While driving back to Gardnerville I made my mind up to make sure these two Civil War Veterans are not forgotten as they lay in their resting place, the place called, Ormsby County Poor Farm Gravesites, located in south Carson City, known as Fuji Park, Carson City Nevada.


