HISTORY AND MEMORIALS REPORT

36-STAR FLAG IN SPARKS

I was told of a 36-star flag on display at the Sparks Heritage Museum, and went to see it yesterday afternoon. It is 72 inches by 76 inches, silk, and apparently hand sewn with brass rings down the side for mounting. The stars are sewn on the blue field. The blue field was also cut out behind the stars, so the stars are on piece of cloth seen on both sides. The flag was folded and stored through the years, and at some point got wet causing the red to run some on the white.

The origin of the flag is unknown. Recently, one of the docent thought of hanging an old flag on the wall. They had a box of mostly later flags, and this one was found inside. The museum has been around for about 25 years, and records for early donations are sketchy at best.

One of the docent did an internet search, and found one exactly like this one, but minus the brass rings, on the website of Jeff R. Bridgman American Antiques and Antique Flags - http://www.jeffbridgman.com/inventory/index.php?page=out&id=844 - located in York County, Pennsylvania. The docent e-mailed Mr. Bridgman for more details, but so far has gotten no reply.



The flag had 33 stars when the Civil War started, and stars are added the July 4th after a state is admitted. The 34th was added after Kansas became a state in 1861, and the 35th was added for West Virginia, which became a state in 1863. Nevada became a state on October 31, 1864, and the star would not officially be added until July 4, 1865, after the Civil War was over. It is probably unlikely this is true Civil War flag, however that being said, stars were locally unofficially added immediately after a territory became a state, and sometimes before. Also, General Grant's Civil War Headquarters for 1864-1865 had a 36-star flag (The Flags of the Union, An Illustrated History, 1994, by Devereaux Cannon, Jr.). Also, a note on http://www.illinoiscivilwar.org/cwflags.html says Army Regulations required regiments to have two silk flags 6 feet by 6 feet. One was the national flag with the regimental name and number on the middle stripe, and the other was the regimental flag. This flag is about the right dimensions but lacks regimental identification.

I have seen two other 36-star flags. Nevada State Archives has one that few over Fort Ruby, and a 36-star flag of unknown provenance is on display at the Way It Was Museum in Virginia City.

COLONEL NORMAN PARKER CHIPMAN

Recently, our Graves Registration Officer Don Huffman tracked down the final resting place of Colonel Norman Parker Chipman. Colonel Chipman co-founded the GAR and authored the order creating Memorial Day. He was also GAR Department of California and Nevada Commander in 1897. He died in San Francisco in 1924 and was cremated. His cremains were sent for burial at Cypress Lawns Cemetery in Colma, California. Department Civil War Memorials Officer Dean Enderlin had been researching Col. Chipman and ran into a dead end, because Cypress Lawns said he was not buried there. After a diligent search, Don found that Colonel Chipman was buried at the Bellefontaine Cemetery in Saint Louis, Missouri. He also has a rather ordinary gravestone with no mention of his military or GAR record.



ROAD TRIP TO CALIFORNIA MILITARY MUSEUM

On Oct. 15, Commander John Riggs and I met with our Graves Registration Officer Don Huffman at the California State Military Museum in Sacramento. We attended a talk on the Civil War era history of California by an historical novel author. On the way back to Reno, Commander Riggs and I visited the GAR plot in the cemetery at Auburn and the GAR monument at the cemetery in Newcastle.

SALUTE TO VETERANS CONCERT IN ELKO

Saturday, November 12, 2011, the Ruby Mountain Symphony presented <u>Salute to Veterans</u> at the Elko Convention Center in honor of veterans, and Carlin Camp 25 participated. I gave a brief synopsis of the Civil War. Secretary-Treasurer Brian Worcester presented Jerry Reynolds a certificate recognizing the medal of honor his grandfather Harry Reynolds posthumously received for his actions in the Indian Wars. Chaplain/Patriotic Instructor Tyrone Davis took pictures, and a reception was held at the Northeastern Nevada Museum after the event. This activity is written up in more detail with several pictures in the November issue of the Carlin Camp Dispatch. Also during the trip, Mountain View Cemetery near Lovelock, the Elko cemeteries, and Carlin Cemetery were reconnoitered, and the graves of Civil War veterans were photographed.

CIVIL WAR FEBRUARY-MARCH 1862

[Modified from The Blue and Gray Trail - Civil War Timeline / Chronology (http://blueandgraytrail.com/)]

- February 2: Union Captain David Farragut leaves Hampton Roads aboard the USS <u>Hartford</u> en route to assume command of military operations on the southern Mississippi River
- February 4: Confederate forces in Fort Heiman, Kentucky, withdraw to Fort Henry, Tennessee
- February 6: Battle of Fort Henry, Tennessee
- February 7: Battle of Roanoke Island, North Carolina. General Stonewall Jackson withdraws from Romney and returns to Winchester, Virginia
- February 8: Ambrose Burnside captures Roanoke Island with an amphibious force, taking some 2,765 Confederates as prisoners
- February 9: Union Brigadier General Charles Stone arrested and taken to Fort Lafayette, New York and placed in solitary confinement. He was not told the reason for his confinement.
- February 10: Securing Roanoke Island, Ambrose Burnside's navy destroys a small squadron of Confederate vessels in Pamlico Sound, North Carolina. Navy Secretary Gideon Welles forms an organization to review inventions and technical developments. The group eventually became today's National Academy of Science.
- February 13: Confederate General John Floyd takes command of Fort Donelson, Tennessee. Battle of Fort Donelson.
- February 16: General Ulysses S. Grant demands the unconditional surrender of the garrison from an old friend, Simon Bolivar Buckner
- February 17: General John Floyd arrives in Nashville after leaving Simon Bolivar Buckner to surrender at Fort Donelson
- February 18: The first Confederate Congress meets in Richmond, Virginia. Prior to this time, legislative duties had been carried out by secessionist convention. West Virginia Constitutional Convention adopts the first constitution of the state of West Virginia.
- February 21: In the "battle" of Valverde, Union forces under Colonel E. R. S. Canby are driven into Fort Craig by Brigadier General H. H. Sibley.
- February 22: Jefferson Davis is inaugurated as the first (and only) President of the Confederate States of America. Alexander Stephens is inaugurated Vice President.
- February 23: General Ulysses S. Grant orders William Nelson to advance on Nashville, Tennessee.
- February 25: "Bull" Nelson enters Nashville, Tennessee, first Confederate state capital to fall into Union hands. Don Carlos Buell accepts the city's surrender. Nathan Bedford Forrest provides a rear guard for Hardee's Army of Central Kentucky as it withdraws to Alabama.
- February 28, 1862: The Battle of New Madrid / Island No. 10
- March 2: Leonidas Polk completes his withdrawal from Columbus and moves south to New Madrid, Missouri.
- March 3: Abraham Lincoln appoints Andrew Johnson to be military governor of Tennessee. General John Pope lays siege to New Madrid
- March 4: Halleck relieves Grant from command and replaces him with Charles Ferguson Smith.
- March 6: Battle of Pea Ridge, Arkansas. Abraham Lincoln proposes that slaves in the border states be emancipated gradually, with compensation to the owners. The <u>Monitor</u>, the first Union ironclad, departs from New York. Barnwell Rhett proposes a yellow sun in a blue shield with a ray for each state. It would eliminate the stars and the red, white, and blue combinations of the Yankee flag

March 8: Battle of Elkhorn Tavern, Arkansas. The CSS <u>Virginia</u> (formerly USS <u>Merrimac</u>) battles the USS Congress and the USS Cumberland, destroying both frigates and killing more than 240 of their crewmen. Joseph E. Johnston orders the Confederate Army of the Potomac to withdraw from Centerville/Manassas to the Rappahannock River based on reports from J. E. B. Stuart of increased Yankee activity. Abraham Lincoln, chagrined at George McClellan for not appointing corps commanders, names Edwin Vose Sumner, Samuel Heintzelman, Erasmus Keyes and Irvin McDowell for him.

March 9: Battle of Hampton Roads - the duel of the ironclads, The USS Monitor and The CSS Virginia. First use of a turreted gun.

March 11: President Lincoln relieves George McClellan as General-in-Chief of the U. S. Army. He continues as commander of the Army of the Potomac. President Lincoln puts Henry Halleck in charge of all forces in the West. Lincoln also creates the Mountain Department, covering West Virginia and the mountainous area of Virginia. John Fremont is put in command. For their disastrous performance at Fort Donelson, President Jefferson Davis relieves John Floyd and Gideon Pillow from command.

March 12: Jacksonville, Florida, is occupied by Union naval forces.

March 13: Grant is reinstated to his command.. Jefferson Davis orders Robert E. Lee to "...conduct military operations of the armies of the Confederacy."

March 14: Battle of New Bern (sometimes called Newberne), North Carolina. Following a two week siege, federals under John Pope take New Madrid, Missouri

March 15: William Tecumseh Sherman and Stephen Hurlbut arrive at Pittsburg Landing and move inland to Shiloh Baptist Church.

March 17: Ulysses S. Grant assumes command of the forces at Pittsburg Landing. George McClellan begins transporting his men to Fort Monroe for the Peninsula Campaign in Virginia. Major General Lew Wallace and his division stop at Crump's Landing, Tennessee, to destroy the tracks of the Mobile and Ohio Railroad.

March 18: Jefferson Davis moves Judah Benjamin from the War Department to Secretary of State, replacing R. M. T. Hunter. George Randolph of Virginia is appointed Secretary of War.

March 20: Threatened by Stonewall Jackson, Nathaniel Banks withdraws from Strasburg to Winchester, Virginia.

March 23: Union General John G. Parke demands the surrender of Fort Macon on the coast of North Carolina. When the Confederates refuse, he lays siege to the fort. First Battle of Kernstown, Virginia. In the first battle of the Shenandoah Campaign General Stonewall Jackson loses to Brigadier General James Shields.

March 24: Confederate General Albert Sidney Johnston's Army arrives at Corinth, Mississippi, from Murfreesboro, Tennessee.

March 26: Moving along the Santa Fe Trail, Confederates engaged a group of Colorado volunteers at Johnson's Ranch. Federal forces withdraw to Glorietta.

March 28: Jefferson Davis proposes a conscription bill, shocking many Southerners.

March 29: The Central Army of Kentucky and the Army of Alabama and West Florida are merged into the Army of Mississippi in Corinth under General Albert Sidney Johnston with P. G. T. Beauregard as second-in-command. Corps commanders are Braxton Bragg, Leonidas Polk, William Hardee and George Crittenden.

March 30: The Baltimore and Ohio Railroad reopens following six months of Confederate control in Maryland and West Virginia
