#### HISTORY AND MEMORIALS REPORT

#### MEMORIAL DAY WEEKEND

Camp Commander Edward G. Carson, Brian I. Worcester, Ray Ahrenholz, and I participated in the Memorial Day weekend parade in Virginia City on May 28. I drove the Commander's van with the Camp 25 signs, and the others marched in front. After the parade, we minus Ray had lunch at the Gold Hill Hotel, and then Commander Carson and I visited the old Gold Hill cemetery. On May 29, Jenny and I went to Fort Churchill and visited the Nevada Civil War Volunteers re-enactors who were camped there and holding skirmishes over the weekend. On May 30, I attended the 9:30 am service with other Camp 25 members at the Grand Army of the Republic O. M. Mitchell Post 69 (GAR) cemetery at the old Hillside Cemetery. Ray Ahrenholz, Jim Ferrigan, David Hess, Roger Linscott, and Brian I. Worcester then held a short impromptu service at the grave of John Riggs. His grave is still not marked, though a flag had been placed there for Memorial Day.

#### HILLSIDE CEMETERIES

Over the last few weeks, the American Legion and VFW put up a new 6-foot-high, chain link fence around the GAR cemetery with a second gate opening directly into the old Hillside Cemetery from the back. The taller fence is intended to discourage vandals. The previous shorter fence dated to the 1960s and was part of renovations done by the previous DUVCW Johana Shine Tent 86 and SUVCW Isaac Crist Camp 28. Also, Hebrew Cemetery Inc. acquired the lane between the Hebrew Cemetery and the GAR and Knights of Pythias Cemeteries from Drew Lawton, the owner the Hillside Cemetery. The GAR Cemetery will now have a common boundary with the Hebrew Cemetery and will no longer be an "island" in the Hillside Cemetery. Hebrew Cemetery Inc. also attempted to acquire the strip of land between the GAR Cemetery and Angel Street, but Mr. Lawton declined to sell that parcel.

On June 6, articles of incorporation were filed for the Hillside Cemetery Preservation Foundation. The purpose of this foundation will be to raise money for the preservation and eventual acquisition of the Hillside Cemetery. With the encouragement of cemetery owner Drew Lawton and some of the families who own the plots, Frances Tryon has been cleaning up the graves for the last several years with some help of volunteers. She and others have also been researching those buried there as well as the history of the cemetery. She has been a driving force behind getting the foundation set up. She asked if I would be on the advisory board, and I agreed.

#### **NEVADA STATE FAIR**

Tyrone and I attended the Nevada State Fair at Mills Park in Carson City. The Fair also included the Rendezvous, which had been dormant the last few years. Several Civil War re-enactment groups were present, which did skirmishes. When the Rendezvous was still active and the State Fair was still held in Reno. Camp 25 was allowed to have a booth present for free. When the State Fair was resurrected in Fuji Park in Carson City several ago, they wanted \$300, which was out of the question.
