# **MEETING – AUGUST 26, 2018**

Minutes of the camp meeting Sunday, August 26, 2018, at 1300 Hours, VFW Hall, 255 Veterans Historic Way, Reno, NV General William Passmore Carlin--Camp 25 Department of California and Pacific

#### I. Opening

A). The meeting was called to order by Commander Carson at 13:05 hours.

B). The Pledge of Allegiance was led by SVC David Davis.

C). Invocation was led by JVC Kurt Dietrich.

D). Members in attendance were: Ray Ahrenholtz, Col. Edward Carson, David Davis, Kurt Dietrich, David Hess, Frank Wood, and Brian Worcester.

E. No guests were in attendance.

#### II. Camp Commanders Report-- Camp Commander Edward Carson

A). Commander Carson reported the following nominees for Camp 25 Officers for 2019. They include:

B). Commander Carson also discussed Camp 25's participation in upcoming events.

#### III. Treasurer's Report--Treasurer David Hess

A. Brother Hess presented the financial statements as of August 1, (attached to these Minutes as EXHIBIT 1). Hess asked if there were any questions. Being none it was MOVED (Dietrich) and SECONDED (Carson) that the financial statements be accepted as presented. The motion passed unanimously.

#### IV. Secretary's Report--Secretary David Hess

A). Approval of Minutes. Secretary Hess referred to the minutes of the June meeting, which were previously printed in the last issue of the Carlin Dispatch (Attached to these Minutes as EXHIBIT 2). Hess asked for any additions or corrections. Being none, it was MOVED (Worcester) and SECONDED (Dietrich) that the Minutes of the April meeting be accepted as presented. The motion passed unanimously.

B). Bylaw Amendments. Secretary Hess reported on why the amendments were necessary. There reasons include: 1) Changes mandated by national in order to make our Bylaws conform to changes necessary to include Camp 25 under the umbrella of their pending application for 501(c)(3) tax-exempt status. 2) Changes that were cosmetic, that is, for the purpose of making our Bylaw Articles fall in a commonly accepted format order. 3) Changes to articles (geographic boundaries of the Camp) that have been rendered moot by policy changes at the National and Department level. It was MOVED (Worcester) and SECONDED (Ahrenholz) to approve the Bylaw amendments as presented. Except for one typo correction, the motion PASSED unanimously (see final copy of Bylaws as amended attached to these Minutes as EXHIBIT 3).

# C). **Dues Change.** Secretary Hess pointed out that for as long as the national dues was \$23 we have been out of conformance with our Bylaws. Camp Bylaws state that the annual dues for the camp will be \$10 above the combined sum of the national dues and the department dues. At present national dues are \$23 and department dues are \$5. The sum of the two is \$28 which means total annual dues should be \$38, not the \$36 we have been charging. **After much discussion it was MOVED (Dietrich) and SEONDED (Worcester) to amend Article VII, Section 1 of the Bylaws to increase the Camp annual dues to \$12 (formerly \$10). The motion PASSED unanimously.**

#### V. Senior Vice Commander and Historian Report--Brother David Davis

A). Brother Davis reported that notices of the meeting were posted in the calendars of local media.

B). Brother Davis presented the History and Memorials Report. Topics for this report included:

#### VI. Junior Vice Commander's Report--Brother Kurt Dietrich.

A). New Member Application of Alexander Holmes Bertea. Brother Kurt Dietrich presented the completed application of Alexander (Alex) Holmes Bertea of Gardnerville, Nevada. His Civil War ancestor is his Great Great Grandfather, Henry H. Isley, a private in Company F of the 8th Regiment Iowa Volunteer Cavalry from 1863 to 1865. The application has been processed and approved in accordance with the Bylaws of Camp 25 and the National Office and all the required fees have been paid. It was MOVED (Hess) and SECONDED (Ahrenholz) to approved Mr. Bertea's application. The motion PASSED unanimously.

B). New Member Application of Michael Howard Juckett. Brother Kurt Dietrich presented the completed application of Michael Howard Juckett of Carson City, Nevada. His Civil War ancestor is his Great Uncle, Franklin Howard Juckett who served as a private in Company E, 77th New York Infantry-Saratoga from 1861 to 1862. The application has been processed and approved in accordance with the Bylaws of Camp 25 and the National Office and all the required fees have been paid. It was MOVED (Ahrenholz) and SECONDED (Hess) to approved Mr. Juckett's application. The motion PASSED unanimously.

C). **GAR Tree Status.** Brother Dietrich inquired if anyone was aware of the current status of the GAR tree near the UNR campus. Houses around the tree are being removed. Brother Worcester reported that the tree was still standing when he recently drove by to check on it. It was suggested that the Camp write to the State Historic Preservation Office to determine its future.

#### VII. Patriotic Instructor's Report-- Brother Tyrone Davis

A). Brother Tyrone Davis was absent but provided a written reported this month on the Battle of Mobile Bay. (Attached to these Minutes as EXHIBIT 5).

#### HISTORY AND MEMORIALS REPORT

August 26, 2018

David A. Davis, Gen. William Passmore Carlin Camp 25 Camp Historian/Civil War Memorials Officer.

#### THOMAS KANE/BARTHOLOMEW KEENAN

Since at least 2011, SVC/Historian David A. Davis and now deceased Commander John Riggs have periodically researched bugler (trumpeter) Bartholomew Keenan, aka Thomas Kane. He served in the Civil War, and later received the Medal of Honor for action during the Indian Wars in Arizona. He committed suicide in the Storey County jail in 1874 and was interred in the public section of the Gold Hill cemetery. An unnamed wife is noted in the obituary. His grave is listed as being decorated during Memorial Day at least between 1895 and 1905. At the time of his death, he went by the name Thomas Kane. A Medal of Honor for Bartholomew Keenan was found in his cell shortly after the removal of his body. A letter was sent to the sheriff stating that Keenan and Kane were the same man and the medal was his.

In 2011 Gayle Alvarez of the Congressional Medal of Honor Society was alerted to Mr. Keenan/Kane. A few months ago, Ms Alvarez contacted me about revived interest on their part to document Mr. Keenan/Kane. The Society has found some record of his apparent Civil War service and signed off on his death date and cemetery of burial. A much fuller report on this saga will be included in a future issue of the <u>Carlin Camp Dispatch</u>. The Congressional Medal of Honor Society is a Congressionally chartered organization whose members received the Medal of Honor. It also researches and keeps track of those who received it historically.

The U.S. Bureau of Land Management (BLM) owns the Gold Hill Cemetery, and the Comstock Cemetery Foundation oversees the Comstock cemeteries including the one at Gold Hill. They have a good working relationship with the BLM. I contacted the Foundation. They are very interested in having Mr. Keenan's grave marked and his Medal of Honor noted. They said they need to do some of their own research into him, but if they are satisfied, they can make it work if a marker is produced. The Congressional Medal of Honor Society would be happy to see his grave marked, too. Non-related individuals can now order Government markers for veterans who served prior to 1917. The glitch is the Government will not issue a marker if the exact grave site is not known. Most of the graves in the public section are not marked including Mr. Keenan's. Also, the cemetery records are scanty, and the exact patch of cheat grass Mr. Keenan is under is also not known. A cenotaph can be procured bout only by a family member, but Mr. Keenan had no known descendants, and it is uncertain if he had siblings. The Society has a contact that makes markers for about \$600 and might be able to fund it, but no guarantees.

#### **UNIONVILLE REMAINS**

On July 31, 2018, Brothers Senior Vice Commander/Historian David A. Davis and Camp Bugler Ray Ahrenholz of Carlin Camp 25, Sons of Union Veterans of the Civil War met with Eugene "Gene" Hattori and Bryan Hockett to view the holdings associated with the Unionville skeleton. Gene is a curator with the Nevada State Museum, and Bryan is an archaeologist with the U.S. Bureau of Land Management. The holdings are held at the Nevada State Museum Indian Hills Site facility at 1026 Topsy Lane, Carson City, Nevada.

The bones and artifacts were in several plastic bags packed in a small box. The skeleton including the skull were in pieces and the teeth were separate. Also in separate bags were buttons, very dry leather shoes, and bones of unidentified animals that were found with the human remains.

**Skeleton:** The bones appeared well weathered. The cause of death is thought to have been blunt force trauma to the face. The jaw and skull were in pieces and 24 teeth were separated from the jaws. However, present cracks in the remaining skull pieces may be due to weathering. An upper thigh bone had a "green stick" fracture. The teeth had wear such as might come from eating tough food (hardtack?). The bones were apparently of a young man in his late teens or early 20s. The wisdom teeth had erupted (18 to 25 years of age) and the leg bone was not totally fused (by 22 years of

age). the person was likely of European or of European descent, though the incisors were broken so the parts that would be "shovelled" indicating an aboriginal American were not present. The sex and height were not discussed though forensics reports state the artifacts indicate a male about 5' 6" to 5' 7" tall.

**Shoes:** The remains of two very dry leather Army (ankle length) boots or brogans, both of which were assembled at one time with wooden pegs and iron nails. The soles were clad with hob nails and one rusty "heel plate" (mini horse shoes for boot heels).

**Buttons:** 4 different types of buttons were present. These included: two bone(?) buttons of about 5/16" diameter which were of a type to fasten a shirt collar or wrist opening; one "pie crust" button of about 3/4" diameter. This is a type of button which because of its cross section is usually associated with the anchor point for suspenders; one brass eagle button 3/4" diameter which was of a type used on a 4 button sack (fatigue) coats, frock coats and main closure for overcoats; one brass eagle button 9/16" diameter of a type used to fasten a chin strap of a forage cap, cuffs to jackets, gorget tape on collars, and main closure of shell jackets. Gene noted several buttons appeared to be missing. The brass buttons were referred as General Services buttons and contained no letters identifying the service branch.

**Conclusion:** The presence of two different size Military issue buttons and apparent Military style brogans kind of puts a thumb on the scales towards being the artifact of a soldier, but admittedly inconclusive. A civilian may have used loose Military buttons to sew up his clothes and wore brogans similar to those used by the Military. Unionville was less than half a mile from site where the remains were found and was a well established mining camp when the Civil War began.

**Miscellaneous Notes:** All issue items had to come from around the Horn to either the Los Angeles port or Presidio of San Francisco. One opinion was that items were military surplus. Great idea for 21st Century, non-existent for 19th Century. A letter from the Quartermaster General to a U.S. senator in December of 1851 reveals that all the clothing for the Army was made at the Schuylkill Arsenal (Philadelphia)

Patriotic Instructor Report By Tyrone Davis Battle of Mobile Bay

The Battle of Mobile Bay occurred on August 5, 1864 was a major naval battle during the <u>American Civil</u> <u>War</u> where a Union fleet commanded by <u>Rear Admiral David G. Farragut</u>, aided by a contingent of soldiers, attacked a small Confederate fleet commanded by <u>Admiral Franklin Buchanan</u> and three forts that guarded the entrance to <u>Mobile</u> <u>Bay</u>. A paraphrase of his order, "Damn the torpedoes, full speed ahead!" became famous. Farragut's actual order was "Damn the torpedoes! Four bells. Captain Drayton, go ahead! Jouett, full speed!".

The battle was remembered by Farragut's rash but rather successful advance through a minefield that had taken out one of his <u>ironclad monitors</u>, enabling his fleet to get beyond the range of the shore-based batteries. This was followed by a reduction of the Confederate fleet to a single vessel, ironclad <u>CSS *Tennessee*</u>.

*However the Tennessee* did not retreat, it battled the entire Northern fleet. The *Tennessee*'s armor enabled her to inflict more injury than she received, but she could not overcome the imbalance in numbers. She was eventually reduced to a motionless hulk and surrendered, ending the battle. With no Navy to support them, the three Confederate forts also surrendered within days. Complete control of lower Mobile Bay was obtained <u>Union</u> forces.

Mobile had been the last important port on the Gulf of Mexico east of the Mississippi River remaining under Confederate control, so its capture was the final step in completing the blockade in that region. This Union victory, along with the <u>capture of Atlanta</u>, was extensively covered by Union newspapers and was a significant boost for Abraham Lincoln's bid for re-election three months after the battle.
