SEASONAL OPENING OF BOWER'S MANSION

May 18, 2019

On Saturday, May 18, Washoe County opened Bowers Mansion at the Bowers Mansion Regional Park for the season. The Nevada Civil War Volunteers reenactors set up camp and conducted several skirmishes through the day. Camp 25 SVC/Historian David A. Davis, PCC, and Councilman Roger Linscott manned displays in the Library through the day. Commander Kurt Dietrich came in the afternoon. Camp 25 displayed the 1863 Groot map of Nevada Territory and the map showing expeditions of the First Nevada Cavalry around Nevada during the Civil War. Also displayed were the 1913 G.A.R. Department of California and Nevada Reno Encampment parade picture, the Camp 25 flag, and a portrait of President Lincoln. Camp 25 Chaplain Ray Ahrenholz and member Robert Burr participated with the Reenactors.

G.A.R. POST 69 CEMETERY GATE DEDICATION

May 24, 2019

On Friday, May 24, a dedication and ribbon cutting was held at the G.A.R. General O.M. Mitchel Post 69 Cemetery at Hillside for the newly renovated gate. The Nevada Chapter of the Associated General Contractors (AGC) under the direction of Congressman Mark Amodei was responsible for the work. The original 1960s sign was kept, but

the poles were replaced and the steps removed and replaced with ramped up dirt for mobility impaired people to enter the cemetery. Camp 25 members who attended were Commander Kurt Dietrich, SVC/Historian David A. Davis, PCC, Councilman Roger Linscott, and member Jim Ferrigan. Those who conducted the dedication were Congressman Mark Amodei, Reno Vice Mayor Naomi Duerr, and the American Legion Darrell Dunkle Post 1 Commander Richard Dickerson. Representatives from the contractors were also present. Lunch was provided on site afterwards.

XI). New Business.

- A). Commander Dietrich asked the members which events they would like to participate in during Memorial Day weekend. Brother Worcester stated that historically the camp participated in events at Hillside and Lone Mountain

cemeteries. SVC Davis stated that the camp also participated in a wreath laying at the Carson City civil war memorial. A discussion took place regarding the restoration of the Carson City memorial. A consensus was reached to attend the Hillside event.

- E). Commander Dietrich stated that Counselor Linscott has contacted a company to produce hat badges that indicate our camp number, rather than the common "SUV".

XII). Old Business.

- A). Brother Worcester stated that he presented the ROTC award to a cadet at the University of Nevada. Unfortunately, the certificate was not prepared. Commander Dietrich stated, moving forward, he would like the Form 7 processed by the camp, so that we can ensure that the presenting brother has the certificate and medal in hand.

XIII). The closing prayer was offered by Chaplin Ahrenholz.

HISTORY AND MEMORIALS REPORT

April 28, 2019

David A. Davis, Gen. William Passmore Carlin Camp 25 Camp Historian/Civil War Memorials Officer.

RENO NUN WHOSE FATHER WAS A UNION VETERAN

Our Graves Registration Officer Don Huffman sent me the obituary of Sister Ann Clem of the Reno Carmelite Monastery. She passed away on September 5, 1997, at the age of 91 and was buried in the "courtyard of the Monastery". She came to Reno in 1954 to help found the Carmelite Monastery now on La Fond Drive in Reno. Don found that her father, John Lincoln Clem (a.k.a Klem), was a sergeant in Company C, in the 22nd Michigan Infantry on May 1, 1863. He was discharged September 19, 1864, at the age of 13. However, he went on to become a 2nd Lieutenant on December 18, 1871, in the US 24th Infantry, a 1st Lieutenant on October 5, 1874, a Captain in the Quartermaster Department (QM) on May 4, 1882, a Major in the QM on May 16, 1895, and a Lieutenant Colonel in the QM on February 2, 1901. He retired as a brevet Major General in 1916. Don found a picture which is included below. Notice that Col. Clem appears to be wearing a G.A.R. badge

I called the Monastery and spoke with a nun who remembered Sister Clem as an elderly nun who was ill and could not speak. She was buried in a small cemetery on the Monastery grounds but is not in a "courtyard". Only relatives of those buried there are allowed to visit the graves.



Patriotic Instructor Report

The Battle of Five Forks took place on April 1, 1865, southwest of Petersburg, Virginia, around the road junction in Five Forks, Dinwiddie County, at the end of the Siege of Petersburg, nearing the conclusion of the Civil War.

The Union Army commanded by Major General Philip Sheridan routed a Confederate force from the Army of Northern Virginia commanded by Major General George Pickett. The Union force inflicted over 1,000 casualties on the Confederate army and took captured 4,000 soldiers while seizing Five Forks, the key to control of the South Side Railroad, a vital supply line and evacuation route.

Following the Battle of Dinwiddie Court House (March 31st) at about 10:00 pm, V Corps infantry began to arrive near the battlefield to reinforce Sheridan's cavalry. Pickett's orders from his commander General Robert E. Lee were to defend Five Forks "at all hazards" because of its strategic importance.

At about 1:00 pm, Sheridan pinned down the front and right flank of the Confederate line with small arms fire, while the massed V Corps of infantry, commanded by Major General Gouverneur K. Warren, attacked the left flank soon afterwards. Owing to an 'acoustic shadow' in the woods, Pickett and cavalry commander Major General Fitzhugh Lee did not hear the opening stage of the battle, and their subordinates couldn't find them. Although Union infantry weren't able to exploit the enemy's confusion, owing to lack of reconnaissance, they were able to roll up the Confederate line by chance, helped by Sheridan's personal encouragement. After the battle, Sheridan controversially relieved Warren of command of V Corps, largely due to private enmity. Meanwhile the Union held Five Forks and the road to the South Side Railroad, causing General Lee to abandon Petersburg and Richmond, and begin his final retreat.

Special Committee to Explore the Possibility of Coordinating Joint Activities between the SUVCW/ASUVCW Department of California and Pacific and the Sons of Confederate Veterans California Division in 2020.

By the authority vested in me as Commander of the Department of California and Pacific, by the Department Bylaws, the National Constitution and Regulations, and National Policies, it is hereby ordered as follows:

Section 1: Several years ago, the Special Committee to Explore the Possibility of Coordinating Meetings and/or Activities of the SCV California Division Convention and SUVCW/ASUVCW Department Encampment in 2020 was created. During its report at the 133rd Annual Department Encampment, on 23 March 2019, at Bakersfield, California,

the Committee had no recommendations, but concluded it was unlikely such activities could be achieved in 2020. The committee was then discharged. Delegates unanimously requested the Department Commander for 2019-2020 appoint a special committee to further investigate possibilities of such activities in 2020 and future years.

Section 2: I am hereby establishing the Special Committee to Explore the Possibility of Coordinating Joint Activities between the SUVCW/ASUVCW Department of California and Pacific and the Sons of Confederate Veterans California Division. The purpose of this special committee is to examine the feasibility of conducting joint functions between the Department of California and Pacific, SUVCW/ASUVCW and the California Division of the Sons of Confederate Veterans during their respective state-level conventions in 2020 or for future conventions.

Section 3: This special committee shall: a) Serve through the close of business at the 134th Annual Department Encampment of the Department of California and Pacific, SUVCW, at which time it shall be discharged of its duties and cease to exist. b) No later than ninety (90) days after issuance of this Department Order, the Committee shall report to the Department Commander its findings and recommendations for the likelihood of joint SUVCW/SCV activities during the 2020 conventions. c) The Committee shall determine the practicality of pursuing the likelihood of joint SUVCW/SCV activities during future conventions after 2020. d) The final decision on whether to pursue the possibilities of joint SUVCW/SCV activities during future conventions shall be determined by the Department Senior Vice Commander, who shall report the Special Committee's findings and recommendations at the 134th Annual Department Encampment.
