
THE NEXT MEETING

PAUL FREDERICK WASHELESKI, PCC, 1938-2019

Paul Washeleski, PCC, the driving force behind the founding of General William Passmore Carlin

Camp 25 and its first Commander, passed away from cancer in Arizona on July 15. 2019. He was born June 22, 1938, in New Jersey and served in the United States Army. As Camp Commander, he was instrumental in getting the white bronze statue of a Union soldier at parade rest restored in the G.A.R. Custer Post 5 plot in the Lone Mountain Cemetery in Carson City. Though this type of statue is common back East and California has a few, this particular statue is the only one in Nevada. The service was held in Arizona. and burial will be held at Eastside Memorial Park near Minden on Friday, August 2, 2019, at 10 am. GEN. O.M. MITCHEL POST 69 CEMETERY

I have been in contact with Jack Edstrom with the Darrell Dunkle Post 1 of the American Legion, which oversees the G.A.R. General O.M. Mitchel Post 69 Cemetery at Hillside. He's been doing some research into ownership of the cemetery, and I provided him copies of the deeds. He has the history I wrote up a few years ago and asked if anyone had a list of who is really buried there. I have a list from our Graves Registration Officer Don Huffman, a 1955 D.A.R list, a partial list from the G.A.R. records at UNR, and a list of tombstones Commander John Riggs and I did in 2011. So far, there is no end-all, be-all list. I told Jack, I would see about reconciling the lists before sending him copies.

Patriotic Instructor's Report - Battle of Simmon's Bluff

The Battle of Simmon's Bluff was a minor and bloodless Union victory which took place on June 21, 1862, in <u>Meggett, South Carolina</u> during the <u>American Civil War</u>. <u>Union</u> troops laid siege to Charleston, which was being resupplied from a nearby railroad. Union forces were eager to capture the city, so they sent the <u>55th Pennsylvania Infantry</u> regiment to dismantle the rail line. The 55th Pennsylvania departed by sea shortly before the battle in search of a place to land closer to the railroad. On June 21, the 55th Pennsylvania came ashore at Wadmalaw Sound. Union forces discovered an encampment of the 16th South Carolina Infantry regiment and quickly razed the encampment and engaged the Confederate forces. The Confederates were taken by surprise and after the encampment was razed and were unable to launch an effective

counterattack so they retreated. There were no reports of injuries on either side and after the raid the Pennsylvania regiment returned to their ships and abandoned their original mission which was to interrupt the rail line to Charleston.

Department Order No. 3 Series 2019-2020 Department of California and Pacific Sons of Union Veterans of the Civil War

Observance of Memorial Day 2019

By the authority vested in me as Commander of the Department of California and Pacific, Sons of Union Veterans of the Civil War, by the Department Bylaws, the National Constitution and Regulations and National Policies, it is hereby ordered as follows:

Section 1: Upon becoming members of the Sons of Union Veterans of the Civil War, we pledged ourselves for the purpose of, and among other things, to always observe the day set aside by the Grand Army of the Republic as Memorial Day, sacred to the memory of the Union Soldiers, Sailors and Marines of 1861 to 1865.

Section 2: Grand Army of the Republic Commander-in-Chief John A. Logan's General Order No. 11 instructs us that The 30th day of May (1868) is designated for the purpose of strewing with flowers or otherwise decorating the graves of comrades who died in the defense of their country during the late rebellion, and whose bodies now lie in almost every city, village and hamlet churchyard in the land. In this observance no form or ceremony is prescribed, but Posts and Comrades will, in their own way, arrange such fitting services and testimonials of respect as circumstances may permit.

Section 3: Camps and Brothers are encouraged to participate in the observance of Memorial Day on Thursday, May 30th or as circumstances permit May 25 through May 27.

Section 4: Remembering the Boys in Blue and rendering such fitting services and testimonials of respect can be an elaborate ceremony with many or a single Brother decorating a lone isolated and almost forgotten grave.

Section 5: Sentiments that endure to this day that link us to the Grand Army of the Republic, of honored memory, are acknowledged in the Sons of Veterans Creed and are as follows;

- To be a true American and a good citizen.
- To discountenance disloyalty in any form.
- To revere the name of my ancestor who gave his service and made his sacrifices for the maintenance of the Republic.
- To assist the Grand Army of the Republic and to perpetuate the patriotic teachings of that organization.
- •To be loyal to my Camp and the Order and faithful to my fellow members that we may work in brotherhood for these ends.

Section 1: It is my sad duty to report that after a long battle with cancer, Brother Paul Frederick Washeleski, PCC passed away on July 15, 2019 at the age 81. Brother Washeleski was a Charter Member of General William Passmore Carlin Camp No. 25 and the first Camp Commander, 2003 & 2004.

Section 2: Born on June 22, 1938, Brother Washeleski was a United States Army Veteran.

Section 3: Services for Brother Washeleski are pending.

RECENT GENERAL ORDERS

Four new General Orders by Commander-in-Chief Donald Shaw have been announced since the last issue of the <u>Carlin Camp Dispatch</u> was posted. For a complete list of General Orders back to 1994, please see the National website: http://www.suvcw.org/?page_id=513. In summary, General Order No. 10 is to have the Council of Administration to appoint an Acting National Treasurer to replace Treasurer David H. McReynolds, who is ill with cancer. General Order No. 11 announces that James B. Pahl, PC and C has been appointed by the Council of Administration as Acting Treasurer until David McReynolds is well enough to resume his duties. General Order No. 12 amends a decision in the National Constitution and Regulations, "A camp can carry no flag except those authorized by the C.R.& R" to: "A Camp and/or Department may carry no flag except those authorized by the Constitution and Regulations. In addition, Departments may also carry their official State Flag and Camps may carry their official State Flag and the official Municipal and/or City flag of the city they meet in, if such flag has been officially adopted by that municipality/city." General Order No. 13 reports the passing of Brother David H. McReynolds on Saturday, July 27, 2019. He was a member of the William A. McTeer Camp No. 39, Department of Tennessee, and served as Past Commander for both his Camp and Department.
