DEATH OF THE LAST CIVIL WAR PENSIONER

May 31, 2020

Irene Triplett died at the Accordius Health nursing home in Wilkesboro, North Carolina on May 31, 2020. She was the last recipient of a Civil War pension. She was born January 9, 1930 to Moses (a.k.a. Mose) Triplett and Elida Hall. Her father had fought first on the Confederate side in Co. K, 53rd North Carolina Infantry and Co. C 26th North Carolina Infantry. He deserted and joined the Union side prior to the Battle of Gettysburg. The 1890 Census has him in Co. F, 3rd North Carolina, and a pension index card has him in Co. B, 3rd North Carolina Mounted Infantry, a.k.a Kirk's Raiders. The 3rd North Carolina was a Union regiment. Moses' first wife passed away in 1923, and at age 78, he married Elida in 1924. She was about 50 years younger and suffered from mental disability. Irene grew up on her father's farm in Wilkes County, North Carolina. She suffered a difficult childhood and was regularly beaten by both her parents and schoolteachers. Also classmates teased her about her father whom they denounced as a "traitor". She left school in 1943 after the sixth grade and lived with her mother and brother Everette to the Wilkes County poorhouse until 1960. Everette ran away prior to that and eventually became a bulldozer operator. He died in 1996. After 1960, Irene and her mother lived in private nursing homes until their deaths. Elida died of cancer in 1967. Irene was a regular user of chewing tobacco since getting hooked in the first grade and was a fan of gospel music. However, she did not drink moonshine. Moses passed away July 18, 1938 at age 92. He had just returned from the 1938 Gettysburg Reunion, where he "fooled them" and camped out with the Confederate veterans. Since Irene suffered from cognitive impairments and was under 18, she qualified as a helpless child of a veteran. She inherited her father's pension and received \$73.13 a month from the Department of Veterans Affairs. The question was raised to determine any interest in members of Camp 25 making a similar show of appreciation to either veterans or others whose Covid-19 services and/or sacrifices have been exemplary. Brother Hess volunteered to contact Glenna Smith who was the contact for the SAR to see if there are upcoming opportunities in connection with the VA.


JEFF DAVIS PEAK, ALPINE COUNTY, CALIFORNIA

Another Jeff Davis Peak is about to be renamed. Some time back, Jeff Davis Peak in White Pine County was renamed Doso Doyabi. Now, Jeff Davis Peak in Alpine County, California, is up for renaming. Ironically, both Jeff Davis Peaks are in Camp 25's sphere of influence. This Jeff Davis Peak is located about 7.5 miles west-southwest of Markleeville in the northwest quarter of Section 16 in Township 9 North, Range 19 East. The top of the peak contains a volcanic plug also known as Sentinel Rock.


Jeff Davis Peak is thought to have been named by southern sympathizers who came to the now defunct mining camp of Summit City. Summit City began in 1863 and appears on the 1879 public land survey in the south half of Section 2 in Township 9 North, Range 18 East, about 4 miles west-northwest of Jeff Davis Peak, and just inside of Eldorado County. A Lower Summit City is shown in the southwest quarter of section 3 a half of a mile farther west. A gold strike was reported at Summit City as late as 1880. An 1883 survey referred to the site of Jeff Davis Peak as Sentinel Rock, but the 1889 topographic map shows it as Jeff Davis Peak. The 1956 topographic map also shows Jeff Davis Creek flowing for about 3 miles just northeast of Jeff Davis Peak with its headwaters in the saddle between Jeff Davis Peak and Markleeville Peak about 1 1/2 miles to the north.

In 2017, Anthony Oertel of San Rafael, California, proposed renaming it after Frederick Bee, who had fought for the rights of Chinese immigrants in the 19th Century. However, Alpine County officials and the Washoe Tribe of Nevada and California preferred the more aboriginal name. Mr. Oertel agreed, and the proposed name was "De-Ek Dow Go-Et". This translated into "saddle between points". In 2018, the California Advisory Committee on Geographic Names voted the name change down due in part to the early survey containing Sentinel Rock. A compromise was reached whereby Sentinel Rock would remain as the name for Jeff Davis Peak, and whole mountain would be named De-Ek Dow Go-Et. Also, Irvin Jim, Jr., chairman of the Washoe tribe's Hung Lel Ti Community Council in Woodfords noted that this restores a name connected to the Washoe tribes who have been in the region for over 10,000 years.

The Alpine County Board of Supervisors is expected to vote on a second letter of support for the name in early July. The U.S. Board of Geographic Names could vote on the name change at its meeting on July 11.

RECENT GENERAL ORDERS

Seven new General Orders by Commander-in-Chief Edward J. Norris have been announced since the last issue of the <u>Carlin Camp Dispatch</u> was posted. The General Orders are summarized below. General Order No. 27 is a reminder of SUVCW policies involving an increase for requests for comments on historical monuments.

General Order No. 28 creates the Department of Alabama from the Department of Tennessee with Alabama and Mississippi. It takes three camps to be eligible to create a Department of which Alabama has three.

General Order No. 29 is an approved form letter brothers, Camps, or Departments can use to express concerns to the appropriate authorities over the destruction or removal of monuments.

General Order No. 30 suspends the Department of Connecticut for failure to file annual reports.

General Order No. 31 cancels the National Encampment until further notice.

General Order No. 32 extends the deadline for nominations for awards and recognition.

General Order No. 33 lifts the suspension the Department of Connecticut.

General Order No. 26 Series 2019-2020 2 June 2020

1). It is my sad duty to report the death of Real Daughter Irene Triplett, on May 31, 2020 in Wilkesboro, North Carolina at the age of 90.

2). Sister Triplett was the last federally pensioned dependent of a Civil War veteran. Her father, Pvt. Mose Triplett, served in both the Union and Confederate armies during the Civil War. After the Battle of Gettysburg, Triplett left the Confederate forces and joined the 3rd North Carolina Mounted Infantry, a Union regiment. Sister Triplett's father died a few days after returning from the 75th anniversary celebration at Gettysburg.

3). The Sons of Union Veterans of the Civil War's National Web Site, Social Media platforms, and the Charters of all Departments and Camps will be draped in black. And, all Brothers will attach a black mourning ribbon to their membership badges in remembrance of Sister Triplett.

4). This order shall remain in effect for 30 days from this date.
