Funding Found for GAR Monument Restoration Project

In a surprise turn of events, on April 26, 2004, the Carson City Board of Supervisors announced the approval of funds to be used for the restoration of the historic Grand Army of the Republic Civil War Monument located at the Lone Mountain Cemetery District property.

The G.A.R. Monument was originally constructed and dedicated in 1891 as Nevada's tribute to the soldiers, sailors and marines who fought to preserve the Union during the Civil War.

It is the only one of its kind in Nevada. Additionally, it is also believed to be the only one of its kind west of the Mississippi.

The cost to disassemble, transport, repair and re-assemble the monument is estimated to be over \$82,000.

Thanks to the efforts of several historical, hereditary and civic groups (specifically included in that group was the SUVCW !!), this project would not have gone forward.

The project was, all along, supported by the Carson City Department of Parks and Recreation, the Lone Mountain Cemetery District, Mayor Ray Masayko and other leading government officials, however the cost of the restoration project was

Gen. Carlin Camp Participates In <u>Memorial Day Events</u>

On May 31, 2004, several members of the Sons of Union Veterans of the Civil War -General William Passmore Carlin Camp No. 25, participated in the Memorial Day Services at the Lone Mountain Cemetery, Carson City, Nevada. This was the first appearance of the newly formed Camp Guard.

The day included a wide range of activities and participants. Several military, civic and lineage societies were represented and over 300 spectators were estimated to be in attendance.

The master of ceremonies was David Stultz (Sexton, Lone Mountain Cemetery District). He and his staff had meticulously prepared the grounds of the cemetery for this auspicious occasion. Flags and beautiful floral bouquets could be seen adorning the graves and headstones of veterans throughout the historic cemetery. And Mother Nature, also, cooperated for this memorial service.

Participants included members of the Nevada Air National Color Guard, Sierra Highlander Pipe Band, the Naval Cadet Color Guard and the SUVCW – General W. P. Carlin Camp Guard.

Guest speakers included Gwen Hadd (Women's Army Corps –

the prohibiting factor.

The monument is scheduled to be disassembled the last week of June or the first week of July, 2004. It will then be transported to the restoration company's main plant in the Mid-West where it will be repaired and refurbished to "like new" condition.

Additionally, the restoration process will include a new stainless steel interior to support the weight of the statue.

All work is hoped to be completed for its return and reassembly in the late Fall.

A grand re-dedication ceremony is planned for the 2004 Veterans Day Celebration at the Lone Mountain Cemetery.

It should be noted, that while this much needed restoration is being performed, it will be the first time in 113 years that the sentinel atop the GAR Monument will not be standing guard over Nevada's largest assemblage of Civil War Veterans !!

Last Civil War Widow Dead at 97

Alberta Martin, the last known widow of a Civil War Veteran, died May 31, 2004, at a nursing home in Alabama, at the age of 97.

She was born December 4, 1906, in Coffee County, Alabama. On December 10, 1927, she married William Jasper Martin (a private in Company K, 4th Alabama Infantry- CSA). She was 21 years old and he was 82 !! The marriage lasted 4 ¹/₂ years and when her husband died she received a pension of \$50.00 a month.

The last widow of a Union Veteran of the Civil War, Gertrude Janeway, died January 2003, in Tennessee, at the age of 93. She had married John Janeway (a private in Company B, 14th Illinois Cavalry) when she was 18. When her husband died, she received a pension of \$70.00 a month !!

Although all the Civil War Veterans and their widows are now gone, there are a few *real* sons and daughters left. Let us not forget them !!

Another Civil War Moment

The below envelopes contained letters written to Tilton C. Reynolds from his parents between September 1861 and March 1862. These "Patriotic Covers" are sought by collectors because of their appearance.

Until recently, little was known of Tilton C. Reynolds. Various record checks utilizing several on-line databases (NARA database, Ancestry.com Civil War collection, etc.) revealed little about his Civil War military service record. The only record found was for a "Tilman Reynolds", Company H, 105th Pennsylvania Infantry. Nothing else.

It was not until this year, that it was discovered that the US Library of Congress had an entire collection of his letters on-line for viewing, including his photograph and biography !!

The following is a brief synopsis of what can be found in regard to - Tilton C. Reynolds. He was born on 26 October 1843 and was the oldest son of Thomas and Juliana Reynolds of Winslow Township (later Reynoldsville), Pennsylvania.

Soon after the start of the Civil War, Tilton joined the 105th Regiment Pennsylvania Volunteers (known as the "Wild Cat Regiment" because recruits came largely from an area of individual oil explorations known as "wildcat" operations).

In September 1861, seventeen-year-old Tilton enlisted and was assigned as a private in Company H. After initial training Reynolds was detailed as a clerk at the headquarters of the III Corps, First Division - USA. He kept this post until the Battle of Fair Oaks on May 31, 1862, where he fought and was one of three members of his company taken prisoner. He was exchanged in September 1862, after serving time in prisons in Libby and Belle Isle, Virginia, and Salisbury, North Carolina.

Upon being exchanged, Tilton was granted a leave of absence before rejoining his company in December 1862. He remained in its service until the end of the war.

Tilton was promoted to sergeant-major on September 23, 1864, and soon thereafter, commanded Company H after receiving a captain's commission on November 25, 1864.

Captain Reynolds was mustered out with the soldiers of the 105th Regiment on July 11, 1865. He died in 1913 and was buried in Beuhela Cemetery in Reynoldsville, Pennsylvania.

During the Civil War, Tilton Reynolds corresponded extensively, to and from, his family. Between September 1861 and March 17, 1862, Tilton was stationed at Camp Jamieson, Fairfax County, Virginia. There he received many letters from home.
