# GAR Civil War Monument Returns to Lone Mountain Cemetery

During the morning of November 10, 2004, members of the Sons of Union Veterans of the Civil War - General William Passmore Carlin Camp eagerly awaited the arrival of the truck transporting the 113 year old Grand Army of the Republic Civil War monument, back to Carson City, Nevada.

After a four month long refurbishing and restoration procedure the monument was ready to return to "sentry duty" at the Civil War Veteran's section of the Lone Mountain Cemetery.

A score of spectators were present (cemetery personnel, media, etc) which included members of the SUVCW – Camp No. 25 (Paul Washeleski, Gary Parrott, Brian Worcester and Jeffery Vaillant).

Shortly after 11:00 AM, the first of the crew and equipment, to reassemble the monument, began to arrive at the cemetery. At approximately 12:30 PM the truck carrying the sections of the 17 foot tall monument made its entrance - the end of a cross-country trek from the Karkadoulias Bronze Arts Foundry in Cincinnati, Ohio.

Mercene Karkadoulias (owner of the Foundry) and her daughter, Kathy Axiotes, also made the trip to personally oversee the re-assembly of the monument and to be present during the re-dedication ceremony on Veteran's Day.

# General Carlin Camp Participates in Carson City Veterans Day Event

On November 11, 2004, members of the Sons of Union Veterans of the Civil War assembled at the Lone Mountain Cemetery, Carson City, Nevada, to participate is a very special and historic Veterans Day memorial service. The main event was the unveiling of the newly refurbished and repaired Grand Army of the Republic - Civil War monument.

Present during this auspicious occasion, and despite the prediction of a major storm front passing through the region during the day (bringing the possibility of snow or rain !!), were over 200 spectators, participants, dignitaries and various media personnel.

The Memorial Services included speeches, music, military color guards, Civil War re-enactors and the rededication of the GAR Civil War Monument.

#### Monument Returns - cont.

Two "time capsules" were placed inside the monument (which is now hollow with the removal of its concrete "filler"). One from the SUVCW – Camp No. 25 and one from Carson City.

The "time capsule" from the SUVCW contains a current membership roster of the Camp, newspaper articles about the restoration process, photographs, various 2004 coins and other items of interest.

The reassembly process went without a hitch (unlike the dismantling process in July !!) and all was completed by 3:30 PM.

The monument was then covered with a large blue tarp (to be removed during the re-

dedication ceremonies scheduled for Veterans Day).

The refurbishing project cost \$82,000 which included repair of all cracks, chips, holes and other types of deterioration. Also, a new stainless steel interior was added to support the weight of the statue and a coating of a special blue-gray sealant to preserve the monument's non-metalic zinc alloy exterior from weathering.

It should be noted, this restoration project would not have gone forward without the tireless efforts of several historical, hereditary and civic groups (specifically included in that group for special recognition was the SUVCW - General Carlin Camp No. 25 !!) and the support of the City Council of Carson City, Nevada, and Mayor Ray Masayko.

The afternoon events included a wide range of activities and participants. Several military, civic and lineage societies were represented during this event.

The master of ceremonies was David Stultz (Sexton, Lone Mountain Cemetery District). He and his staff had meticulously prepared the grounds of the cemetery for this auspicious occasion. Flags and beautiful floral bouquets could be seen adorning the graves and headstones of Veterans throughout the historic cemetery.

Participants included members of the Naval Sea Cadet Color Guard, Sons of Union Veterans of the Civil War and members from the Nevada Civil War Volunteers.

Guest speakers included Carson City Mayor Ray Masayko, Cindy Southerland (local historian), Brad Schall (SUVCW – Dept. of Calif. & Pacific), David Stultz (Lone Mountain Cemetery District), Mercene Karkadoulias (owner of the foundry which restored the monument) and Paul Washeleski (SUVCW – Camp No. 25).

Representing the SUVCW as members of the Color Guard were - Paul Washeleski, Gary Parrott, Brian Worcester, David Davis, Frank Wood and Don Guidici (from Camp No. 25). Also present were - Brad Schall and Kirby Morgan (from the Dept. of California and the Pacific).

Music during the Veterans Day Memorial Service included a moving rendition of *Amazing Grace* performed by Robert Bledsaw on the bagpipes.

Also present and providing valuable assistance during this event were – Jeffrey Vaillant, Camp No. 25 Tresurer (manning the Camp's display/recruitment table) and Lori Parrott, Auxiliary to the SUVCW – Dr. Mary E. Walker No. 52 (taking video and photographs of the event).

## The S. U. V. C. W.

The Sons of the Union Veterans of the Civil War was formed in 1881 as the potential successor to the Grand Army of the Republic (GAR). Its purpose was to ensure the continuance of the mission and goals started by the GAR. It was originally called: The Sons of Union Veterans. The name was changed in 1925 to further identify its heritage.

Prior to the disbanding of the GAR (when the last surviving members died), the SUVCW was officially designated the legal heir to the GAR on August 20, 1954.

Currently, the SUVCW is composed of 26 Departments (each contain Camps located within one of more states in a geographical region), 5 Camp-at-Large organizations (for the states of AZ, GA, NC, OR and WA) and a National Membership-at-Large organization (for those states which do not have Camp or Department status). Total membership is approximately 6,000 Brothers in good standing.

In addition, the SUVCW is associated with several Allied Orders. These include: Sons of Veterans Reserve, the Auxiliary to the SUVCW, Daughters of the Union Veterans of the Civil War, Women's Relief Corps and the Ladies of the GAR.

# The Latest SUVCW National News

The following is the latest information and General Orders from the National Organization of the Sons of Union Veterans of the Civil War:

#### **GENERAL ORDERS SERIES 2004 – 2005**

#### **GENERAL ORDERS No. 3**

Stephen A. Michaels Commander-in-Chief

The following is the Commander-in Chief Kent Armstrong's suspension of Douglass R. Knight, from any and all duties, as an officer of the William Tabor Camp No. 162, Department of Massachusetts. A hearing council was appointed, pursuant to the C & R, Chapter V, Article VI, Section 17B.

The Council was composed of six brothers, one each from the Departments of Connecticut, Maine, Maryland, New Jersey, New York, and Vermont. A seventh, from New Hampshire, recused himself.

On August 4, 2004, the hearing council completed its deliberations. The council found that Brother Knight was guilty of the charges, described in the Commander-in-Chief's General Order No. 16.

It was the sentence of the council that Brother Douglass R. Knight be removed from all current elective and/or appointed offices of the Order. They further ordered a lifetime ban on holding any elected and/or appointed office of the Order.

A copy of the council's decision was sent to Brother Douglas R. Knight by certified mail on August 9th, 2004. Receipt by Brother Knight was refused.

On September 12th, the requisite 30-day appeal period expired. The members of the hearing council were subsequently discharged with the thanks of the Order.

# Civil War Letter



The above is a copy of an original Civil War letter written in 1864 (from the private collection of the Editor)

# Another Civil War Moment

Andrew Smith Chilcote enlisted as a private on 18 September 1862, at the age of 24, in Company G, 143<sup>rd</sup> Pennsylvania Volunteer Infantry Regiment (attached to the 1<sup>st</sup> Corps, 3<sup>rd</sup> Div, 2<sup>nd</sup> Brigade). As a member of that unit, he would participate in several major battles (Chancellorsville, Gettysburg, the Wilderness and Spotsylvania).

Andrew served honorably during the Civil War and was mustered out with the rest of his Company on 12 June 1865 at Hart's Island, New York. After the War he returned home to Pennsylvania, got married, raised a family and lived for many years, thereafter. He passed away in 1908 (his final resting place is at the Broad Top IOOF Cemetery, Huntingdon County, Pennsylvania).

The below is a transcript of a letter Andrew S. Chilcote sent to a brother-in-law:

Monday April 4, 1864 Camp Near Culpepper, Virginia

#### Mr. S. B. Morland,

My dear brother, it is with much pleasure that I again take up my pen in reply to your kind, kind letter that I received a few days ago. I was glad to hear from you and can assure you that your letter was thankfully received and was read with much pleasure and interest.

If I mistake not, in my last, I promised that I would write something that would be interesting in my next, but as nothing has transpired here since I wrote you last, I am again at a loss, to know what to write that would interest you.

I still enjoy my health good. Jake is not very well at present. He has the mumps. I think he will get over them in a few days if he gets good attendants. They were brought into the regiment by some new recruits who came in a short time ago. Several boys have had them.

I had the pleasure of seeing General Grant a few days since. He reviewed the Fifth Army Corps, infantry and also, General Merritt's cavalry on week before last near Culpepper. He is a noble looking man. And from his appearance I think he possesses those qualities which are necessary to enable him to complete the great work that is now before him. I hope and trust that luck and success will crown his efforts and earnestly pray that he may be directed by a divine inspiration so that he may victoriously lead our noble and gallant armies against the host of armed traitors and Rebels of the South.

All is quiet along our lines, there is no signs of active operations at present. But though things seem to be quiet just now, yet, it is very certain that all necessary preparations are being made for a vigorous prosecution of the war in the coming campaign. And if our armies are only victorious, which it is hoped they will be, the coming struggle will end the war. May God preserve us and fight our battles and deliver our enemies into our hands.

You wanted to know in your letter what I had done with my money. Well, I sent it by express to Uncle Samuel Miller and requested him to send it home. I expect to be paid again in a few days and will send it home immediately by express if I have the opportunity. If you need money, let me know and I think I can accommodate you.

I think I must soon close for the present. I want you to ask L. B. Morland if he got my letter and if he did why he don't answer. Give my love to Polly and Elly. I want you all to continue to pray for us. May God bless you all with all needful blessings - is the prayer of your affectionate brother. Write soon,

The above letter contained several Civil War references, some of which were:

- in Spring 1864, 143rd PA Inf Regt was stationed near Culpepper Court House, VA;
- Gen. Grant established his HQ at the Culpepper Court House (on 26 March 1864);
- Gen. Wesley Merritt was the commander of the 1st Div Cavalry Corps AoP; and,
- the anticipated start of the major Union offensive that would begin with the Battle of the Wilderness (May 1864) and culminate at Appomattox Court House (April 1865).

# General William P. Carlin Camp No. 25

Organized in December 2002, the first official Camp meeting was held on March 1, 2003, in Gardnerville, Nevada, and, subsequently, was officially chartered by the Sons of Union Veterans of the Civil War – Department of California and the Pacific on August 23, 2003.

#### Maplewood Cemetery, NJ

The above is a photograph of the historic Maplewood Cemetery in the City of Freehold, Monmouth County, New Jersey, within which is located the final resting place of *Edwin F. Applegate* (a Civil War ancestor of Camp No. 25 member and Commander *Paul Washeleski*). He was the Colonel of the 29<sup>th</sup> New Jersey Volunteer Infantry Regiment from 1862 to 1863.

# Our Civil War Ancestors

Edwin Forest Applegate (a Civil War ancestor of Camp No. 25 member – Paul Washeleski) "heeded the call" from President Lincoln on 4 August 1862 for an additional 300,000 soldiers "To Preserve The Union".

Subsequently, *Edwin* offered his services and was commissioned as the Colonel of the 29<sup>th</sup> New Jersey Volunteer Infantry Regiment on 12 September 1862 (\* note: he had experience as an officer in the Rhode Island State Militia prior to the start of the Civil War).

Upon successful organization of the regiment at Camp Vredenburg (with 39 officers and 866 men) the 29<sup>th</sup> New Jersey Infantry Regiment left for Washington DC on 20 September 1862. Upon arrival, it was attached to General John J. Abercrombies's Brigade (of General Silas Casey's Division) AKA - the Defenses of Washington.

On 30 November 1862, the 29<sup>th</sup> New Jersey Infantry Regiment was re-assigned and attached to General M. R. Patrick's Provost Guards - Army of the Potomac. It was then ordered to proceed to Aquia Creek, Virginia, where it performed provost duty and security for the railroad in that region. During that time, the regiment was involved in several skirmishes with Rebel forces in that area.

Later, in December 1862, the 29<sup>th</sup> New Jersey Infantry Regiment would participate in the Battle of Fredericksburg, Virginia, and would earn distinction as the last Union Army unit to withdraw from that city under enemy cannon fire.

\* major battles or actions: the *Battle of Fredericksburg*, Virginia (December 13-15, 1862).

On 16 January 1863, *Edwin* resigned his commission (due to poor health) and returned home. However, his association with the Grand Army of the Republic did not end there.

*Edwin* was instrumental in the formation of the GAR- Captain James W. Conover Post No. 63 (established: 16 January 1882 in Monmouth County, New Jersey) and was the Post Commander from 1883 until 1885. Additionally, he was instrumental in the formations of the Women's Relief Corps No. 1 of New Jersey (associated with the GAR - Frank Lloyd Post No. 79). Furthermore, he assisted in the formation of the Monmouth Battle Monument Association (an organization dedicated to the erection of monuments, plaques and other tributes to commemorate the memory of military personnel who served their country from Monmouth County).

*Edwin F. Applegate* was born in New York City, New York, on 3 June 1831. He was one of five children born to William and Ann (Martin) Applegate. William Applegate had been a prominent businessman and well know printer in New York City during the mid-1800s.

On 21 April 1849, *Edwin* married (Mary Lucinda French) in New York and over the years they had 8 children. Sometime prior to 1857 they moved to Rhode Island where he engaged in the newspaper business.

Shortly after the start of the Civil War, *Edwin* and his family moved to Monmouth County, New Jersey. There he was offered a commission in a newly forming militia unit (29<sup>th</sup> New Jersey Volunteer Infantry Regiment).

After his tour of duty, *Edwin* returned home and resumed the life of a family man, newspaper publisher and editor. Over the years he became a very successful businessman and important member of the community.

On 23 January 1885, *Edwin Applegate* passed away at the age of 53. His final resting place is at the Maplewood Cemetery, Freehold, New Jersey.
