## CAMP 25 READY FOR 2022 WREATHS ACROSS AMERICA

Wreaths Across America for 2022 will be held on Saturday, December 17th. WAA had a corporate match program running from December 18, 2021 until January, 14, 2022. For all sponsor pages, they would match all purchased wreaths one for one.

## RITUALS, CUSTOMS AND TRADITIONS

The local GAR post officers were elected by the membership of the post, and each member was voted into membership using the Masonic system of casting black or white balls (except that more than one black ball was required to reject a candidate for membership). When a candidate was rejected, that rejection was

reported to the Department which listed the rejection in general orders and those rejections were maintained in a Black Book held at each Post meeting place or Post Hall. The meeting rituals and induction of members were similar to the Masonic rituals and have been handed down to the descendant organizations, including the Sons of Union Veterans of the Civil War. During meetings, conducted according Ritual, the Guard secures the Camp room and ensures that on one is permitted to enter or leave the Camp room, except in the performance of duty, and under orders of the Commander. During recesses the room may be opened. When a member wishes to enter the Camp when the Camp in session, the member shall knock with three raps and present their membership card to the Guard. Upon entering the member proceeds to the alter, salutes the Commander, and upon return of the salute takes his seat

The Minutes of the October meeting were previously reported to all members of Camp 25 via the Camp newsletter. Secretary Hess asked if there were any additions or corrections. **Being none, it was MOVED (Linscott) and SECONDED (Dickey) to approve the Minutes of the October meeting as submitted. The motion PASSED unanimously.**

**IV. Treasurer's Report—Treasurer David Hess.**

- 1. Brother Hess presented the Financial Statement for Camp 25 for the period ended November 30 which was previously mailed to members. Hess asked if there were any questions/additions/corrections. **HISTORY AND MEMORIALS REPORT**

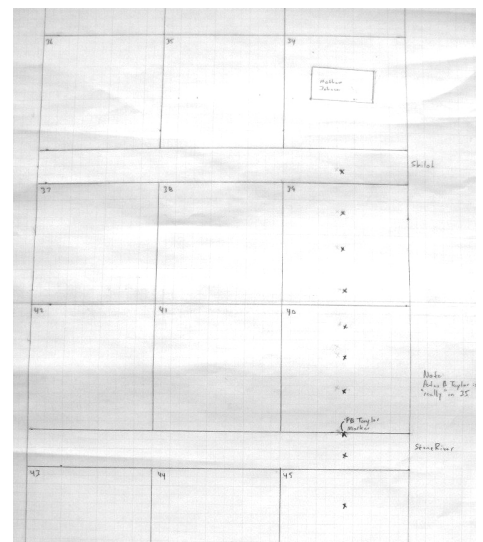

**NOTES ON THE G.A.R. CEMETERY AT HILLSIDE**

I created a map of the Gen. Mitchel Post 69 cemetery at Hillside on graph paper with a scale of 0.25 inch = 1 foot using the old cemetery plot map measurements. The deed states the cemetery is 329 feet long north-south and 42 feet wide. Recently a few graves on the south east side of the cemetery caved in and were later filled in by the Hillside Cemetery Preservation Foundation (see next page). Fran Tryon of the Foundation, Donn Dalton of the Foundation and Camp 25, and I measured the distance of the depressions from the marked grave of Mathew Johnson (Plot 34) just to the north. The depressions marked by an “X” lined up quite well with the plots noted on the map. The numbered plots are 14 feet by 14 feet and the lanes in between are 4 feet wide. Note that a marker for P. (Peter) B. Taylor is in the line, but he is actually buried in Plot 35.

After looking at the old plot map and the County Assessor’s maps, it



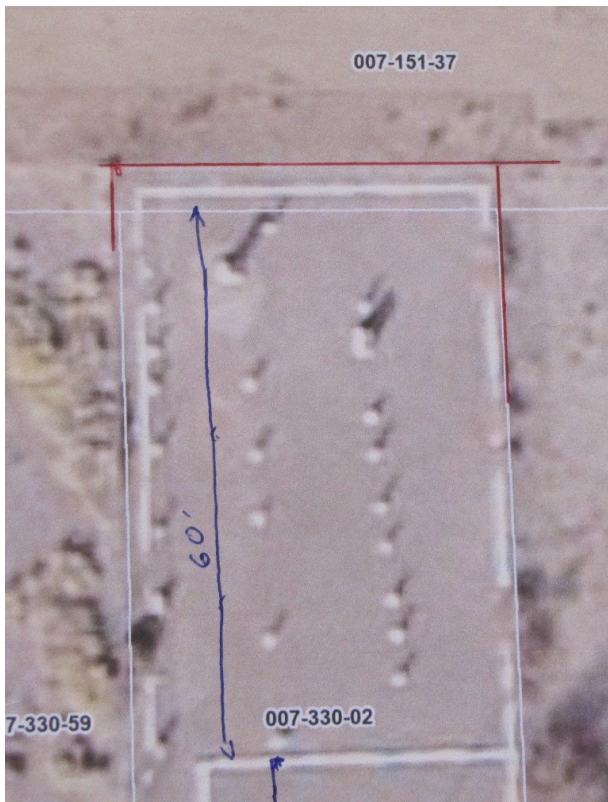
appears the fence is lies beyond the actual property lines, and even the northern three or four feet of what is considered to be the cemetery may also lie beyond the line. In the poor County Assessor's images below the white lines are the property lines, and the red line marks the fence. When checked against similar images of the road right-of-ways and other properties, the lines on the images appear to be accurate, though the website carries a disclaimer about using the maps as the final legal say. The 60-foot line marks the distance noted on the old cemetery plat map from the flag pole area to the top line on that map, which corresponds with the actual property line according to the Assessor's map. I measured it with a measuring tape. Food for thought.
