I have continued to review the By-laws discrepancies, but I will be meeting with the Camp Secretary-Treasurer about the deadlines before I make some proposals for change, probably before the April meeting.

CAMP BOUNDARIES

One of the By-law discrepancies I have found is that the website description of our camp boundaries does not match the By-law description. Several of us Camp Commanders are concerned about this and have inquired to Department Commander Tad Campbell. This was his reply:

Brothers:

As you can see, I have received several e-mails concerning Camp boundaries.

A solution to this issue was presented by Camp 4 several years ago at the Department Encampment, and subsequently referred to a committee that was never appointed by the Department Commander. The issue was again brought before a Department Encampment and again referred to a committee, which I appointed and which reported back to the following Encampment with its recommendation. The proposal was rejected and the general consensus was that the Camp boundaries should be worked out amongst the individual Camps affected.

Therefore, the Department's hands have been tied by the wishes of the Encampment and I would hereby direct the individual Camps to come up with modified Camp boundaries through mutual agreement. Any changes decided upon should be relayed to the Department Commander for distribution to the Signals Officer, Eagle Scout Certificate Coordinator, Patriotic Instructor, Junior Vice Commander, and any other concerned Department Officers.

Once upon a time there was a map defining the Camp boundaries, but with the addition of several new Camps the map has become obsolete and was discarded.

In F, C, & L, Tad

Tad D. Campbell, PCC Commander Dept. of CA & Pacific Sons of Union Veterans of the Civil War Some camps have overlapping boundaries and some areas lack camp coverage. This can lead to duplication of effort in the graves registration and monument documentation efforts. Apparently, it's up to adjoining camps to work out differences. I have been in contact with our neighboring Camps 12, 22, and 26. The possibilities are to have the GAR Highway mark the boundary between us and Camp 12 in southern Nevada. Tonopah and probably Ely would go to our Camp. The boundary between us and Camp 26 will likely be the Stateline north from the Hallelujah Junction area and then along Route 70. Several ideas for the boundary with Camp 26 are still being considered but it will probably partly follow Route 89 south from Route 70 and cut due south to a point along Route 50. I will have a map showing some of this to begin discussions at the meeting. Once we settle on the boundaries the Department will approve them, and I suggest we fix them in the By-laws and on the website accordingly. The boundaries will then be fixed until the need for readjustment when new camps are created.

General Orders No. 5

Hundreds of brothers of this Order took the time to observe Remembrance Day, by either attending the special ceremonies in Gettysburg, Pennsylvania, or the various activities conducted by Departments and Camps of the Order all across this great country. Through my participation in the Gettysburg event and by viewing photographs forwarded of other observances, I noted countless brothers, proudly wearing their member badge of our Order and honoring both the Grand Army of the Republic and our 16 th President in his delivery of a speech, now known as the Gettysburg Address.

- To those brothers who marched in the parades, participated in the observances, and represented our Order in many ways and to those who were able to be with us in spirit only, I convey to each of you, a Job Well Done.
- I have been privileged to honor several, both within and outside of our Order, for acts and programs that help keep green the memory of the Grand Army.
- To Brother Past Commander-in-Chief Al Loomis, the Meritorious Service Award with Gold Star was approved and awarded at the Council of Administration meeting in Gettysburg, Pennsylvania, for his work on several committees, including the Lincoln Tomb Ceremony Committee and his spearheading the work to commemorate the 2009 anniversary of the birth of Abraham Lincoln, recommended by the Commander-in-Chief.

General Orders No. 6

- During the 122nd National Encampment, National Color Bearer Jeff Stephen recommended a Special National Committee. The purpose of this committee was to inventory all Civil War battle flags in the possession of the Federal government and also the several States and further, to learn the status of each State's preservation program.
- In his General Order #2, then Commander-in-Chief Kent Armstrong appointed brother Jeff Stephen to chair the National Committee on Civil War Flag Conservation.
- This Special Committee has not filed any reports, including at the 123 rd, 124 th and 125 th National Encampments and for the Council of Administration meeting recently held in Gettysburg, Pennsylvania. This committee is not functioning.
- Therefore, this committee is discharged.

General Orders No. 8

Upon the recommendation of Michigan Department Commander Richard Greene, being fully satisfied that all efforts to preserve the Camp have been taken, IT IS ORDERED the Charter of the George W. Howe Camp #9, Department of Michigan, is revoked for failure to submit Annual Camp Reports and Per Capita Tax. This order is effective as of December 31, 2006. Ordered this 6th day of January, 2007.

General Orders No. 9

- 1. Brother Robert Moore, Commander of the Luray-Carlisle Reunion Camp #1881, Department of Maryland, is hereby appointed a National Aide and charged to complete an inventory of all Union battle flags held by the Federal government and various state entities.
- 2. An Exploratory Committee is hereby authorized and charged with exploring the possibilities of erecting a suitable monument to commemorate the services of Canadians in the Union army during the Civil War. This committee is to study the feasibility, explore possible locations, review preliminary designs and fund raising opportunities, to report to the 126th National Encampment, with the view of potentially appointing a Special Committee to pursue this venture. Brother Bob Heath, Member at Large and residing in Canada, is appointed chair of this exploratory committee. Any brother of the Order interested in serving on this committee should contact the Commander-in-Chief. Ordered this 20th day of January, 2007.

THE GENERAL WILLIAM PASSMORE CARLIN CAMP 25

SONS OF UNION VETERANS OF THE CIVIL WAR

WILL HAVE AN OPEN HOUSE FOR THE GENERAL PUBLIC ON SUNDAY, FEBRUARY 11, 2007, AT 1400 HOURS (2 PM) AT THE VFW POST 9211 HALL AT 255 BURRIS LANE NEAR ITS INTERSECTION WITH BAKER LANE NEXT TO MOANA PARK.

THE OPEN HOUSE WILL CONSIST OF A DISPLAY OF GRAND ARMY OF THE REPUBLIC AND RELATED ITEMS, A SLIDE SHOW ABOUT THE GRAND ARMY OF THE REPUBLIC AND THE SONS OF UNION OF THE CIVIL WAR IN NEVADA, AND COFFEE AND SNACKS.

PRESIDENT ABRAHAM LINCOLN, WHOSE BIRTHDAY ON FEBRUARY 12 WAS AT ONE TIME A HOLIDAY, WILL ALSO BE HONORED.

THE GRAND ARMY OF THE REPUBLIC, OR GAR AS IT WAS MORE COMMONLY KNOWN, WAS AN ORGANIZATION OF UNION CIVIL WAR SOLDIERS THAT LASTED FROM 1866 UNTIL 1949. AT ITS HEIGHT IN 1890, IT HAD OVER 409,000 MEMBERS AND 7,000 LOCAL POSTS ACROSS THE COUNTRY AND WAS A DRIVING FORCE BEHIND VETERANS' BENEFITS AND GETTING MEMORIAL DAY RECOGNIZED. THE GAR WAS ALSO THE FORERUNNER OF OTHER VETERANS' ORGANIZATIONS SUCH AS THE VETERANS OF FOREIGN WARS AND THE AMERICAN LEGION. BETWEEN 1868 AND 1937, NEVADA HAD 18 POSTS INCLUDING ONES IN RENO, CARSON CITY, AND VIRGINIA CITY. THE GAR CEMETERY AND TREE IN RENO, AND THE GAR PLOT AND STATUE IN THE LONE MOUNTAIN CEMETERY IN CARSON CITY ARE PART OF THEIR LEGACY. THE WOMANS RELIEF CORPS, LADIES OF THE GRAND ARMY OF THE REPUBLIC, SONS OF VETERANS RESERVES, SONS OF UNION VETERANS OF THE CIVIL WAR, AND DAUGHTERS OF UNION VETERANS OF THE CIVIL WAR, AND STILL EXIST TODAY. THE SONS OF UNION VETERANS OF THE CIVIL WAR, WHICH HAS TWO CAMPS IN NEVADA, IS THE DESIGNATED HEIR ORGANIZATION TO THE GAR.
