#### NEVADA DAY AND VETERANS' DAY ACTIVITIES

October 31, 2009; November 11, 2009

Historian/Memorials Officer David A. Davis, PCC, Tyrone Davis, Senior Vice Commander John Riggs, Camp Commander Frank Wood, Secretary-Treasurer Brian Worcester represented Carlin Camp 25 at the Nevada Day Parade, which was actually be held on October 31, the real Nevada Day this year, in Carson City. For those of you who may not know it, Nevada became a State on October 31, 1864, hence, Nevada Day. We used Frank's pick-up truck and hung the Camp and 36-star U. S. flags from the back of the bed and put the Camp signs on the side. David, Tyrone, and Brian rode in the back using chairs borrowed from VFW Post 9211. The weather was nice, and the parade route was well attended. After we exited the parade, we attended the chili feed put on at the Nugget.

David, Tyrone, and Brian represented Carlin Camp 25 in the Veterans' Day Parade in Reno. We used Brian's Jeep Cherokee. This was the first time we used hitch haul-cum-flag holder, and it worked well. We displayed the Camp flag, 36-star U. S. flag, and the old State flag donated by Paul Washeleski, PCC. Thanks to Craig Roelofs, we had a color guard from the Comstock Civil War Reenactors, which marched in front of us. Craig is a first sergeant Co. C of the 2nd U. S. Regular Infantry. Also participating were his wife Christa, daughter Brinn, and sons Cody, Caden, and Brodrich, and Eric Quinlan, Harvey Mitchell, and Gerry and Janet Dunlap. Christa was the photographer, and she and Brinn rode in the Jeep. Gerry and Janet portrayed civilians. As a Scotsman, Gerry wore his kilt and related attire, and his wife Janet wore an 1860s dress. The crowd was well attended, and we were generally well received as we went by. John Tyson in one of the speakers' booths commented on Brian's genuine Civil War-era Jeep.

In the afternoon on Veterans' Day, Brian, Tyrone, and David with his wife Jenny, attended the rededication of the Veterans Memorial at the Lone Mountain Cemetery, which was held by American Legion Post 56 of Carson City and others. Veterans Memorial had been rebuilt by the

Leadership Carson City Class of 2009. After the ceremony, Brian, David, and Tyrone laid a wreath at the statue in the Custer Post 5 plot. We had a moment of silence, and then Brian fired a salute from his revolver.

## RECENT CIVIL WAR VETERAN FINDS

I recently attended the monthly meeting of the Nevada State Genealogical Society at the Reno Family History Center. While waiting, I perused the Nona Parkin collection. Nona Parkin spent many years compiling lists from cemeteries, vital records, mortuary records, and obituaries across Nevada and parts of California. The lists are available at the Historical Society on microfilm and in about 100 or so binders at the RFHC. I made a few notes on several promising veterans and sent them to our Graves Registration Officer Don Huffman. My notes are in not italicized below, and Don's research notes are italicized.

#### From list of graves in Paradise Valley Cemetery, Humboldt Co., NV:

John J. Stewart Corp. Co. D Mich. Cav. 1845-1925 (no regiment number) Catherine Stewart 1865-1945 Fred B. Stewart 1881-1959 Edith C. Stewart 1886-1965 4th Regiment (He is listed in our database)

Thomas Melody Co. D 45 Illinois Inf.

According to records he was a Pvt. with the 146th Illinois Inf.

(He was not listed in our database, but will be shortly)

#### **Eddy Mortuary Records:**

5 February 1929 - John James Stewart - IOOF Cemetery, Paradise Valley (yes 1929) 19 March 1935 - Thomas F. Melody - IOOF Cemetery, Paradise Valley

#### Reese River Reveille, May 31, 1885:

W. S. WILLIAMS, a former resident of Washoe City, Nev. A GAR veteran. Shot at Lovelock. Very peacacle man and never had a quarrel with anyone. Leaves wife and 4 children, the youngest being 6 years old.

#### From list of graves in Big Meadows Cemetery, Lovelock, NV:

W. S. Williams 1835-1885

Eliza J. Williams 1848-1919 (IOOF)

William S Williams, enlisted as a Sergeant on 5 Nov 1864 at Sacramento, CA. Co. G, 2nd Ca Cavalry. Mustered out at Camp Union, CA 1 Feb 1866. He is buried at the Big meadows Cemetery Lovelock, NV, No military stone or marker. He shares a private marker with his wife. He will be our Camps first CW burial that I have record of in Pershing County. Although he probably died ,at the time, in Humboldt County.

(He was not listed in our database, but will be shortly)

#### Reese River Reveille, June 18, 1885:

ERNEST REDBURGH aged 91 yrs; veteran of Mexican War and Civil War and said to be the oldest Commander (or comrade) of the GAR, died today at Vancouver, Washington Territory.

Last name is probably in reality Rettberg, was born in Hannover, Prussia in 1794. He and his wife Catherine lived in WI when he joined Co. C 3rd US artillery as a musician (most likely a bugler). He was living with his son Henry A Rettberg, in Vancouver City, Clark County, WA at the time of his death in 1885. Find a Grave has no marker picture but does list him with out birth or death

dates, but as a band member in the Civil War. He is buried in the Old Vancouver City Cemetery Clark County, WA. I sent an email to the contributor to please up date this Civil War Veteran's information at Find A Grave.

On a recent trip to State Archives, I had a number of miscellaneous files copied concerning Nevada and the Civil War. These include information on the Nevada Volunteers, militias, and correspondence. While there, they brought out the 36-star flag that flew over Fort Ruby in eastern Nevada. Fort Ruby was active from 1862 to 1869 mainly to keep tabs on the Indians. The flag was less than 2 feet by 3 feet, and consisted of the colors painted on canvas. The archivist was going too look for the documentation. SVC John Riggs said they have other flags stashed away.

Former Carlin Camp 25 member Jeff Vaillant recently visited the National Archives at San Bruno. He made copies of the burial lists of Forts Halleck, McDermit, and Ruby and sent them to us. Unfortunately, they did not have the burial list for Fort Churchill.
