# **EAGLE SCOUT CERTIFICATES**

It was brought up at the last meeting to look into reviving the program of handing out Eagle Scout certificates. I had looked into this when I was Camp Commander. At that time, the Boy Scout Headquarters for the Nevada Area Council said they would send us a monthly list of those making Eagle Scout. They said then between about 10 and 20 make it monthly. I contacted Department Eagle Scout Certificate Coordinator Al Peterson for more information. He also coordinates the program for the Keith Camp 12 in Las Vegas, and said their Camp hands out about 450 or so annually. He has the form scanned and prints it out on the proper weight paper and either mails it, or if invited makes a point to go to the Court of Honor and personally hand it to the new Eagle Scout. Because of the time involved, it was decided by the Camp to have a "passive" program where anyone interested could just contact us. I handed out one certificate over a year ago to the son of parents I know. We have had no inquiries.

A couple of weeks ago, I went the Boy Scout Headquarters and inquired again. They said that when we are ready, they will send the monthly list to our responsible party. If we are going to do this, we will need a "responsible party", a very good scan of the certificate, and a very good printer. Work, family, and my present level of SUVCW duties preclude me from taking on this responsibility. Also, my scan was so-so, and my printer did a <del>crappy</del>, er, less than professional job of printing it out. After trial and error with plain paper and backlighting, I was able to print directly on a form from National and make it look like something near professional.

This battle, in 1868, was the only battle site where a US Army soldier was awarded the Medal of Honor for an action within our State. Camp Brothers have done extensive research concerning this action and plan to mark via GPS any artifacts as well as extensive photography. Brother Riggs also has submitted extensive material including Execution of Union Soldiers for Heinous Crimes during the Civil War and a Civil War Diary and photos of related Tombstones to the Indiana Genealogical Society Journal.

# HISTORY AND MEMORIALS REPORT

December 20, 2009

David A. Davis, SUVCW Gen. William Passmore Carlin Camp 25 Camp Historian/Civil War Memorials Officer.

The following is a summary of recent activities:

## **RECENT CIVIL WAR VETERAN FINDS**

I recently attended the monthly meeting of the Nevada State Genealogical Society at the Reno Family History Center. While waiting, I perused the Nona Parkin collection. Nona Parkin spent many years compiling lists from cemeteries, vital records, mortuary records, and obituaries across Nevada and parts of California. The lists are available at the Historical Society on microfilm and in about 100 or so binders at the RFHC. I made a few notes on several promising veterans and sent them to our Graves Registration Officer Don Huffman. My notes are in not italicized below, and Don's research notes are italicized.

#### From list of graves in Paradise Valley Cemetery, Humboldt Co., NV:

John J. Stewart Corp. Co. D Mich. Cav. 1845-1925 (no regiment number) Catherine Stewart 1865-1945 Fred B. Stewart 1881-1959 Edith C. Stewart 1886-1965 4th Regiment (He is listed in our database)

Thomas Melody Co. D 45 Illinois Inf. According to records he was a Pvt. with the 146th Illinois Inf. (He was not listed in our database, but will be shortly)

#### **Eddy Mortuary Records:**

5 February 1929 - John James Stewart - IOOF Cemetery, Paradise Valley (yes 1929) 19 March 1935 - Thomas F. Melody - IOOF Cemetery, Paradise Valley

#### Reese River Reveille, May 31, 1885:

W. S. WILLIAMS, a former resident of Washoe City, Nev. A GAR veteran. Shot at Lovelock. Very peacacle man and never had a quarrel with anyone. Leaves wife and 4 children, the youngest being 6 years old.

#### From list of graves in Big Meadows Cemetery, Lovelock, NV:

W. S. Williams 1835-1885 Eliza J. Williams 1848-1919 (IOOF)

William S Williams, enlisted as a Sergeant on 5 Nov 1864 at Sacramento, CA. Co. G, 2nd Ca Cavalry. Mustered out at Camp Union, CA 1 Feb 1866. He is buried at the Big meadows Cemetery Lovelock, NV, No military stone or marker. He shares a private marker with his wife. He will be our Camps first CW burial that I have record of in Pershing County. Although he probably died, at the time, in Humboldt County.

(He was not listed in our database, but will be shortly)

#### Reese River Reveille, June 18, 1885:

ERNEST REDBURGH aged 91 yrs; veteran of Mexican War and Civil War and said to be the oldest Commander (or comrade) of the GAR, died today at Vancouver, Washington Territory.

Last name is probably in reality Rettberg, was born in Hannover, Prussia in 1794. He and his wife Catherine lived in WI when he joined Co. C 3rd US artillery as a musician (most likely a bugler). He was living with his son Henry A Rettberg, in Vancouver City, Clark County, WA at the time of his death in 1885. Find a Grave has no marker picture but does list him with out birth or death dates, but as a band member in the Civil War. He is buried in the Old Vancouver City Cemetery Clark County, WA. I sent an email to the contributor to please up date this Civil War Veteran's information at Find A Grave.

### **RECENT TRIP TO STATE ARCHIVES**

On a recent trip to State Archives, I had a number of miscellaneous files copied concerning Nevada and the Civil War. These include information on the Nevada Volunteers, militias, and correspondence. While there, they brought out the 36-star flag that flew over Fort Ruby in eastern Nevada. Fort Ruby was active from 1862 to 1869 mainly to keep tabs on the Indians. The flag was less than 2 feet by 3 feet, and consisted of the colors painted on canvas. The archivist was going too look for the documentation. SVC John Riggs said they have other flags stashed away.

Former Carlin Camp 25 member Jeff Vaillant recently visited the National Archives at San Bruno. He made copies of the burial lists of Forts Halleck, McDermit, and Ruby and sent them to us. Unfortunately, they did not have the burial list for Fort Churchill.
