Custer Post No. 5 statue.

#### PARADISE VALLEY EXPEDITION

June 6, 2010

Several of us will be going up to Paradise Valley and the Santa Rosa Mountains north of Winnemucca in an attempt to locate where the U. S. Cavalry detachment that included Private James C. Reid skirmished with Chief Howluck and his warriors in 1868. This skirmish resulted in Private Reid receiving the Medal of Honor and has been described in previous issues of the Carlin Camp Dispatch. Brian Worcester and others will be leaving at 5 am sharp on June 6 from the parking lot of the VFW Post 9211 Hall. David A. #### HISTORY AND MEMORIALS REPORT

April 25, 2010

David A. Davis, SUVCW Gen. William Passmore Carlin Camp 25 Camp Historian/Civil War Memorials Officer.

The following is a summary of recent activities:

#### **NEVADA GAR/SUVCW PRESENTATION**

I recently acquired a laptop and projector to attach to it. I scanned and updated the slides to my GAR/SUVCW presentation and figured out how to work Power Point. This will make it much easier to adjust the presentation to the audience.

#### **JAMES C. REID**

Department Civil War Memorials Officer Kirby Morgan subscribes to Footnote and was kind enough to find several dozen pages of records about James C. Reid. Most of it looks like the records we already have, but a few things look different. Unfortunately, its still has no death date or place of burial.

#### **CUSTER POST 5 TRIVIA**

I was looking through the 1884 Department of California GAR Encampment proceedings and came across the following on page 18 under "Visitations" in the Commander's Report:

On my visit to Custer Post, No. 5, Carson Nevada, a special meeting was held, and the work exemplified. The comrades of Custer post have formed a library, where may be found military and historical works, miscellaneous books and magazines; the number collected so far, is over 400 volumes, and constant additions are being made.

The ladies of Carson are active in the management of this library association, and by their zeal add largely to its success.

One of the features of the organization, I understand, is that when Custer Post dies out, the library is to go the Veterans' Home, being a splendid thought and wise provision.

It would be interesting to know what happened to this collection. The "Veterans' Home" at the time was probably the facility at Sawtelle, California, which is now a VA Hospital. It would also be interesting to know where this library was housed. I haven't found where Custer Post 5 met during the 1880s yet.

#### DEPARTMENT OF CALIFORNIA AND PACIFIC ENCAMPMENT

I attended the 124th Annual Department Encampment which was held on March 12-13, 2010, at the NCO Club at Camp San Luis Obispo near San Luis Obispo, California. This was also the 100th Celebration of the Auxiliary's Department of California and Pacific. The encampment went well, and all the same officers were re-elected/reappointed. Hence, I am still the Department Historian. The Auxiliary to the SUVCW and the Daughters of Union veterans of the Civil War also held their conventions at the same time in the same building. I presented the Camp report, which was reprinted in the March issue of the <a href="Carlin Camp Dispatch">Carlin Camp Dispatch</a>. The only other "Nevadan" there was Al Peterson of Keith Camp 12. Brad Schall announced he will run for Commander-in-Chief in 2011. He is the National Junior Vice Commander now. In a departure from recent tradition, after

the meetings, we had a rededication of several recently replaced Civil War grave markers in the Catholic Cemetery. Usually we have a short service at the San Luis Obispo GAR Fred Steele Post 70 cemetery plot.

SUVCW Commander-in-Chief Leo F. Kennedy from Rhode Island and National Auxiliary to Sons of Union Veterans of the Civil War President Nancy Hilton from Virginia attended. The Commander-in-Chief took the train across the country, and this was his first trip to California. He mentioned passing through Reno.

I went down went down a day early and visited the GAR Grant Post 9 cemetery plot in the Pioneer Cemetery in Modesto. It has two massive canon and large Clamper plaque. On the way back, I went to the Big Trees near Santa Cruz and took pictures of the GAR Tree with my digital camera. The film pictures I took last year did not turn out. I also visited the Santa Cruz GAR Wallace-Reynolds Post 32 cemetery plot. It's a tiny one with a flagpole and picket fence. The 1910 GAR Department of California and Nevada Encampment proceedings reported 45 GAR Posts had burial plots, and we know at least three were in Nevada.

# THREE GOLDEN STATE GRAND ARMY OF THE REPUBLIC CEMETERIES



#### DEPARTMENT ORDER No. 2 SERIES 2010-2011

#### PASSING OF BROTHER RICHARD ALLEN IGNATIUS

By the authority vested in me as Commander of the Department of California and Pacific, by the Department Bylaws, the National Constitution and Regulations, and National Policies, it is hereby ordered as follows:

<u>Section 1</u>: Brother Richard Allen Ignatius of Norco, California, a member of The Generals Sedgwick-Granger Camp No. 17, passed away April 18, 2010.

Section 2: Brother Ignatius was born in Long Beach, California on April 7, 1950; he lived with his wife and two children in Norco, California. Rich joined the SUVCW with the Generals Sedgwick-Granger Camp 17 on September 16, 2004. He based his eligibility in the Sons on the service of his great-great-granduncle, Private Jefferson Smith Dowd of Company D, 14th Missouri Infantry (also known as the 66th Illinois Infantry and Birge's Western Sharpshooters). He was a long-time Civil War reenactor, and past president of the Company D, 116th Pennsylvania reenactors of southern California. Rich and his family were active supporters of the Drum Barracks Civil War Museum in Wilmington, California; they were active members of the Corona Genealogical Society, and Rich was an active member of the Orange County Civil War Round Table. Brother Ignatius was instrumental in providing SUVCW support and participation in dedications of Union Civil War veteran grave markers in both Riverside and Corona cemeteries. Rich's son Peter is also a member of Camp 17 and the 116th Pennsylvania reenactors; Rich's wife Diana and daughter Stephanie are members of the Elizabeth Hill-Mills DUVCW Tent 88 of Orange, California.

<u>Section 3</u>: The Department and all Camp Charters are to be draped in black for a period of thirty (30) days.

<u>Section 4</u>: All Department Brothers are respectfully directed to attach a black mourning ribbon to their membership badge (pursuant to C&R, Article III, Sec. 9) for a period of thirty (30) days. <u>Section 5</u>: The Department of California and Pacific extends its sincere condolences to the family of Brother Ignatius and to the Brothers of his Camps and Department.

The foregoing Department Order is proclaimed this 29th day of April in the year of our Lord two thousand ten, and of the Independence of the United States of America the two hundred thirty-fourth, in the City of Newark, County of Alameda, State of California by Charles W. Mabie, Commander of the Department of California and Pacific, Sons of Union Veterans of the Civil War.

- 2. Effective March, 2010, Brother Raymond W LeMay III is appointed a Chair of the Canadian Union Veterans Recognition Monument Committee.
- 3. As Mothers Day approaches, I ask that we re-new a practice followed by the GAR in the early 1900s. In General Orders written by Samuel R. VanSant, Commander-in-Chief of the GAR in 1910, he said, "Who knows better than the members of our order the suffering and sacrifices made by the mothers of '61 to '65, and who of us can forget their devotion to the country and the cause for which we fought." Please join me in honoring our mothers. Let us all adopt the task of wearing a white carnation on Mother's Day, following the GAR who adopted this to support the enactment of Mothers Day and to honor their mothers.

General Order No. 11 SERIES 2009-2010 3 May 2010

A question arose on the Constitution and Regulations, Chapter II, Article II, Section 1, paragraph 1, regarding who can vote at department encampments. The paragraph includes" *Appropriate credentials for all Past Commanders-in-Chief, Past Department Commanders and Department elective and appointive officers shall be issued by the office of the Department Secretary.*" This was reviewed by the National Counselor and he has issued an opinion, which I am adopting as a decision. Listed below is part of the Opinion.

Opinion No. 10 SERIES 2009-2010 National Counselor Robert E. Grim April 13, 2010 Since the Regulations do not specifically list either the department elected or appointed officers among those constituting a department encampment while the Regulations do specifically identify the elected national officers among those constituting a national encampment it is my opinion that the provision in the Regulations stating "Appropriate credentials for all ... and department elective and appointive officers shall be issued by the office of the department secretary" is merely a directive in the Regulations regarding the issuance of credentials by the department secretary intended to make sure someone in the department is responsible for the issuance of department credentials. It does not extend department encampment membership to the elected and appointed department officers.

This Decision becomes effective on this date.
