## WILD WEST FAIR

August 25-29, 2010

Carlin Camp 25 had a booth as an exhibitor at the Nevada Territory Wild West Fair, a. k. a. State Fair in the past, at the Reno Livestock Center. The Fair ran Wednesday, August 25 through Sunday, August 29. Our booth was inside the Livestock Events Center next to the one for the Nevada Volunteer Cavalry, which is a living history group. We had a considerably larger number of people come by than at the Carson City Rendezvous, and we handed out probably over 100 flyers and at least a half dozen membership forms. However, we have yet to hear from anyone following through with the information passed out. Several people were from California, so we may have actually helped their membership there.

Camp Historian David A. Davis, PCC, helped the Comstock Civil War Reenactors during the Wild West Fair by doing Union artillery duty. They have a nice replica of a breech-loading Whitworth 3-pounder fashioned from a World War I ship's gun. Member Tyrone W. Davis also helped by filling out the Union infantry ranks. Both are members of the CCWR.

At the Wild West Fair Jeadene Solberg approached us for information on our Camp. She is also with the Historical Society and a member of the Northern Nevada Ghosthunters. She asked about our meetings and we invited her to sit in on the October 3rd meeting as a guest with her friend Leanette. She said she was very excited to attend. Camp Historian David A. Davis, PCC, has known Jeadene for several years. She has been doing some research on the alleged GAR cemetery in Goldfield.

## **UPCOMING EVENTS**

The Nevada Day parade will be held Saturday, October 30, 2010, in Carson City, and the Reno will be having its annual Veterans' Day parade. For the past few years, we have had entries.

The deadline was September 13, for the Nevada Day parade, and an e-mail is in to see if we can enter late. The deadline for the Veterans' Day parade is October 18. Also, election of officers will be held during the December meeting.

## NATIONAL ENCAMPMENT August 12-15, 2010

The 129th National Encampment of the Sons of Union Veterans of the Civil War, the 124th National Encampment of the Auxiliary to the Sons of Union Veterans of the Civil War, and the 124th National Encampment of the Ladies of the Grand Army of the Republic was held on August 12-15, 2010, at the Overland Park Marriott Hotel in Overland Park, Kansas. The Encampment was hosted by the Department of Kansas and is the first ever held in Kansas. The new Commander-in-Chief is our very own Brad Schall. The new Senior Vice Commander-in-Chief is Donald Palmer, Jr., PDC, of Ballwin, MO, and the new Junior Vice Commander-in-Chief is Perley Mellor of Nashua, NH. ## SOLDIER'S(?) REMAINS FOUND AT UNIONVILLE

During the Wild West Fair, a member of the Nevada Volunteer Cavalry told us a little about some potential Civil War-era remains found near Unionville. Recently, Camp Historian David A. Davis, PCC, talked to Ray Ahrenholz, of that group about it. The info he gave is that the remains were found in the 1980s. A lady was walking her dog, and the dog brought back a human bone. The remains were found in a rock crevice. The police determined they were an archaeological find and not a police matter. The man had been shot in the head, and the remains included brogan shoes, bits of cloth, leather including possibly saddle leather, and small buttons. The materials appeared to be military issue suggesting this man was a soldier, likely Civil War or Indian war era. It's also possible that an Indian was running around out there with pilfered military clothing and horse gear. The remains are the property of the BLM, but Ray was told that they are housed at the Nevada State Museum. No DNA testing has been done. The remains are considered to be a cultural artifact.

Soldiers were stationed at nearby Dun Glen because of Indian troubles (and probably also to keep an eye on southern sympathizers in the Dixie part of Unionville). Gregory Michno's "Deadliest Indian War in the West, The Snake Indian War, 1864-1868" mentions some soldier's deserting or killed in the general area though the Fort Churchill records need to be researched to see if they are recorded.

Ray is an expert in Civil War era uniforms, weaponry, saddles, and leather work and could help identify some of the stuff found. Also, Ray's group has been making inquiries with minimal responses so far, and as I understand it some of the veterans' organizations are also interested in getting this man's remains released and buried as a veteran. Since the remains are considered Federal property, one avenue would be to have them transferred to the Army. Unfortunately, they have not been granted access to even just look at the remains or reports. Senator Reid's office has been contacted, but his veterans' contact says the Senator is too busy electioneering at this time.

I looked into the U. S. Code of Federal Regulations. They specifically cover what can be classified as cultural artifacts, and this includes human remains. Remains that are specifically American Indian are repatriated to the appropriate tribe. The Code allows non-Federal agencies with the proper curation techniques and facilities, such as state museums, to house such collections. The Code limits research to archaeologists, historians, scholars, government officials, and a few others. The Code does specify not allowing members of the general public access to these

collections and related reports including site locations. The concern is that too many members of the general public will rush out to these sites with metal detectors and shovels.

This would probably preclude us from also making a stab at getting these remains at least looked at to see if they might be those of a soldier. On the other hand, we are a Federally chartered organization that is the designated heir to the Grand Army of the Republic, and one of our Camp members is the official Historian to the Department of California and Pacific.

## TOMBSTONE TRIVIA



This is the plot of William Erskine in the Odd Fellows Cemetery in Virginia City. As can be seen, his die is off its base, and the iron post suggests that he had a GAR star at one time. Mr. Erskine died from consumption about midnight on September 23, 1899, aged 54, at a Mrs. Siena's house on B Street, probably a boarding house. According to his tombstone, he was a member of the Grand Army of the Republic, Odd Fellows, and Masons.

He originated from Ireland, and worked in the Comstock Mines for many years. This suggests his ailment was miner's consumption or silicosis and not tuberculosis, which was also referred to as consumption. He went to the Soldier's Home in California several years before he died. The Soldier's Home was located at Sawtelle just outside of Los Angeles and is now a huge VA hospital complex. He returned to Virginia City three months before his death to live out his final days. His obituary stated, "Deceased was of a happy disposition and had many friends in this city." The Phil Kearney Post No. 10 of the Grand Army of the Republic, Virginia Lodge No. 8 of the Odd Fellows, and Pioneer Encampment No. 1 of the Odd Fellows put out newspaper notices requesting their members to attend the funeral. They also noted he was a Patriarch in the Odd

Fellows. The procession left from the Odd Fellows Building and included a drum and bugle corps and a firing squad from Co. A of the Nevada National Guard.



Mr. Erskine had also been in the Civil War in Battery A, the First West Virginia Light Artillery. Notice that the Grand Army of the Republic emblem has oversized crossed cannons indicating an artilleryman.
