CARLIN CAMP 25 REMEMBERANCE OF THE 150TH ANNIVERSAY OF THE START OF THE CIVIL WAR, GAR O. M. MITCHEL POST 69 CEMETERY, RENO, NEVADA

April 16, 2011

To mark the 150th anniversary of the start of the Civil War, Carlin Camp 25 Commander John Riggs, Secretary-Treasurer Brian Worcester, Historian David A. Davis, PCC, and Graves Registration Officer Don Huffman laid a wreath at the grave of the last known GAR member buried in Nevada. George Warren was a private in Company F of the 17th Maine Infantry and the last member of O. M. Mitchel Post 69. The GAR ended in Nevada when he died at the age of 93 in 1936. Larry Balsley and another member of the American Legion and Peggy Fish of the VFW Auxiliary attended. A photographer and Martha Bellisle, a reporter for the Reno Gazette-Journal, also attended. Ms Bellisle had a nice little article and picture of Brian in the April 17 issue of the paper. The presentation given is reprinted at the end of this newsletter.

SAMUEL FULTON


As you all know, the attempt at getting Samuel Fulton a new marker in the Custer Post 5 plot at the Lone Mountain Cemetery in Carson City has been stymied by not being able find out what unit he served in during the Mexican War. During the Civil War, he apparently received his commission as a "Colonel" as an aide to then Pennsylvania Governor Andrew Curtin. Possibly his Mexican War service might be listed with his commission in Governor Curtin's records in the state archives in Harrisburg. Unfortunately, the staff there won't go look and said we would have to go there. A week or so ago, I found the website of the General John F. Hartranft Camp 15 of the SUVCW in Harrisburg. It contains phone numbers, but only the e-mail address of the Chaplain. I sent him a message asking for their help on this matter. So far, so answer, but maybe the person is on vacation

Commander John Riggs and Senior Vice Commander/Historian David A. Davis, PCC, attended the Department Encampment on March 11-12 Camp San Luis Obispo. John had the pleasure to meet Department Civil War Memorials Officer Kirby Morgan, who a couple of weeks ago passed away from cancer.


On the way down to Camp San Luis Obispo, we visited the GAR plot in the Rural Cemetery in Stockton. Ruel Colt Gridley is also buried there. Most of you know the story of Ruel Colt Gridley, a storeowner in Austin, NV, and his sack of flour which raised over \$275,000 for the Sanitary Commission during the Civil War. The traveling around the country ruined Gridley's health. Also, after the Civil War, the mines gave out in Austin, and Gridley had to close his store. He and his family moved to the Stockton area. He had a store and served as postmaster in the mining camp of Paradise for awhile, but was intending to move his business to Stockton when he died. According to some sources, newspaper editors in California and Nevada heard of his family living in poverty and raised money to buy them a house and farm. Unfortunately, Gridley never recovered and died in 1870 at age 41. He was buried in an unmarked grave. In 1887, the Rawlins Post 23 of the GAR raised money by selling miniature bags of flour nationwide and erected a statue Some of this story and pictures can be found on the websites: in his honor. http://civilwar.bluegrass.net/HomeFront/reuelcoltgridley.htm, http://civilwartoday.net/austin.aspx, and http://civilwartoday.net/GridleysGrave.aspx. 


















RON LIENAU, PCC

GENERAL ORDER NO. 16 SERIES 2010-2011 21 APRIL 2011

QUESTION: From the Department of Oklahoma there comes two issues:

- (1) Can a sitting Camp Commander who has not yet completed his first term of office run for the office of Department Commander?
- (2) Can a Brother simultaneously hold the office of Department Commander and Camp Commander or must he vacate the office of Camp Commander if elected to the office of Department Commander?

The Commander-in-Chief concurs with National Counselor Donald Darby, PCinC opinion number 7.

Opinion 7: National Regulations Chapter II, Departments, Article IV Section 2 (Page 27 of the C&R annotated) states that a brother cannot serve as a Department Commander unless he has served as a Camp Commander. I believe that the key to this sentence is the SERVED in the past tense. Thus meaning that the Brother has obtained the rank of PAST Camp Commander.

General Regulations Chapter V Article III Badges and Decorations, Section L (page 56 of C&R annotated) states that a Brother who have served a full term as Camp Commander or who been elected to fill an unexpired term and who has served until the end of that term are authorized to wear the Past Camp Commander Badge and use the suffix P.C.C. in conjunction with their name.

Furthermore, under National Organization Chapter III Article IV Section 2 Footnote 29 (Page 35 C&R annotated) CinC Hammer made the following ruling: When a brother is elected to the office of Department Commander, but it is discovered that he never served as a Camp Commander, the election is void and the office must be declared vacant. If a brother is elected to the Office of Junior Vice Commander-in-Chief but it is discovered that his election to the office of Department Commander was void as he never held the office of Camp Commander, the election is void and the office is declared vacant. Dec 1, CinC Hammer, 110 th, 12 confirmed by National Encampment 110 th, 51.

Given the aforementioned sections of the Constitution and Regulation (annotated) I believe that the Commander-in-Chief must rule that the term served indicates that the Brother must be eligible for the honor of Past Camp Commander (P.C.C.) having served either a full term or fill an unexpired term and who have served until the end of that term before he can run for or obtain the office of Department Commander.

The Commander-in-Chief rules that when a Department commander is elected he must hold the honors of Past Camp Commander.

Question 2: The C&R is mute on the subject at this time and it within the authority of the Commander-in-Chief to make a ruling. From a historical perspective at the 65th National Encampment National Counselor Church issued an Opinion 1 which states that when a Camp Commander is promoted to Department Commander, Camp Commander must be vacated. One cannot hold the Office of Camp Commander and Department Commander at the same time.

The Commander-in-Chief rules that an elected Department Commander must vacate the elected position of Camp Commander.

CARLIN CAMP 25, SONS OF UNION VETERANS OF THE CIVIL WAR, REMEMBERANCE OF THE 150TH ANNIVERSAY OF THE START OF THE CIVIL WAR, GRAND ARMY OF THE REPUBLIC O. M. MITCHEL POST 69 CEMETERY, RENO, NEVADA, APRIL 16, 2011

Presentation of Carlin Camp 25 Historian and Past Camp Commander David A. Davis

We are here to mark the 150th anniversary of the start of the War of the Rebellion, today more commonly called the American Civil War. We will do this by laying a wreath at the gravesite of George Warren, who had been a private in Company F of the 17th Maine Infantry.

The Civil War is commonly considered to have started with the Confederate bombardment of Fort Sumter in Charleston Harbor, South Carolina on April 12, 1861. This date is rather arbitrary as on December 20, 1860, South Carolina was the first state to secede, and by the time of the Fort Sumter incident, had already captured one federal ship and fired on others.

News of all these events was transported to the West Coast by the Pony Express, and news of events after October 1861 was sent by the newly completed transcontinental telegraph. Regular Army troops fighting the Indians out West were sent East while the states of California, Oregon, and Colorado, and the Territories of Nevada, New Mexico, and Washington raised regiments to keep order out West. A skirmish with Confederates occurred as far west as Picacho Pass, 50 miles northwest of Tucson. The Pacific Squadron, initially consisting of six ships, escorted gold shipments and patrolled the entire Pacific for potential Confederate interlopers. At one point one ship even had a skirmish with the Japanese.

Before the Civil War was over, 2-3 million Union soldiers had fought 1-2 million Confederate soldiers. This also includes several hundred very determined and resourceful women, who cut their hair, donned binders and baggy uniforms, and passed themselves off as fighting men. 660,000 died in the Civil War. Of the U. S. population of 36 million, this means 8-13% fought and 2% died. Almost 4 years to the day of the firing on Fort Sumter, on April 9, 1865, General Lee surrendered to General Grant at Appomattox Courthouse in Virginia. Though this is the commonly accepted date of the end of the War, pockets of Confederate resistance continued on into May. Rather than decisively ending, the Civil War more or less fizzled out.

We are marking the anniversary of the beginning by placing a wreath on the grave of George Warren, who died March 10, 1936, at the age of 93. He was the last member of the O. M. Mitchel

Post 69 of the Grand Army of the Republic and the last Civil War veteran buried in Nevada that we know of. Another Civil War veteran and member of an as yet unidentified GAR post, W. O. Philips, was in the 1940 Memorial Day parade in Reno, but was buried out of state when he died in 1941.

Mr. Warren was born around 1843 in Maine and led a colorful life. He ran away from home to join the Union army as a drummer boy. He joined the 17th Maine, which was known as the Red Diamond Regiment because of a red diamond worn by the soldiers on their kepis as ordered by their Division commander General Phil Kearny. When Kearny was killed, the 17th Maine continued to wear the diamond as a memorial to him.

The 17th Maine received the heaviest losses of any Maine regiment. Mr. Warren was made a full fledged private in short order as the ranks thinned. He was wounded at Gettysburg, but returned to duty after recuperating. I lost my great-great- grandfather in the Confederate army at Gettysburg. Mr. Warren saw action at Spotsylvania and Petersburg and in the drive for Richmond. He was at Appomattox when Lee surrendered.

After the war, he came west in an ox-drawn covered wagon, and settled in Reno for awhile. He engaged in lumbering along Alum Creek southwest of Reno and provided timber and wood to the Comstock. He eventually resettled for a time in Arizona and later the San Joaquin Valley of California. He eventually took up lumbering in Oregon and Washington and later joined the gold rush to the Yukon and Alaska. He spent three years in Alaska and many more years in British Columbia.

As far as we know, he remained a bachelor. He retired and moved back to Reno, where he boarded with a Mrs. Nora Duryea on State Street in Reno. He joined the Mitchel Post 69 in 1928 when it had only about 4 or 5 members left. He was stricken with paralysis and died in the hospital a month later.

His services were held under the auspices of the Mitchel Corps 15 of the Woman's Relief Corps, and the Methodist Reverend Carl Warner officiated. The American Legion Quartette sang "Now the Day is Over" and "Sleep, Soldier, Sleep". The United Spanish War Veterans served as pallbearers and conducted the grave side committal service. The American Legion rifle squad fired three volleys, and D. Ramsey of the Boy Scouts played "Taps" on a bugle.
