REAL SON



HISTORY AND MEMORIALS REPORT

June 12, 2011

SAMUEL FULTON

As you all know, the attempt at getting Samuel Fulton a new marker in the Custer Post 5 plot at the Lone Mountain Cemetery in Carson City has been stymied by not being able find out what unit he served in during the Mexican War. During the Civil War, he apparently received his commission as a "Colonel" as an aide to then Pennsylvania Governor Andrew Curtin. Possibly his Mexican War service might be listed with his commission in Governor Curtin's records in the state archives in Harrisburg. Unfortunately, the staff there won't go look and said we would have to go there. Two months ago, I found the website of the General John F. Hartranft Camp 15 of the SUVCW in Harrisburg and e-mailed address their Chaplain to see if someone would go look.

Last week, I got an answer to the effect, that they knew about us contacting them two years ago, and that they found no record of Fulton being an aid to Curtin then. I e-mailed back to say, two years ago, a biographical book was looked in that had no mention of him. They suggested he may have even been a fraud. However, Curtin's records in the state archives apparently were not consulted. I told them books are secondary sources that do not mention everything a man did, and that archived records are primary sources that should contain detailed minutiae such as any commission Fulton received. Let's see if they take the hint.

HILLSIDE CEMETERY COMPLEX

Commander John Riggs and I compiled an inventory of all the names on tombstones in the O. M. Mitchel Post 69 Cemetery at Hillside and tied it to an aerial image of the cemetery. I also found several old lists from the Nona Parkin collection of cemetery lists, on-line Genweb lists, the Mitchel Post 69 burial register, and several other lists at the Historical Society. I also have a 1955 list on order from the main library of the Daughters of the American Revolution. Supposedly, the Johanna Shine Tent of the DUVCW and our predecessor the Isaac Crist Camp researched the cemetery thoroughly and in detail and had 39 vandalized or missing markers replaced.

The results are that the lists do not totally agree with one another or our inventory. Several of the veterans buried in the cemetery have more than one marker several of which are not near one another. Possibly as many as 15 burials have no markers. One marker is for a veteran buried in Mountain View. Three markers are for veterans originally buried in the old Saint Thomas Catholic Cemetery, which was moved in 1965. It's not known yet if they were reburied in the Mitchel Post 69 cemetery, moved to Our Mother of Sorrows or another cemetery, or ignored and left. Recent construction at the old Saint Thomas site unearthed several coffins.

The Hillside complex of cemeteries also contains the Hebrew Cemetery, the Knights of Pythias Cemetery, and the old now heavily vandalized Hillside cemetery originally founded by Reno undertaker Wilshire Sanders. It's now owned by Sierra Memorial Gardens which also owns the veterans' cemetery in Golden Valley. I compiled all the potential Civil War veterans from various lists into one spreadsheet. The Hebrew Cemetery has at least Union veteran. The Knights of Pythias Cemetery has a known Confederate and two known Union veterans. It may have at least one more Union veteran. The old Hillside cemetery has at least 16 Union veterans and a Mexican War veteran. Commander Riggs and I found a large hole in the cemetery fence and walked around the cemetery. Using the County Assessor's parcel map and a list with Assessor's parcel numbers, we found two graves still marked and a family plot for one that just had the plot curbing and family name left. The rest had no indication of where the graves were except for finding the site by the parcel map. Eventually we should inquire about the graves at Sierra Memorial Gardens.

My spreadsheet also contains Civil War veterans buried in other Reno area cemeteries. It is likely not complete, as I found one veteran not on it. He was listed as a captain on a family marker, and our GRO Don Huffman confirmed him as a Civil War veteran.

LONE MOUNTAIN STATUE

As you all know, Carlin Camp 25 and its first commander Paul Washeleski were instrumental in getting the Civil War veterans' statue in the Custer Post 5 plot in the Lone Mountain Cemetery in Carson City renovated in 2004 to the tune of \$82,000. The hollow statue was dedicated in 1891 and is made of zinc from the now defunct Monumental Bronze Company of Bridgeport, Connecticut. Cement was removed from the interior and replaced with a stainless steel internal support structure. Shotgun pellets and 20+ bullets were removed, numerous cracks filled, and the statue was painted light blue (now fading to gray!).

After 7 years, the statue is recracking and looks about like it did before the restoration. Cemetery sexton Tim Glancy is checking on the warrantee. I took many pictures of every crack I could find for documentation, though I have not had the time to go back through our files on the statue. In the manufacturing process, Monumental Bronze filled in seams and cracks with molten zinc. A check of the internet notes the restoration process uses either molten zinc or an epoxy. I had a small piece of filler from the statue checked at UNR with a hand held x-ray fluorescence scanner. It had little zinc in it, but was almost 90% some unknown material. Since XRF detects elements, the unknown was probably an epoxy filler, though it did look metallic. The warrantee and original specs need to be consulted, as right now, the statue is starting to look rather ragged.

LONE MOUNTAIN MARKERS

The broken markers for L. W. Robinson and the unknown Fort Churchill U. S. Soldier have finally been replaced at Lone Mountain Cemetery in Carson City. Sexton Tim Glancy is always thankful to have the help and is punctual in getting them set.
