HISTORY AND MEMORIALS REPORT

August 14, 2011

LONE MOUNTAIN STATUE

In my last meeting's report, I told how cracked the statue at Lone Mountain had become after just 7 years. I contacted Lone Mountain Sexton Tim Glancy about it, and he said_Scott Fahrenbruch is checking on the warranty. Lone Mountain is cared for by the Department of Parks and Recreation, and Scott is the Director of Operations. Tim said the warranty is for 20 years, but they have not been able to get in contact with Karkadoulias Bronze Art Co. of Cincinnati, Ohio, who did the restoration. I checked the Ohio Secretary of State Business Search website. Karkadoulias Bronze Art Co., owned by Marcene Karkadoulias went out of business in 2007,

however, a Marcene Karkadoulias Enterprises, LLC, came into existence in 2008. The latter business, so far, has no on-line contact information I have been able to find.

GAR BERRY POST 85 FLAG AND GRAVE

Commander John Riggs and I recently visited the Jail Museum in Truckee, CA. The museum has the GAR Berry Post 85 flag hanging on the wall. Post 85 was organized in 1885 in Truckee and lasted until at least 1894. The Museum also had a Ladies of the GAR badge. Though the badge appeared old, it was similar to those of today. Below is a picture of the flag. It hangs down, and the picture is rotated 90 degrees. The flag contains 38 stars. There were 38 states between 1876 and 1889 during which time the Post was organized.



While in Truckee, we also visited the cemetery, two of the graves mentioned the GAR with a photo below of the one showing naming of the Berry Post 85. As time permits, we'll try to find an obituary to see why the post name is prominently displayed.



ANOTHER NURSE'S GRAVE IN THE CARLIN CAMP 25 AREA

Johanna Shine, a Civil War nurse buried in Austin, has been reported on before. Truckee historian Chaun Mortier e-mailed about the grave of Civil War nurse Rebecca Lemmon Oleson buried in the Sierraville Cemetery in California. Commander Riggs and I visited the grave, and pictures of the marker are attached below stating she was an army nurse 1861-1865. Graves Registration Officer Don Huffman has found she did receive a pension for her service, and she can be added to the National Graves Registration Database. When time permits, we will work up a biography of her.



RECENT CEMETERY VISITATIONS

Recently, some of us have been making generally reconnaissance visits of cemeteries. Camp Patriotic Instructor Tyrone Davis and I recently went on camping trips to Seven Troughs and eastern Nevada. During these trips, we visited cemeteries near Lovelock and in Ely. I took pictures of as many Civil War veterans' graves as I could find. Commander Riggs and I visited the cemeteries in Truckee and Sierraville (noted earlier), and Camp Secretary-Treasurer Brian Worcester and his wife Pat visited cemeteries in Elko and Carlin. Member Wayne Eder and hi wife Suzette in Elko also visited the cemeteries in Elko and Carlin. It appears so far, that most of the graves have been documented already by our Graves Registration Officer Don Huffman and his predecessor Jeff Vaillant. Also, we were just concentrating on the obvious ones such the military markers, and it will take much more time to research those with family markers (or no markers) but were of the right age to have fought in the Civil War.

MARKERS AT MITCHEL POST 69 CEMETERY FOR VETERANS BURIED AT OUR MOTHER OF SORROWS

Three Civil War veterans – Patrick Keating, Martin Kennedy, and Patrick Reynolds - have Civil War veterans' markers in the GAR O. M. Mitchel Post 69 Cemetery at Hillside. However, lists show that they were originally buried in the old Saint Thomas Catholic Cemetery. The Saint Thomas Catholic Cemetery was sold to the University of Nevada, Reno, in 1965, and the remains were moved mostly to Our Mother of Sorrows Cemetery. The reason given was the cemetery was full and could not expand. The Mitchel Post Cemetery was renovated by the Johanna Shine Tent of the DUVCW and Isaac Crist Camp of the SUVCW in the 1960s, which included acquiring 39 new markers. The markers for the three Civil War veterans mentioned do not contain the words "In Memory Of", which would have indicated the remains are elsewhere.

Commander John Riggs and the manager of the Greek Orthodox Memorial Park in Colma, CA. both attended UNR in 1965. Both told me of witnessing the sloppy removal of remains from the Saint Thomas Cemetery, and others have told me that the gravestones were never moved with the remains but buried somewhere as a pile in a trench. At UNR, two dormitories, Nye and Canada Halls, now stand on the cemetery site, and a new building is now being constructed there. A couple of months ago, several coffins were dug up during this project showing that a few were indeed missed.

Commander Riggs recently visited the office to Our Mother of Sorrows. Records there show that Keating, Kennedy, and Reynolds were disinterred from Saint Thomas and reinterred at Our Mother of Sorrows. They are buried in a section with no markers called the Old Saint Thomas Section. Records exist as to where they are buried in the section; though it might still not be easy to find them exactly should anyone wish to acquire a marker for them.

General Order No. 28 SERIES 2010-2011 13 August 2011

Procedural, Requests, Appointments and Awards

The Commander-in-Chief rescinds the following sections of General Order No. 16, series 2010-2011:

Given the aforementioned sections of the Constitution and Regulation (annotated) I believe that the Commander-in-Chief must rule that the term served indicates that the Brother must be eligible for the honor of Past Camp Commander (P.C.C.) having served either a full term or filled an unexpired term and who has served until the end of that term before he can run for or obtain the office of Department Commander.

The Commander-in-Chief rules that when a Department Commander is elected he must hold the honors of Past Camp Commander.

The Commander-in-Chief at the suggestion of the Department of Maine orders that all references to battles, campaigns or military names be those used by the Federal or Union Armies, Navy, Marines or Revenue Cutters in all Camps, Department or National Newsletters, Banners, Websites or other publications. Names can be researched in the Federal or Union Army section of the *"The Official Records of the War of the Rebellion."*

Appoint Brother Lee Stone as Guard for the National Encampment and Brother Charles Mabie as Guide for the National Encampment.

1). I am truly humbled by the honor you have bestowed upon me by electing me to the office of Commander-in-Chief. I am also humbled by the fact that in the 130 year history of our Order, I am the first Brother from the Department of Missouri to be elected Commander-in-Chief.

2). I wish to thank the Department of the Chesapeake for hosting an excellent 130th National Encampment in Reston, VA. The Brothers that attended this Encampment were treated to some special events that generated memories that will hopefully last a lifetime.

3). Congratulations go out to the newly elected Presidents of the Allied Orders. Our main objective is to perpetuate the memory of the Grand Army of the Republic and those that fought to preserve this great Union. To the Presidents of the Women's Relief Corps, Auxiliary to the Grand Army of the Republic (WRC), Daughters of Union Veterans of the Civil War, 1861-1865 (DUVCW), Ladies of the Grand Army of the Republic (LGAR) and the

4). My focus this year will be on working toward a vision of what our Order should look like by the end of this decade. This vision is "To be recognized by Government, academia and the general public as the leading source of information pertaining to: (1) history, genealogy and preservation initiatives associated with the Grand Army of the Republic and the Soldiers, Sailors and Marines who fought to preserve the Union and (2) patriotism, the duties of citizenship and honoring those that made the supreme sacrifice in defense of this Nation."

I refer to it as 'Vision 2020". This vision feeds off of our mission as defined by our Federal charter. It also focuses on outreach and growth rather than contraction and inward progression. But this cannot be "my" vision only. In order for it to become a reality, it must be a "shared" vision, with Departments and Camps adopting it as well. In addition, my successors must also be committed to seeing it through. Over the next several months, I will be working with the various officers and committees to develop a long term plan to help us achieve Vision 2020. This plan will involve organizational growth, data collection and research, development of youth programs, collaboration between Allied Orders, and developing a sound financial strategy.

5). To support this initiative, I will be forming three new special committees. The Vision and Planning Committee will be tasked with pulling together the long term plan and tracking key metrics associated with that plan. The Committee on Juniors will be tasked with building on the current Memorial University program and developing a broader program for Juniors and Junior Associates. The Committee on Promotion & Marketing will be established to develop advertising and marketing strategies, as well as materials to promote our Order to the general public.

6). Also, the Civil War Sesquicentennial is now upon us. This past year, we rolled out the Signature Event process that resulted in a number of successful events across the country. We must also take advantage of the Sesquicentennial as we work towards our vision because we will not have an opportunity like this again for the foreseeable future.

These websites serve as a vital means of communication, and for some Camps and Departments, the only means of communication. It is imperative that schedules of meetings, events and other activities are maintained. These websites are also a resource for the general public, especially those that are contemplating membership in our Order. We must show that we are active and one way of doing that is properly maintaining our websites.

18). All National Officers and Committees shall file reports of their activities for the coming year, with one to support the November Council of Administration meeting, a second to support the Spring Council of Administration meeting and a final report for the 131st National Encampment. All Department Commander's shall file a report of activities occurring within their respective Departments upon the same schedule.

19). It is my intention to continue the tradition of recognizing Brothers who contribute to the growth of our Order. A Brother who recruits at least three new applicants during the 2011-2012 administrative year will be declared a National Aide in General Orders and be issued a ribbon with the National Organization's colors to be pinned behind his membership badge. A Brother who recruits five or more new applicants in that time frame will, in addition, receive a Certificate of Merit. All recruiting accomplishments are to be reported to the National Secretary through Department Secretaries.

20). Again, I want to thank all of the Brothers for electing me to this position and giving me the opportunity to lead this great Order. I am looking forward to meeting as many Brothers as possible and addressing the challenges that we will face over the next year.
