NEVADA DAY

October 29, 2011

The 2011 Nevada Day Parade was held October 29, 2011, in Carson City. Carlin Camp 25 was represented by Commander John Riggs, Senior Vice Commander/Historian David A. After the parade, we attended the Nevada Day chili feed at the Carson City Nugget.

SALUTE TO VETERANS CONCERT IN ELKO

November 12, 2011

Saturday, November 12, 2011, the Ruby Mountain Symphony presented <u>Salute to Veterans</u> at the Elko Convention Center in honor of veterans, and Carlin Camp 25 participated. Senior Vice Commander/Historian David A. Davis, PCC, gave a brief synopsis of the Civil War, Secretary-Treasurer Brian Worcestor presented Jerry Reynolds a certificate recognizing the medal of honor his grandfather received, and Chaplain/Patriotic Instructor Tyrone Davis took pictures. The orchestra played patriotic songs, and high school students read 400- to 500-page essays on the post-Civil War conflicts America fought in. A reception was held at the Northeastern Nevada Museum after the event.

Jerry Reynolds is the grandson of Harry Reynolds, which is the alias of Robert Smith who died January 5, 1930 and was buried in the Elko City Cemetery. Robert Smith was a Confederate drummer boy, who became a private in Troop M, 3rd U. S. Cavalry during the Indian Wars and was wounded three times. He was posthumously awarded the medal of honor for bravery in action against the Sioux at Slim Buttes, Dakota Territory, on September 9, 1876. Carlin Camp 25 worked with the Medal of Honor Society in finding information on Robert Smith/Harry Reynolds.

During the trip, Mountain View Cemetery near Lovelock, the Elko cemeteries, and Carlin Cemetery were reconnoitered, and the graves of Civil War veterans were photographed.

SONS OF VETERANS RESERVE AND ARTILLERY

Camp 25 brother Wayne Eder is looking into helping with the reforming of the Sons of Veterans Reserve (SVR) artillery unit in the Bay area. He is also a member of the Battle Born Civil War Reenactors of Reno and wrote a grant to the NRA Foundation to acquire Civil War replica cannons. Camp Commander John Riggs wrote Wayne a letter of support. The SUVW Department of California and Pacific is covered by the 6th Military District of the SVR. Wayne had a good question involving artillery units in Nevada or California. Nevada and California had Infantry and Cavalry regiments, but no obvious artillery regiments. So far, in Nevada, it appears Fort Churchill had one 12-pound mountain howitzer according to an 1868 inspection report, and the ca 1865 lithograph of Fort Churchill shows a howitzer in front of the guardhouse. According to the Official Records of the War of the Rebellion, in June 1865, a detachment of 40 troops of the 1st Nevada Infantry and 10 friendly Indians left Fort Ruby to investigate trouble around Austin. They took a howitzer with them. Also, when Colonel Patrick Connor took his command from Stockton, CA, to Salt Lake City, UT, in 1862, he crossed Nevada with two howitzers. He ordered Fort Ruby built during that journey. More research needs to be done on the Civil War artillery situation in Nevada.

HISTORY AND MEMORIALS REPORT

October 9, 2011

David A. Davis, SUVCW Gen. William Passmore Carlin Camp 25 Camp Historian/Civil War Memorials Officer.

NEVADA FLAGS

This morning, I contacted flag historian Jim Ferrigan, whose contact information was given to me Jan Loverin, the curator of the Marjorie Russell Clothing and Textile Research Center in Carson City. Jim travels a lot, and he was travelling on business in Santa Barbara when we spoke. The quality of his cell phone made it a bit hard to understand. He has been researching flags for some time and did a thesis on the flags at the Research Center. It has been at least 10 years since he saw it, but he remembered a GAR Post flag in the collection. There are at least three accession numbering systems that do not agree with one another and makes it difficult to find anything. He said eventually when he gets a chance, he will go there and look for that and other flags that would be of interest to us. He did research the Nevada Cavalry and Infantry regimental flags. Unfortunately, it appears they were given to the Phil Kearney GAR Post in Virginia City and burned up in the 1875 fire.

TRUCKEE TOMBSTONES

Recently, Ms Chaun Mortier, a research historian for the Truckee Donner Historical Society e-mailed to say they just acquired six new tombstones form the Veterans Administration for Civil Veterans buried at the Truckee Cemetery. They are being set soon, and they plan a dedication sometime in June. I suggested in my reply we would be interested in participating.

SCAR FACE CHARLIE

Commander Riggs recently found a rather interesting piece of trivia. In <u>Nevada, a Colorful Past</u>, 1990, vol. II, p. 405, by Doris Cerveri, it mentions "Scarface Charley", a woman who lived on the Comstock during the Civil War. She donned male attire and fought in the cavalry during the Civil War. She was exposed as a female after receiving a saber cut across the face. The scar and

nickname shamed her enough that she left town. Unfortunately, there is no reference to follow through on, though I have not had the time to check the indexes at the Historical Society yet.

REAL SON

As noted with a picture in the two most recent issue of the Carlin Camp Dispatch, Walter Roode of Portola, California, joined Carlin Camp 25 earlier this month. Walter is 98 years young, and is a Real Son. His father, Stephen W. Roode, served with Co. K, 9th Vermont Infantry and Co. B, 2nd Battalion, 17th U. S. Infantry. In July we met with him In Reno, and that meeting included then National Commander-in-Chief Brad Schall, Department Commander Glen Roosevelt, Carlin Camp Commander John Riggs, Carlin Camp Senior Vice Commander/Historian and Department Historian David A. Davis, PCC, and Carlin Camp Graves Registration Officer Don Huffman. A month ago, Carlin Camp Commander John Riggs, Carlin Camp Senior Vice Commander/Historian and Department Historian David A. Davis, PCC, Carlin Camp Secretary-Treasurer Brian Worcester, and Carlin Camp Chaplain Tyrone W. Davis again met with Walter and some his family and friends at his home in Portola and presented him with his membership paper in a frame. We also taped some of his conversation. Walter said his father talked little of the war, and he never received anything from his father that was related to his war service. His father was in the printing business, and left six filing cabinets full of mostly business papers, but possibly containing other documents. Walter's daughter-in-law Janie McBride over that time, she will look for any Civil War related documents that may be in the filing cabinets.

- 1). Additional appointments are being made to the National staff. The following appointments are effective immediately.
- 2). PCinC James B. Pahl is re-appointed as Assistant National Secretary Department-at-Large Secretary/Treasurer. Brother Pahl held this position during the previous administrative year and effectively improved communication between the National organization and Camps-at-Large.
- 3). PCC David K. LaBrot from the Department of Texas is appointed as chairman of the Special Committee on Vision and Planning. This committee will be given ownership of our current vision and will be tasked with pulling together the long term plan designed to accomplish this vision. This committee will also be tasked with tracking key metrics associated with that plan and periodically report progress to the Council of Administration.

- 1). Today, November 11, marks Veterans Day....a celebration to honor America's veterans for their patriotism, love of country, and willingness to serve and sacrifice for the common good.
- 2). In 1918, on the eleventh hour of the eleventh day in the eleventh month, the world rejoiced and celebrated. After four years of bitter war, an armistice was signed. The "war to end all wars" was over. November 11, 1919 was set aside as Armistice Day in the United States, to remember the sacrifices that men and women made during World War I in order to ensure a lasting peace. On Armistice Day, soldiers who survived the war marched in a parade through their home towns. Politicians and veteran officers gave speeches and held ceremonies of thanks for the peace they had won.
- 3). Congress passed legislation to make Armistice Day a federal holiday in 1938, 20 years after the war ended. But Americans realized that the First World War would not be the last. World War II began the following year and nations great and small again participated in a bloody struggle. After the Second World War, Armistice Day continued to be observed on November 11.
- 4). In 1953 townspeople in Emporia, Kansas called the holiday Veterans' Day in gratitude to the veterans in their town. Soon after, Congress passed a bill introduced by Kansas congressman Ed Rees renaming the federal holiday to Veterans' Day. President Eisenhower signed it into law on May 26, 1954. In 1971, President Nixon declared it a federal holiday to be observed on the fourth Monday in October in conjunction with the Uniform Monday Holiday Act. In 1978, it was moved back to the original date of November 11.
- 5). I urge all Brothers in our Order to proudly display the flag of the United States and take time on this day to reflect on the sacrifices made by America's veterans.

- 1). At the 14 August 2011 Council of Administration meeting, a motion to change the required submittal dates for signature event proposals was passed. This motion was passed to promote advance planning of signature events, eliminate the "short notice" rush to secure the necessary approvals and obtain medals and passport books in a timely manner.
- 2). It is now required that signature event proposals be submitted to the Civil War Sesquicentennial Committee no later than 90 days before the proposed event. The Council of Administration subcommittee, chaired by the Senior Vice Commander-in-Chief, must receive the down-selected proposals from the Civil War Sesquicentennial Committee no later than 45 days before the proposed event.
- 3). The signature event forms have been revised and the updated version is now available on the website. Given this, the new submittal dates are now in effect and no proposals will be accepted that do not adhere to these dates.
- 4). Camps, Departments and/or SVR units that have already started the proposal approval process will be allowed to complete the process. However, from this point forward, the Civil War Sesquicentennial Committee is instructed to decline any new proposal that was not received with at least 90 days advance notice.
