

In his second letter he congratulated Brothers of Camp 4 for their work at the Fort Point open house in January.

- 6) Department Encampment: Bob reminded Brothers of the Department Encampment being held on 28-29 March 2003. He recommended Brothers make reservations as soon as possible since this weekend is also spring break and rooms are going fast. He also announced that raffle tickets were available.
- 7) SUVCW Auxiliary: Bob announced that he would like to see that Auxiliary to our Camp reactivated and that it would be nice to located the original Auxiliary charter.
- 8) Movie Gods and Generals: Several Brothers and a Member of the Auxiliary attended the "sneak-sneak preview" of the movie Gods and Generals on Tuesday, 4 February 2003 at the Camera 7 at the Pruneyard in Campbell. All were very disappointed with the movie. Bob reported that National HQ suggested that we make an appearance at theatres when the movie premiers to the general public on February 21-22, 2003. All the theatres that Bob contacted were opposed or ambivalent to the idea, except the Camera 7 that was very enthusiastic about the idea. SCV Stainless Banner members were also contacted and expressed an interest in

joining us. Since only one major theatre in the area is allowed to show the premier, and it will likely not be the Camera 7, therefore we will probably participate in such an event in March or April on a Saturday night.

- B) Secretary-Treasurer's Report Bro. Earl
  - Membership: At the end of the 4<sup>th</sup> quarter membership stood at 47 members, plus two Juniors. During the 4<sup>th</sup> quarter there were no gains or losses. At the request of Brother Daniel Wyatt, he was provided an Honorable Discharge after the first of the year. Additionally, Brother Maynard Goethe of Santa Barbara has requested his membership be cancelled. For the 2003 reporting period we have lost only two members. There is a possibility that these Brothers may pay their dues before the new Annual Reports are due. If they do not, and are not dropped, the Camp will have to pay the full year PCD to National and the Department (\$21 each, which we may never recoup). Dan moved that the Camp Secretary-Treasurer be given permission to drop those Brothers who have not renewed their membership dues by the time the Camp Annual Report is due at Department Headquarters. The motion was seconded and agreed to unanimously.

It also includes many news articles pasted in it about the Sheridan-Dix GAR Post and WRC. Laurel donated this scrapbook to the Camp.

  1) Dan reported that he had spoken to the ACWA and made a request for us to be able to participate in the Memorial Day weekend ceremonies at Roaring Camp in Felton, Santa Cruz County. They have not yet required us to have join the ACWA to participate. Dan reported that he is still collecting many more details and much is still in process. Brothers also discussed the issue of the \$45 fee for ACWA membership. Dave Schleeter moved (and it was seconded) that \$45 be authorized to be appropriated for use for membership in the ACWA if needed for our participation at Roaring Camp in Felton.

#### A Resolution Extending sympathy and condolences to the families and friends of the crew of the Columbia Space Shuttle who were killed on 1 February 2003.

#### Submitted by Brother Daniel R. Earl, Camp Secretary-Treasurer and Counselor

*WHEREAS*, the Columbia Space Shuttle Mission STS-107 departed earth on a 16 January 2003 for a 16 day mission dedicated strictly to scientific research; and,

*WHEREAS*, the flight included the first Israeli astronaut; and,

WHEREAS, the crew of the Columbia included: Col. Rick D. Husband, Mission Commander; Commander William C. McCool, Mission Pilot; LTC Michael P. Anderson, Mission Payload Commander; Capt. David M. Brown, Mission Specialist; Dr. Kalpana Chawla, Mission Specialist; Commander Laurel Clark, Mission Specialist; Col. Ilan Ramon, Payload Specialist; and,

*WHEREAS*, on the morning of 1 February 2003, as the Columbia was re-entering the earth's atmosphere in preparation for landing at the Kennedy Space Center, the shuttle experienced a catastrophic break up over the State of Texas; and,

*WHEREAS*, there were no survivors of this disastrous event; and,

*WHEREAS,* these astronauts truly exemplified the spirit of America's space program; and

*WHEREAS*, despite this tragic incident, NASA is focusing on the tasks at hand and is still fully engaged in its mission; Now, therefore, be it

*RESOLVED*, That the Brothers of the Phil Sheridan Camp No. 4 –

(1) were deeply saddened by the news of the tragic break up of the Columbia shuttle and death of the entire crew; and,

(2) express sorrow for the loss of life of the crew of the Columbia Space Shuttle; and,

(3) offer sympathy and condolences to the families and friends of the crew of the Columbia Space Shuttle who were killed on 1 February 2003, and to all of the American and Israeli people; and,

(4) praise the performance, heroism, and professionalism of all NASA astronauts; now, therefore, be it,

*FINALLY RESOLVED* by the Phil Sheridan Camp No. 4, Department of California and Pacific, Sons of Union Veterans of the Civil War, That the Secretary of the Camp transmit copies of this resolution to NASA with the request that it be forwarded to the families of the Columbia astronauts, and that a copy be transmitted to the President of the United States, the Speaker of the House of Representatives, and the President Pro Tempore of the Senate.

Adopted by the Brothers of the Phil Sheridan Camp No. 4, Department of California and Pacific, Sons of Union Veterans of the Civil War, on this 8<sup>th</sup> day of February in the year of our Lord two thousand three and in the independence of the United States of America the two hundred twenty-sixth, in the City of San José, County of Santa Clara, State of California.

- B) GAR Post Applications Bros. Tad D. Campbell& Daniel M. Bunnell 1) Recently the Camp was contacted by Department Commander Brad Schall, referring us to an individual named José, who has possession of Phil Sheridan Post GAR papers and possibly other GAR papers. Cmdr. Kadlec, Historian Campbell, and Counselor Earl met with the individual and inspected the papers. Brother Campbell was able to authenticate them as genuine. Later Dan Bunnell learned that his brother works with the same individual who possesses the documents. Dan met with José and is in the process of negotiating with him. When Bob, Tad, and Dan Earl met with José, he made it clear that he was seeking a large sum of money (possibly several thousand dollars) for the documents. However, he indicated to Dan Bunnell that he might be willing to donate the documents to the Camp and accept a tax deduction. Bob and others may look into seeking funds from the American Legion to procure these documents and possibly any others José may possess.
- C) United Veterans Council (UVC) Cmdr. Bob Kadlec
  - The UVC has asked us to become members of their organization. Membership is \$12/year. Bob gave a description of what the UVC is and how their purpose is to coordinate veterans events in the county. Clark moved (and it was seconded) that we appropriate \$12 for membership in the UVC. The motion was agreed to unanimously.
- D) Last Soldiers Project Bro. Daniel M. Bunnell, PDC
  - Dan reported on the National Last Soldiers Project and the impact it will have on us locally. Bob referred work on this project, jointly to the Committees on Graves Registration and History, and requested periodic status reports.

X. Good of the Order - Patriotic Instructor - Bro. Campbell, PCC

 A) Tad made a presentation on the history of President's Day. He also reported on war service of presidents and the highest military rank held by presidents. Brother Campbell made this presentation at the conclusion of the meeting during the birthday party of President Abraham Lincoln, in celebration of Mr. Lincoln's 194<sup>th</sup> birthday.

The meeting was closed with prayer led by the Chaplain Seum, at 19:35.




president of the Auxiliary. The individual applications are then sent to National and then they send an installing officer.

    - Dave reported on the safety issues surrounding the use of black powder. He was unable to find any material online that is specific to what we do in the SUVCW. A historical problem that faced many in the Civil War was that if one did not wait long enough after firing, and then added more powder to his musket, there was a chance of firing the musket unintentionally and causing injury. The ACWA recommends replacing the cap last when reloading, to prevent this. Dave suggested that the appointment of a Safety Officer would be useful for us.


