### Successful SUVCW Picnic Held!

Four of the six Northern California Camps were represented at the SUVCW picnic on Saturday, July 28th at the Presidio in San Francisco.

We were honored to have our Department Commander **Bob Lowe** present for the festivities. In addition, the following Camp Commanders were present: **Tad Campbell** of Phil Sheridan Camp 4 (San José), **Bob Nelson** of Lincoln Camp 10 (Santa Cruz), **James Spencer** of Col. Elmer Ellsworth Camp 23 (Santa Rosa), and **Brad Schall** of Gen. Alfred Pleasonton Camp 24 (Castro Valley). A number of wives and other relatives were also present and helped make this truly a family affair.

After gathering at the picnic grounds, the group preceded to the GAR monument at the nearby National Cemetery, where a short memorial ceremony was held, led by Bro. **Nate Pyles**, Pleasonton Camp 24's Chaplain.

Once reassembled at the picnic area, speeches were made by Dept. SVC **Brad Schall**, Dept. Cmdr. **Bob Lowe**, Dept. Historian **Bob Nelson**, and **Charles Christian**. Brother Christian was also presented with his Past Camp Commander's Badge and a certificate of appreciation from the Sons of Confederate Veterans for his efforts in recognizing the sacrifices of both the Boys in Blue and the Boys in Gray.

The group then proceeded to Fort Point National Historic Site for a guided tour of the Civil War era installation. The Fort is located directly below the southern end of the Golden Gate Bridge.

Many attendees returned to the picnic grounds after the tour and continued the festivities for some time. It is hoped this will become an annual event.

## SUVCW Represented at Family Reunion In Kansas

Camp Commander **Tad Campbell** represented the SUVCW at a family reunion of approximately fifty people at Welda, Kansas on July 21, 2001.

The Settle-Taylor Family Reunion consisted of descendants of Robert A. and Susanna (Robinson) Taylor through their daughters Mary Margaret (Taylor) Wolf and Emma Araminta (Taylor) Settle.

Robert and Susanna Taylor had three sons, all of whom served in the Union Army and died during the Civil War.

Cmdr. Campbell, a direct descendant of Mary Margaret (Taylor) Wolf, wore his SVR uniform and spoke to the group about the sacrifices of the Taylor brothers during the war. He also gave a brief history of the GAR and the SUVCW and provided the group with the names and locations of the Sons Camps in Kansas.

#### Membership Eligibility:

A male descendant, whether through lineal or collateral line and not less than 14 years of age (8 to 14 years for Juniors), who: (1) is a blood relative of a Soldier, Sailor, Marine or member of the Revenue Cutter Service, who was regularly mustered and served honorably in, was honorably discharged from or died in the service of the Army, Navy, Marine Corps or Revenue Cutter Service of the United States of America or in such state regiments called to active service and was subject to orders of United States general officers, between April 12, 1861 and April 9, 1865; (2) has never been convicted of any infamous or heinous crime and (3) has, or whose ancestor through whom membership is claimed has, never voluntarily borne arms against the government of the United States. Associate memberships are available for those supporters who are not of lineal descent.
