

# Woman's Relief Corps Home of San José

The Woman's Relief Corps Home of San José, California had the proud distinction of being the first Home of its kind to be established in the United States.

The Home had its origin in the associating together of a group of women of the Woman's Relief Corps for the purpose of providing a Home for certain dependants of the Veterans of the Union Army who served in the Civil War.



The Woman's Relief Corps Home of California was incorporated May 11, 1887, for fifty years, under the provisions of Title XII, Part IV, Division First of the Civil Code of the State of California. Later, on April 1, 1897, the articles of incorporation were amended. In 1907, the Act of April 1, 1897, was codified:

"Section 2210 (of the Political Code) OBJECT: The object of the Woman's Relief Corps Home of California, Santa Clara County, is for the support of ex-Army nurses, and of the wives, widows, mothers, and dependent destitute, unmarried daughters and sisters of the Union Veterans who served honorably in the Civil War. No person is entitled to aid under this chapter except by reason of her services as an Army nurse, or by reason of the military or naval services of her husband, father, brother, or son, nor unless she has been continuously a resident of this State for one year next prior to her admission to the Home."

Through the influence of the Woman's Relief Corps of the Department of California and Nevada, the State Legislature, in 1887, appropriated money for the erection of buildings on grounds at Evergreen, eight miles from San Jose, donated by a generous friend of the Woman's Relief Corps and the Grand Army of the Republic. For many years the Home was known as the "Evergreen Home." There were five acres of land and twenty-three residents in 1920.

On October 10, 1920, the home was destroyed by fire. In 1921 the Corps purchased from Dr. A. E. Osborne the buildings and land of the Feeble-Minded Home, near Winchester, on Saratoga Road. The Home was re-located there and in 1945 had twenty-five residents.

#### Membership Eligibility:

A male descendant, whether through lineal or collateral line and not less than 14 years of age (6 to 14 years for Juniors), who: (1) is a blood relative of a Soldier, Sailor, Marine or member of the Revenue Cutter Service, who was regularly mustered and served honorably in, was honorably discharged from or died in the service of the Army, Navy, Marine Corps or Revenue Cutter Service of the United States of America or in such state regiments called to active service and was subject to orders of United States general officers, between April 12, 1861 and April 9, 1865; (2) has never been convicted of any infamous or heinous crime and (3) has, or whose ancestor through whom membership is claimed has, never voluntarily borne arms against the government of the United States. Associate memberships are available for those supporters who are not of lineal descent.
