## National Encampment Holds Elections: West Advances

Last month eleven delegates from the Department of California and Pacific traveled to Springfield, Illinois to represent the Brothers of our Department. A great deal of business was transacted, including the election of new officers. As many of you may know, this is generally pro forma since the sitting Senior Vice Commander-in-Chief and Junior Vice Commander-in-Chief are "expected" to move up to the next rank. This indeed was the case, as usual, with the election this summer. Brother **ROBERT GRIM** was elected Commander-in-Chief and Brother **KENT ARMSTRONG** was elected Senior Vice Commander-in-Chief.

The election that always brings the most controversy is that of Junior Vice Commander-in-Chief, since it usually involves bringing in "fresh blood" from the organization, and an eventual change in leadership and policy for the Order. This year the short list was narrowed down to two brothers, **JOSEPH**

LONG, JR., PDC of the Department of Pennsylvania and STEPHEN MICHAELS, PDC of the Department of Wisconsin.

After some exceptional nomination speeches, and a great deal of debate, Brother **STEVE MICHAELS** was elected Junior Vice Commander-in-Chief. As Brother Michaels demonstrated to the membership, he is more than qualified for the position and all have a great deal of faith in his abilities to carry out his duties. The "Western Army" as some are referring to them (including primarily Departments west of the Mississippi River, in addition to some eastern Department alliances) has become an informal coalition of Departments seeking increased representation for Departments in the western United States. Although Wisconsin is not west of the Mississippi, it was clear that those supporting Brother Michaels felt he would faithfully represent western interests in a more steadfast manner than has been done in the past.

The election of Junior Vice Commander-in-Chief was not the only contended election. The "Western Army" was also pleased to re-elect (from a one year term to a three year term) Brother Robert Petrovic of Missouri. Brother Petrovic has been very understanding of western concerns and the alliance is convinced he will serve them well.

What about the elections for Secretary and Treasurer? Those positions were filled last year and are held for three-year terms. Brother **ED KRIESER** PC-in-C is serving as National Secretary, and Brother **MAX NEWMAN** is serving as National Treasurer.

#### **Dues Increase**

At this past National Encampment it came as no surprise to Brothers that there would be an attempt to increase the National per capita dues. Unfortunately, the attempt succeeded by almost a 3 to 4 margin. There was a great deal of heated debate over whether or not to increase the dues and how the money would be spent. It was ultimately decided to increase the National dues by \$6 per year. This will be the first increase in many years and should provide increased services to our membership, while allowing us to maintain a fiscally responsible budget at the National level. The increase will become effective in January.

As Treasurer, at the September meeting I will have proposals submitted to the Council and the membership for methods of implementing this increase. Input is needed from ALL brothers on this very important matter. There are several options

that need to be explored before making a final decision at our next meeting.

### SECOND G.A.R. PLOT DISCOVERED AT OAK HILL

Through the efforts of Bro. **BOB KADLEC**, the Camp was recently allowed to photocopy a heretofore unknown book entitled "Record of Deceased Soldiers." This book, containing detailed burial information on Union veterans throughout Santa Clara County, was compiled by our predecessors, the Phil Sheridan Post No. 7, G.A.R. of San José, and is in the possession of Oak Hill Memorial Park.

Upon closer examination, Bros. **DAN BUNNELL** and **TAD CAMPBELL** noticed that several entries were listed as being buried in the "old" Oak Hill G.A.R. plot. These names did not appear among those interred in the large G.A.R. plot at Oak Hill.

This past weekend Camp Commander TAD CAMPBELL with his wife RACHELLE (a member of the Auxiliary) were successful in locating the "old" G.A.R. plot in the earlier section of Oak Hill, behind the maintenance building.

This was apparently the first of two plots established by the Phil Sheridan Post and contains at least eighteen burials, most occurring in the 1880s. It is evident that as the Post grew, they needed a larger burial plot, thus the second G.A.R. plot that now contains over 400 interments.

**Graves Registration - September 14th** 

Our next Camp meeting will be held at the Bold Knight Restaurant, 1400 Monterey Highway on Saturday, September 14, 2002 at 10 am.

Immediately following the meeting we will proceed to nearby Oak Hill Memorial Park for our third session of graves registration. *Your Camp needs your help in searching out the last resting place of our brave Boys in Blue!* 

As most of you are aware, Oak Hill is an enormous cemetery with over 175,000 interments. It is the oldest secular cemetery in California, having been founded some ten years before the Gold Rush. There are likely thousands of Union veterans interred outside the two known G.A.R. burial plots.

Please help us keep green the memory of these Union veterans by seeing that their graves are properly located, marked and recorded. Armed with such information we can see that they are never forgotten!

#### **Membership Eligibility:**

A male descendant, whether through lineal or collateral line and not less than 14 years of age (6 to 14 years for Juniors), who: (1) is a blood relative of a Soldier, Sailor, Marine or member of the Revenue Cutter Service, who was regularly mustered and served honorably in, was honorably discharged from or died in the service of the Army, Navy, Marine Corps or Revenue Cutter Service of the United States of America or in such state regiments called to active service and was subject to orders of United States general officers, between April 12, 1861 and April 9, 1865; (2) has never been convicted of any infamous or heinous crime and (3) has, or whose ancestor through whom membership is claimed has, never voluntarily borne arms against the government of the United States. Associate memberships are available for those supporters who are not of lineal descent.
