Confederate Uncles in the Attic

This past August, during their trip to the National Encampment, two Camp Brothers visited the graves of their Confederate uncles, both of whom are buried in Kentucky.

At the historic Cave Hill Cemetery in Louisville, Bro. **TAD CAMPBELL PCC** located the last resting place of his great-great-great-granduncle, James Knox Polk Hazelwood. Pvt. Hazelwood was a member of Co. I, 25th Virginia Cavalry, CSA, having enlisted in Lee County, Virginia on April 18, 1863. He was taken prisoner on May 22[,] 1864 by the pro-Union Home Guards in Claiborne County, Tennessee. He was then sent to Louisville where he died of pneumonia on June 22nd. Also serving in the same company were his brother Benjamin Franklin Hazelwood and Tad's direct ancestor, Eldridge Campbell. Gravesites of the latter two have yet to be located.



Bro. **DANIEL EARL** was excited to find the grave of his greatgranduncle in the cemetery at Williamstown, Grant County, Kentucky. Augustus C. Webb, who was also from Lee County, Virginia, enlisted on August 25, 1863 in Co. C, 64th Virginia Infantry, CSA. Union forces at Chestnut Ridge, near Harrisonburg, Virginia captured Pvt. Webb on November 29, 1863. He was held at both Camp Chase, Ohio and Fort Delaware, Delaware, where he took the Oath of Allegiance on June 21, 1865 and was subsequently released.

Although the hearts of these Brothers lie with the Union cause, both Bro. Campbell and Bro. Earl remain proud of their Confederate uncles in as much as they fought for ideals in which they believed.

Camp Prepares for 85th Annual Veterans Day Parade Practice to be held on October 11th

Phil Sheridan Camp 4 will once again participating in the annual Veterans Day Parade in downtown San José. This year's parade will refocus on the true meaning of the day, with an "Armistice Day Ceremony" for the "War to end all Wars" beginning on the 11th hour, of the 11th day, of the 11th month (November 11th at 11:00 am). The ceremony will take place on Market Street at Plaza de Cesar Chavez Park. The Parade begins at noon and travels from Delmas Street, along Santa Clara Street, to Market Street, and ends at San Carlos Street.

Members of the Camp wishing to participate in the parade should be sure to come out for the Parade Practice on Saturday, October 22nd at 10:00 am. The practice will be held at the Field Sports County Park, 9580 Malech Road in south San José. To get to the park, take Monterey Highway 1.3 miles south from Bernal Road, turn east on Metcalf Road and continue over US Highway 101. Immediately after the overpass, turn and turn right (south) onto the frontage road, Malech Road. Continue approximately one mile and the entrance to the park/range will be on the left.

Black powder musket firing will be conducted to practice the salute to be given during the Veterans Day Parade. Even if you are unable to participate in or watch the parade on November 11th, come out on October 11th and watch the show as we practice our steps!

CAMP ORDER No. 8 - Series 2003 PATRIOT DAY

By the authority vested in me as Commander of the Phil Sheridan Camp No. 4, by the Camp Bylaws, Department of California and Pacific Bylaws, the National Constitution and Regulations, and National Policies, it is hereby ordered as follows:

<u>Section 1</u>: With the two-year anniversary of the attacks on the World Trade Center and Pentagon being this Thursday, Brothers are reminded to observe Patriot Day and a National Day of Prayer as proclaimed by President Bush.

Section 2: Brothers are requested to fly their flags at half-staff and to observe a moment of silence to remember those who died during the terrorist attacks on September 11, 2001.

Section 3: The Camp Charter is ordered draped in black during the Camp meeting on Saturday, 13 September 2003 and the Camp Chaplain directed to pay tribute to those who perished in the September 11, 2001 attacks during his opening prayer.

Military Salute to Bob Hope

Brothers: An IMPORTANT reminder that tax-deductible donations are still needed for the Bob Hope monument. With a donation as little as \$20you will receive a nice plaque in honor of Bob Hope. Please read the article below for details.



BOB HOPE, the actor, entertainer and comedian, is universally known around the world for his long career as a star of stage, screen and television. Yet it is in the hearts of generations of U.S. servicemen that his most enduring legacy will reside. For over a period of fifty years, from 1943, he dedicated himself to entertaining soldiers, sailors and airmen of the armed forces in the many battle fronts and remote outposts where they've served throughout the world. His overseas USO tours, which often took place over Christmas, were deeply appreciated and well remembered by countless thousands of servicemen on protracted tours of duty, often under combat conditions, far from their homes and families.

Fifty-seven years have passed since **BOB HOPE** first entertained our country's men and women in uniform. Whenever there was a need, **BOB HOPE** was there. Thanks to him, hundreds of thousands of soldiers, sailors, airmen and marines have had their spirits lifted. Congress has honored Mr. **HOPE** five times. But, in October 1997, he received one of his greatest tributes when he was unanimously

made an Honorary Veteran – the first individual so honored in the history of the United States. Ninety-nine and still making a difference. That's **BOB HOPE**. Now it's our turn to make a difference in honoring this legendary man.

Currently, Taffy III is raising funds to create a Military Tribute to **BOB HOPE** in recognition of his efforts for all our country's servicemen and women. Taffy III is a group of World War II Navy veterans who served on three ships that were sunk during the Battle for Leyte Gulf on October 25, 1944. ("Taffy III" was the code name of this task unit.) In recent years, these men have devoted their efforts toward raising money for monuments to preserve the history of this era. In the past several years they have successfully erected and dedicated four monuments. The Port of San

Diego has graciously donated almost a full acre of land on the shoreline of San Diego Bay for tribute to **BOB HOPE**. This property is worth approximately 4.9 million dollars.

One of the hardest obstacles to overcome was the agreement of **BOB**, his wife **DELORES** and daughter **LINDA** to erect this Military Tribute. After 14 months of communications and meetings, agreement was reached with certain conditions: that money raised for this project would come from the Veterans themselves and the American people. It was further agreed that corporate money would not be solicited and neither his former corporate sponsors nor professional friends be approached for funds.

Completion of this "tribute" requires the raising of 4.5 million additional dollars. All Brothers are encouraged to make a donation to this worthy tax-deductible cause. Brother **BOB LOWE** (PDC) of Pittenger Camp 21 has been designated the "collection man" for these donations. Not part of the resolution, but certainly an enticement to move forward these donations, was the following offer by publisher and fellow member **GEORGE VAN VALKENBERG**: any organization or entity thereof (such as our Department) that collects 50 or more donations of \$20 each will receive the following – a 5"x7" plaque for each donor (\$20 or more) and one for the Department. A prototype of this plaque was shown at the Encampment. Each plaque will be inscribed with the name of the donor, the SUVCW Department emblem, and a photo of **BOB HOPE**.

The Moving Wall is a replica of the permanent Vietnam Memorial in Washington, D.C. and is inscribed with the names of 58,228 Americans who gave their lives for the cause of freedom. The memorial has been touring the United States since 1984 and is booked in advance for the next three years in communities across the country.

Membership Eligibility:

A male descendant, whether through lineal (direct ancestor) or collateral line (uncle) and not less than 14 years of age (6 to 14 years for Juniors), who: (1) is a blood relative (descendant or nephew) of a Soldier, Sailor, Marine or member of the Revenue Cutter Service, who was regularly mustered and served honorably in, was honorably discharged from or died in the service of the Army, Navy, Marine Corps or Revenue Cutter Service of the United States of America or in such state regiments called to active service and was subject to orders of United States general officers, between April 12, 1861 and April 9, 1865; (2) has never been convicted of any infamous or heinous crime and (3) has, or whose ancestor through whom membership is claimed has, never voluntarily borne arms against the government of the United States.
