

SUVCW and Auxiliary Make Good Showing at 4th of July Parade

On behalf of the Commanders of the Department of California & Pacific and Phil Sheridan Camp Number 4, as well as the President of Dr. Mary Walker Auxiliary Number 52, Sons of Union Veterans of the Civil War, I wish to extend thanks and appreciation to all who participated in, or attended, the 66th Annual Independence Day Parade in Redwood City, California.

Yesterday [July 5] I met with GENE FANUCCHI, President of the United Veterans Council of Santa Clara County. Gene was invited by the Peninsula Celebration Association (Sponsor of the Parade) to represent all Veterans on the Parade Reviewing Stand and accept the honors and salute from the formations passing in review. Gene told me that he was greatly impressed with our performance and asked that I pass on his appreciation for the outstanding representation of



the Civil War formation honoring the "Boys In Blue Who Saved the Union between 1861 to 1865."

Alfred Pleasonton Camp 24 of the Sons Of Union Veterans, members of Company C of the 8th California Volunteer

Again, thanks to all and I am looking forward to seeing you again in the largest Veterans Day Parade in Northern California on November 11th in San José, California.




Civil War Wedding



Los Gatos, California • Then & Now

The Grand Army of the Republic (GAR) established Los Gatos Post Number 82 on the 4th of September 1885 and named it after Union General Edward Otho Cresap Ord. The first Commander of E.O.C. Ord GAR Post 82 was Thomas Shannon. Civil War Veteran, and promenent Los Gatos businessman, James H. Lyndon was installed as its first Quartermaster.

Decoration Day, a day for remembering the sacrifices of fallen comrades during the Civil War, was established by Major General John A. Logan in 1868, The 30th of May will become what is known today as Memorial Day.


Los Gatos East Main Street Decoration Day Parade Formation May 30, 1891


In 1889 the Los Gatos E.O.C. Ord GAR Post 82 established the John A. Logan Camp 20 of the Sons of Veterans. The Los Gatos Camp, the first to be organized in the Department of California & Pacific of the Sons of Union Veterans of the Civil War (SUVCW), was named after Major General John Alexander Logan (1826-1886), the third National Commander in Chief of the Grand Army of the Republic.

In the early years of the Sons of Union Veterans, many Camps adopted "uniforms" to be worn by their membership. Additionally, during the late 19th Century, many SUVCW Camps formed reserve military units. These units volunteered their services during the Spanish American War in 1898. In 1903, the uniformed "military" element of the SUVCW, The Sons of Veterans Reserve (SVR), was officially established with a membership of over 5,000. SVR members volunteered their services again during World War I and with the National Guards in the various States. After World War II, as the SUVCW became a more patriotic and educational organization, the SVR evolved into a ceremonial and commemorative branch.

Armed Forces Day Parade

Santa Cruz, California • 21 May 2005

Lincoln Camp Number 10, Santa Cruz, California, was invited by the Santa Cruz Chamber of Commerce to participate in the first veterans/military oriented parade in the City in almost forty years. Carrying the Department Banner was World War II Veteran Wayne Thalls, Lincoln Camp 10 Secretary/Treasurer.

Did you Know?

About eleven Union Civil War veterans received the Purple Heart. the award for combat wounds, which was revived by Gen. Douglas McArthur in 1932. Confederate veterans did not qualify for the award and those qualifying Union veterans had to verify their nearly seventy-year-old combat-related wounds. No posthumous Purple Hearts were authorized for service before December 7, 1941. Photos exist of some of these veterans wearing their Purple Hearts at the 75th anniversary of the Battle of Gettysburg in 1938!

THE FIRST HAND GRENADES

During the Civil War, two kinds of hand grenades were made, but they saw little use in combat. One of them, patented in August 1861, carried a percussion cap and an activating "plunger" that was not inserted until it was about to be thrown. Rated as effective at a distance of about twenty-six yards, this explosive piece was known by the name of its inventor, Ketchum.

A more sophisticated grenade, "the Excelsior," was developed in 1862 by W. W. Hanes. Its cast-iron shell held fourteen nipples, to each of which a percussion cap was attached before it was thrown. Hanes insisted, correctly, that at least one cap was sure to trigger an explosion. In practice, men trying to use his device often hit a cap accidentally and had a hand or arm blown off. As a result, it seems never to have been used in battle.

Soldiers who may or may not have heard of the Ketchum grenade or the Excelsior sometimes improvised similar weapons. At Vicksburg, Confederates in Louisiana units stuck short, lighted fuses into 6 and 12-pounder shells, then rolled them into ranks of Union sappers.

One demonstration of this weapon was enough to make believers of opponents. Confederate Captain John M. Hickey said that when one of the city's forts was stormed, "the air was made black with hand grenades, which were thrown at us by every Federal soldier who got inside the works." Similar explosive devices were made on the spot by Federals at Knoxville.

Describing some of the action near Chattanooga, Union Colonel P. C. Hayes said an assault by troops under Confederate Lieutenant General James Longstreet reached a deep ditch dug by Federals. Confederates, he said, jumped into the ditch in order to raise scaling ladders. According to him, "This action was fatal to them. Our men, being unable to reach them with their heavy guns, lit the fuse of the shells, which they threw by hand into the ditch, where they exploded, slaughtering the helpless occupants by the wholesale."

Records do not indicate the number of engagements in which improvised explosives were rolled or thrown against foes. Nevertheless, they were employed frequently enough to show that although technology to produce suitable hand grenades did not yet exist, the concept behind these weapons was fully developed by men in both gray and blue.



MY CIVIL WAR ANCESTOR

WILLIAM ELLIOT MORROW OF COMPANY H, 46TH IOWA INFANTRY

Great-great-granduncle of Paul E. Lavrischeff

William Elliot Morrow was born May 15, 1846 in Tuscarawas County, Ohio, the third of four children of Thomas Adam Morrow and Esther Scott. When he was ten years old, the family moved to Clarke County, Iowa.

William was reared on a farm and was educated at the local common schools and at the graded school at Garden Grove, Iowa. After completing his education he began a career as a teacher, following that profession in both winter and summer until after his marriage, when he only taught during the winter terms.

On May 30, 1864, just two weeks after his eighteenth birthday, William E. Morrow enlisted as a private in Company H, 46th Iowa Infantry, a 100-days regiment. He was mustered into the service on June 10th.

The regiment was dispatched to Tennessee, where it performed duty garrisoning posts and guarding railways. About the middle of August, a portion of the regiment was

engaged with the enemy at Collierville, Tennessee.

While stationed at Collierville during the first part of August, Private Morrow was among the many soldiers that contracted mumps. This resulted in the atrophy of one of his testicles and he was treated in camp by the regimental surgeon. Morrow later had to be castrated due to extreme swelling of the testicles. He was mustered out with the rest of his regiment on September 23, 1864 at Davenport, Iowa.

On October 20, 1869, William E. Morrow married Mary M. Whisler, of Clarke County, Iowa. Together they had two sons, Francis Elliot and Robert Enoch. After their marriage, the family settled on a farm, where William followed agricultural pursuits until 1873. He then moved to Osceola, Iowa and became associated with his father in the agricultural implement business. He spent a year in Colorado, but upon the death of his father in 1884, he returned to Osceola and took charge of the business.

Mrs. Mary (Whisler) Morrow died on June 21, 1911 and William remained a widower until his death. He was a member of the Masonic Order and a comrade of the Grand Army of the Republic (GAR). On April 11, 1919 he was known to have attended a meeting of the Clarke-Lucas Association of Shiloh Veterans, by which he was listed as a visiting veteran. William E. Morrow died at Osceola, Iowa on January 26, 1922, at the age of seventy-five, and was buried in the Maple Hill Cemetery in that town.

Last Funeral of a Civil War Veteran

Sister Lori Parrott, along with her husband Gary, drove 1,800 miles to participate in the "Last Funeral of a Civil War Veteran" at Memphis, Missouri on May 28, 2005. For those that are not familiar with the situation, this was the first and only burial for Corporal John Payton Byrne of Co. I, 21st Missouri Infantry, USA. When he passed away in California in 1920 he was cremated and his ashes shipped back to Missouri to be claimed by the family. It wasn't until 84 years later that his great-great-great-grandniece, Margaret Gordon, discovered their existence while conducting genealogical research. There were over 1,600 participants and spectators present for the solemn two-day event, which featured representatives from many patriotic organizations.

MEMBERSHIP ELIGIBILITY

A male descendant, whether through lineal (direct ancestor) or collateral line (uncle) and not less than 14 years of age (6 to 14 years for Juniors), who: (1) is a blood relative (descendant or nephew) of a Soldier, Sailor, Marine or member of the Revenue Cutter Service, who was regularly mustered and served honorably in, was honorably discharged from or died in the service of the Army, Navy, Marine Corps or Revenue Cutter Service of the United States of America or in such state regiments called to active service and was subject to orders of United States general officers, between April 12, 1861 and April 9, 1865; (2) has never been convicted of any infamous or heinous crime and (3) has, or whose ancestor through whom membership is claimed has, never voluntarily borne arms against the government of the United States.
