Installation Ceremony Banquet

The newly elected officers for Phil Sheridan Camp Number 4 and Dr. Mary E. Walker Auxiliary Number 52 will be installed on **Saturday, the 28th of January 2006** at the Biltmore Hotel in Santa Clara, California.

Shortly you will receive the official invitation to this annual joint ceremony and banquet. The menu this year will be an all you can eat (within reason) buffet dinner with two main course entrees -- Roast Beef and Lemon Herb Chicken. It is essential that you complete the reservation form and return it, with your check, no later than the **12th of January** to guarantee that there will be more than enough for everyone.

The Installation Ceremony Banquet will be held in the **San Jose Room of the Biltmore Hote**l. The owner of Lou's Village, where our banquets have been held in the past, is retiring and closing his restaurant for good on the 31st of

December 2005. The Biltmore is conveniently located just off of Highway 101 at San Tomas Expressway, just north of American Legion Post 564 where our Camp meetings are held.

Following the dinner, and installation of both the Camp and Auxiliary officers for the year 2006 by **DEPARTMENT COMMANDER TAD CAMPBELL**, Brother **RICHARD STALEY** will provide the keynote presentation on the life and times of Civil War Veteran, and member of San Jose's Sheridan-Dix GAR Post 7, Charles L. Burdick.

This promises to be an exciting evening. Be sure to clear your calendar and return your reservation early to ensure that you have a place at

this annual event to kick off the New Year for the Sons Of Union Veterans of the Civil War, and Auxiliary, in Northern California.

VETERANS DAY PARADE

The 87th Annual Veterans Day Parade took place in downtown San José on November 11, 2005. This is the fifth year in a row that the Phil Sheridan Camp 4 has participated in this, the largest Veterans Day parade in Northern California, which is sponsored by the United Veterans Council (UVC) of Santa Clara County.

This year the Camp was once again joined by members of the Lincoln Camp 10 of Santa Cruz, the Dr. Mary E. Walker Auxiliary No. 52 of San José, the American Civil War Association (ACWA), and the National Civil War Association (NCWA). The procession was led by Brother **ROBERT J. KADLEC, PCC**, followed by the color guard, ranks of armed infantry, musicians, and finally Brothers **RICHARD STALEY** and **ROBERT NELSON** portraying veterans of the Grand Army of the Republic (GAR), who escorted the ladies of Auxiliary No. 52.

The combined Sons of Union Veterans of the Civil War contingent was honored to be the only organization in the entire parade to be allowed to stop in front of the reviewing stand and provide a demonstration. Once again our annual musket salute, lead by Brother PAUL E. LAVRISCHEFF. was a huge success and a real crowd pleaser!

During this moving ceremony, the names of all the deceased veterans honored during the past month were read, and the National Colors were retired in formal form by the Camp Color Guard. **BOB KADLEC PCC** acted as Master of Ceremonies, while Camp Commander **DAVE SCHLEETER** conducted most of the speaking parts. Department Commander **TAD CAMPBELL PCC** performed the duties of acting Chaplain. Members of the Camp Color Guard included **VINCENT BARTNING, DAN EARL, JOE MARTI**, and **STEVE WELCH**. Also attending the ceremony was Auxiliary No. 52 Sister **ANN SCHLEETER**. This year was the first time in memory that the public seating was completely filled, leaving standing room only!

A Message from the Secretary-Treasurer

Brothers, it is that time of year again for us to renew our membership dues for the Camp. Many of you probably wonder how your dues money is spent. A majority the \$35 each of you contribute - \$18 (or 51%) - is used to pay the



required dues renewal to our National Organization. Only \$3 (or 8.6%) of your dues is forwarded to the Department of California and Pacific. The remaining \$14 (40% of the total) stays here at home with your Camp. In the past your local dues (which, when separated from the National and Department per capita dues) provides your Camp with a working budget of about \$550 a year. This money has been used to compensate speakers at our meetings, publish and mail the Camp newsletter, pay for SUVCW badges, purchase Camp flags (and flag stands), various awards, entrance fees, and miscellaneous supplies associated with Memorial Day, Veterans Day and other patriotic events the Camp has participated in over the years. Additionally, if the Camp has the funds available, appropriate charitable contributions are made. Most expenses are borne by the individual who incurs them. With postage costs increase in 2006, it is even more important that we are diligent about promptly renewing our membership.

MEMBERSHIP ELIGIBILITY

A male descendant, whether through lineal (direct ancestor) or collateral line (uncle) and not less than 14 years of age (6 to 14 years for Juniors), who: (1) is a blood relative (descendant or nephew) of a Soldier, Sailor, Marine or member of the Revenue Cutter Service, who was regularly mustered and served honorably in, was honorably discharged from or died in the service of the Army, Navy, Marine Corps or Revenue Cutter Service of the United States of America or in such state regiments called to active service and was subject to orders of United States general officers, between April 12, 1861 and April 9, 1865; (2) has never been convicted of any infamous or heinous crime and (3) has, or whose ancestor through whom membership is claimed has, never voluntarily borne arms against the government of the United States.
