NELSON** provided to each Brother a complementary copy of his newly compiled history of Camp No. 4, which featured newspaper accounts of Camp activities between 1897 and 1960. This is the only known history of the Camp ever published and certainly fills in many of the gaps.

Department Commander TAD D. CAMPBELL PCC and his wife, Auxiliary President RACHELLE M. CAMPBELL, were honored to present Brother ROBERT J. KADLEC PCC, with a unique pocket watch in appreciation of his continued dedication and support of both Orders. The front of the watch was inscribed with Brother Bob's name and "S.U.V.C.W." The back was inscribed in memory of Bob's ancestor, Color Corporal Jacob Stauff of Company I, 26th Wisconsin Infantry, while the inside featured an image of Corporal Stauff. Brother Bob was also awarded the General Philip H. Sheridan Exemplary Dedication Award by Camp Commander DAVID C. SCHLEETER.


The California Regiment – 71st Pennsylvania Volunteers

Within a few days of the firing on Ft. Sumter, Edward D. Baker, Senator from Oregon, called upon his long time personal friend Abraham Lincoln and tendered his services in defense of the Union. President Lincoln suggested to Sen. Baker that he raise a regiment as he had done during the Mexican War.

On April 21st, Sen. Baker along with former citizens of the states of California and Oregon held a meeting in New York City. Those in attendance resolved to raise and offer to the United States a regiment of infantry, to be credited to the state of California. Recruiting went forward in and around Philadelphia and New York City. On May 16, 1861, twenty-five days later, the 1st California Regiment was mustered into service.

Initially called the 1st California, it was determined there were not enough Californians in the ranks and as a result, after the death of Baker in October 1861, the regiment was given to the state of Pennsylvania and re-designated the 71st Pennsylvania. Despite this new designation and lack of Californians, the Regiment was known throughout the war as the "California Regiment".



The Regiment served in the Eastern theater of war from 1861 to 1864. Assigned to the 2nd Corps of the Army of the Potomac, the 71st was engaged in some of the largest battles in the Eastern theater, including Antietam, Fredericksburg, Gettysburg, Spotsylvania, and Cold Harbor.

Did You Know?

The Battle of Valverde, in New Mexico Territory, was fought on February 21, 1862.

Colonel Christopher "Kit" Carson (1809-1868) commanded part of the Federal force and was brevetted for the action.

During a full day of fighting the Federals lost 68 men killed in action, 160 wounded, and 35 missing, out of 3,810 engaged. The Confederates lost 36 men killed in action and 160 wounded out of 2,600 engaged.

The night before the battle Captain James "Paddy" Graydon, commanding the "Spy Company" of New Mexico volunteers, packed six 24-pounder howitzer shells on the backs of two mules and led them close to the Confederate lines. The mules refused to cooperate by continuing into the Confederate camp and were blown up without damage to the enemy.

The "Spy Company" was made up almost entirely of local natives of Mexican origin and continually harassed General Sibley during his retreat.

MEMBERSHIP ELIGIBILITY

A male descendant, whether through lineal (direct ancestor) or collateral line (uncle) and not less than 14 years of age (6 to 14 years for Juniors), who: (1) is a blood relative (descendant or nephew) of a Soldier, Sailor, Marine or member of the Revenue Cutter Service, who was regularly mustered and served honorably in, was honorably discharged from or died in the service of the Army, Navy, Marine Corps or Revenue Cutter Service of the United States of America or in such state regiments called to active service and was subject to orders of United States general officers, between April 12, 1861 and April 9, 1865; (2) has never been convicted of any infamous or heinous crime and (3) has, or whose ancestor through whom membership is claimed has, never voluntarily borne arms against the government of the United States.
