
Changes to Department and Camp Web Sites



From the *Reno Evening Gazette* of September 20, 1947 comes this interesting Civil War tidbit:

Turtle Honored As Civil War Vet

WORCESTER, Mass., Sept. 20. (AP)—Willie Grout post, Sons of Union Veterans, will observe a moment of solemn silence Monday in honor of Myrtle, a turtle, who died Wednesday in New Brunswick, N. J. Myrtle was credited with being a veteran of the Civil War because of the words "Vicksburg, 1865" engraved on its shell.



MY CIVIL WAR ANCESTOR

DANIEL ENOCH TALBOTT Co. G, 8th Iowa Infantry Great-great granduncle of Linn W. Malaznik

Daniel Enoch Talbott was born about 1839 in Jackson County, Indiana, the son of Edward Talbott and Mary Merritt Laning. About 1851 the family moved to Iowa County, Iowa.

At Marengo, Iowa on September 3, 1861, Daniel E. Talbott enlisted in the Union Army for a period of three years. He was mustered in as a Private in Company G, 8th Iowa Infantry at Davenport, Iowa on September 20, 1861. The descriptive list states that he was aged 22 years, about 5 feet 9 inches tall, with light complexion, blue eyes and brown hair. His occupation was that of a farmer.

Soon after its organization, the regiment went to St. Louis, Missouri, and thence to Syracuse, where it joined Gen. John C. Fremont's army in pursuit of Confederate Gen. Sterling Price's forces and operated in southwestern Missouri, losing heavily through sickness. Private Talbott was soon detailed as company teamster. In November 1861 the regiment went to Sedalia, Missouri, where it remained until ordered to join Gen. Ulysses S. Grant's forces in Tennessee the following spring.

In April 1862, the regiment participated in the battle of Shiloh, Tennessee, fighting ten hours on

the first day. They repelled attack after attack, and, with the battery it was supporting, inflicted terrible punishment upon the enemy. They were the last to leave the advanced line of the army, being surrounded as it attempted to withdraw and compelled to surrender. Out of 650 men engaged, the regiment lost 64 killed, 100 wounded, and 47 missing. The 8th, 12th, and 14th lowa Regiments formed four-fifths of the little force that held back ten times its number at the close of the first day at Shiloh, giving Gen. Buell time to bring up his forces and snatch victory from defeat. Entirely cut off, they fought until they could fight no longer, and threw down their arms only to see many of their number shot down in cold blood after they had surrendered as prisoners of war.

Private Talbott was among those that were obliged to surrender at Shiloh on April 6, 1862. As a prisoner of war, he was initially held at Montgomery, Alabama, but subsequently taken to Camp Oglethorpe at Macon, Georgia, where he died of disease on July 26, 1862. Records indicate that his final burial place was in Andersonville National Cemetery, where he was counted among the unknown dead.

Two of Daniel's brothers are also known to have served in the Union Army, namely: Lewis W. Talbott of Company B, 1st Iowa Infantry and Company G, 47th Iowa Infantry; and Alexander A. Talbott of Company G, 28th Iowa Infantry.

Did You Know?

The Woodstock Races was a cavalry clash on October 9, 1864, at Tom's Brook, Virginia, precipitated by Gen. Philip H. Sheridan's scorchedearth program in the Shenandoah Valley. Confederate forces Thomas L. Rosser and Lunsford Lomax harassed Sheridan's army as it was withdrawing from the valley, and finally Sheridan ordered his cavalry to engage the Southerners, advising them to "either whip the enemy or get whipped yourself." Union horsemen under Wesley Merritt and George A. Custer routed the Southerners in a spirited two-hour fight near Fishers Hill. Merritt pursued Lomax twenty miles to Mount Jackson, capturing five guns. Custer drove Rosser to Columbia Furnace on the Back Road, taking six guns. The victory was not only an embarrassment to the Confederates, hence the use of the term "races." but it also resulted in the Federal cavalry attaining overall control of the valley.

Happy Birthday General Sheridan!



March 6th marks the 177th anniversary of the birth of our Camp's namesake, Major General Philip Henry Sheridan (1831-1888). Sheridan was born either in Ireland, at sea, New York, or Ohio. He later proclaimed his birthplace to be Albany, New York, but there still remains some uncertainty.

MEMBERSHIP ELIGIBILITY

A male descendant, whether through lineal (direct ancestor) or collateral line (uncle) and not less than 14 years of age (6 to 14 years for Juniors), who: (1) is a blood relative (descendant or nephew) of a Soldier, Sailor, Marine or member of the Revenue Cutter Service, who was regularly mustered and served honorably in, was honorably discharged from or died in the service of the Army, Navy, Marine Corps or Revenue Cutter Service of the United States of America or in such state regiments called to active service and was subject to orders of United States general officers, between April 12, 1861 and April 9, 1865; (2) has never been convicted of any infamous or heinous crime and (3) has, or whose ancestor through whom membership is claimed has, never voluntarily borne arms against the government of the United States.
