The National organization of the Sons of Union Veterans has established a Reserve Officer Training Corps (ROTC) Awards Program designed to recognize deserving ROTC and Junior ROTC cadets who have demonstrated patriotism, academic performance, and leadership qualities. This National program, operating with cooperation from the Department of Defense Military Reserve organization, is administered in Santa Clara County by Phil Sheridan Camp No. 4.

ARMED FORCES DAY PARADE

On April 16th, 2009 Phil Sheridan Camp No. 4, Gen. Alfred Pleasonton Camp No. 24 and Dr. Mary E. This parade coincided with Union City's celebration of the 50th anniversary of its official incorporation in 1959, when the communities of Alvarado, Decoto, and New Haven were merged to establish Union City.

Tribute was paid to the men and women of the Armed Forces on this the 60th anniversary of the establishment of Armed Forces Day with a black powder musket volley in front of the reviewing stand. Union City is only the second city that has permitted us to fire during a parade. Additionally, our participation in this parade witnessed the first appearance of a period wheelchair to transport an aging and decrepit GAR Comrade, portrayed by a spry Brother **ROBERT J. KADLEC, PCC**.





The United Veterans Council of Santa Clara County (UVC) Flag Lowering Ceremony at Oak Hill Memorial Park in San José will be held on June 28th. The flag in front of the Administration Building at the cemetery is flown each month in honor of the memory of deceased veterans. On the last Sunday of the month a formal ceremony is conducted by one of the member organizations of the UVC. Phil Sheridan Camp No. 4 will conduct the June ceremony. At least six Brothers, in uniform, will be needed to conduct the ceremony, which will begin at 2:30 pm and will last about 15 minutes. You will need to arrive at Oak Hill no later than 1:30 pm to receive your assignment and perform a "dry run." Please notify Camp Commander Frank Avila if you will be able to assist with this worthy event.

Independence Day Parade

For the fifth year in a row the Peninsula Celebration Association in Redwood City, California has invited Phil Sheridan Camp No. 4 to its Annual



Independence Day Parade. Again this year we expect to be ioined by Brothers from Col. Elmer Ellsworth Camp No. 23 and Gen. Alfred Pleasonton Camp No. 24, along with Sisters of Dr. Mary E. Memorial Day Weekend Activities

Sherwood Tent No. 89 of the Daughters of Union Veterans of the Civil War (DUVCW), again took part in the United Veterans Council of Santa Clara County's Memorial Day Ceremony at Oak Hill Memorial Park in San José. Campbell, PAP placed the wreath honoring the sacrifices of the soldiers, sailors and marines who saved the Union between 1861 and 1865. Brother Paul E. Sergeant LEONARD SCHLUSSEL, father of Auxiliary No. 52 President KAREN L. LAVRISCHEFF and a World War II Bronze Star and double Purple Heart recipient, placed the wreath honoring the memory of the World War II veterans. Brother RICHARD STALEY, in the guise of GAR Comrade C. L. Burdick, escorted by his wife JANICE and Tent No. 89 President SHARON POPE, placed the Decoration Day Tribute of flowers.

Ninety-four years ago, under the direction of Wheaton Camp No. 6 of the United Spanish War Veterans (USWV) and Sheridan-Dix Post No. 7 of the Grand Army of the Republic, along with Brothers and Sisters of Phil Sheridan Camp No. 4 of the SUVCW and the "Ladies Auxiliary," conducted a "ritualistic memorial service" at the Oak Hill GAR and USWV plots. A reprise of this event was performed for the second year in a row as Camp Commander Frank Avila led a Memorial Service at the GAR and USWV plots following the UVC ceremony. Assistant Chaplain RICHARD STALEY provided the invocation for the ceremony and summarized General John Logan's General Order No. 11, which in 1868 established what today has become known as Memorial Day.

Tent No. 89 President **Sharon Pope** and Brother **William Pope** placed a Civil War wreath in front of the GAR Monument. Past Department

Civil War Soldiers Finally Rest in Peace

Discovered two years ago in graves unearthed at a construction site, the remains of 61 Civil War-era veterans and three civilians were reinterred at Southern Arizona Veterans Memorial Cemetery in Sierra Vista, Arizona, May 16. The caskets were escorted along their route by American Legion Riders, the Arizona Highway Patrol, U.S. Border Patrol and other patriotic groups.

A memorial ceremony honored 22 California Volunteers who fought during the Civil War, and 39 regular Army troops who served at various times between 1866 and 1881. The remains

included those of three Army Indian scouts and one unknown Civil War veteran from the U.S. Colored Troops.

Many of the remains belonged to soldiers who were part of the California Column, a 2,300-man brigade that marched into the territory from California in 1862. Their mission was to confront Confederate troops and drive them out of the southern part of what is now Arizona and New Mexico. Troops from the California Column occupied Tucson in 1862 and various California units were stationed there until 1866.

Other remains represent the 1st, 3rd and 6th U.S. Cavalry regiments, as well as the 8th 21st and 32nd U.S. Infantry who served at Fort Lowell from the late 1860s to the 1880s.

Soldiers from nearby Fort Huachuca helped to carry the troops' remains – in small, U.S. flag-draped coffins – to a ceremonial staging area. Arizona's official balladeer, Dolan Ellis, sang "Amazing Grace," and Joe Joaquin said a prayer in his native Indian language. The 4th Cavalry Regimental Band provided music for the memorial ceremony, which was hosted by the Sons of Union Veterans of the Civil War.

The Department of California and Pacific took a prominent role in the ceremonies, with a number of Sons and Auxiliary members making the journey to Arizona to participate.

AUXILIARY HISTORY: The history of the Auxiliary to the Sons of Union Veterans is closely associated with the Grand Army of the Republic, which was founded

in 1866 and the Allied Orders who were later formed to continue their work. Post No. 94 of the Grand Army, Philadelphia, in 1878 created a Cadet Corps, which later became the Sons of Union Veterans. Similar units were organized throughout many neighboring States. In 1882, the first session of the Commandery-In-Chief, Sons of Veterans was held at Pittsburgh, Penn.

In later years, the name was changed to Sons of Union Veterans of the Civil War. The need for an Auxiliary was soon recognized and through the efforts of Major A.P. Davis, the first Ladies Aid Society was organized at Philadelphia, Pennsylvania in 1883 and in the following year was officially recognized as their Auxiliary. Ladies Aid Societies were formed in several States in rapid succession and in 1886 plans for a National Organization were formed, with the first National Encampment being held in Akron, Ohio, September 1887. At the National Encampment at Boston, Massachusetts in 1894, our name was changed to the Sons of Union Veterans Auxiliary, with it eventually becoming known as the Auxiliary to Sons of Union Veterans of the Civil War.

AUXILIARY PRINCIPLES: A firm belief and trust in Almighty God and realization that under his beneficent care and guidance the free institutions of our land, by the assistance and sacrifice of our veterans, have been preserved and the integrity and life of the Nation maintained.

True allegiance to the government of the United States of America, and a respect for devotion and fidelity to its Constitution and Laws, with a firm opposition to anything that may tend to weaken loyalty, or in any manner impair the efficiency and permanency of our nation.

AUXILIARY PURPOSE: We strive to assist the Sons of Union Veterans in keeping alive the memories of our ancestors and their sacrifices for the maintenance of the Union; to caring for helpless and disabled Veterans; to properly observe Memorial Day; to aid and assist worthy and needy members of our Auxiliary; to instill true patriotism and love of country; and to spread and sustain the doctrine of equal rights, universal liberty and justice to all. Our Auxiliary members, on national, state, and local levels participate in ceremonies and programs to commemorate events and honor leaders-and personalities of the Civil War period and events important to the history to the Grand Army of the Republic. Representatives of the National Organization attends wreath laying ceremonies at the impressive Lincoln Memorial on Lincoln's birthday, February 12th in Washington, DC; Lincoln Death Day ceremonies at Lincoln's Tomb, Springfield, Illinois on April 15th; Cathedral of the Pines, Ridge, New Hampshire. In November we travel to Gettysburg, Pennsylvania for Remembrance weekend. We participate in the parade and wreath laying ceremony at the monument of Albert Woolson, the last surviving member of the Grand Army of the Republic.

Did You Know?

- More than three million men fought in the war.
- Two percent of the population—more than 620,000—died in it.
- In two days at Shiloh on the banks of the Tennessee River, more Americans fell than in all previous American wars combined.
- During the Battle of Antietam, 12,401
 Union men were killed, missing or wounded; double the casualties of D-Day, 82 years later. With a total of 23,000 casualties on both sides, it was the bloodiest single day of the Civil War.
- At Cold Harbor, Va., 7,000 Americans fell in 20 minutes.
- Senator John J. Crittendon of Kentucky had two sons who became major generals during the Civil War: one for the North, one for the South.
- Ulysses S. Grant was not fond of ceremonies or military music. He said he could only recognize two tunes. "One was Yankee Doodle," he grumbled. "The other one wasn't."
- Missouri sent 39 regiments to fight in the siege of Vicksburg: 17 to the Confederacy and 22 to the Union.
- During the Battle of Antietam, Clara Barton tended the wounded so close to the fighting that a bullet went through her sleeve and killed a man she was treating.
- At the start of the war, the value of all manufactured goods produced in all the Confederate states added up to less than one-fourth of those produced in New York State alone.

MEMBERSHIP ELIGIBILITY

A male descendant, whether through lineal (direct ancestor) or collateral line (uncle) and not less than 14 years of age (6 to 14 years for Juniors), who: (1) is a blood relative (descendant or nephew) of a Soldier, Sailor, Marine or member of the Revenue Cutter Service, who was regularly mustered and served honorably in, was honorably discharged from or died in the service of the Army, Navy, Marine Corps or Revenue Cutter Service of the United States of America or in such state regiments called to active service and was subject to orders of United States general officers, between April 12, 1861 and April 9, 1865; (2) has never been convicted of any infamous or heinous crime and (3) has, or whose ancestor through whom membership is claimed has, never voluntarily borne arms against the government of the United States.
