## **Local Son Elected Commander-in- Chief**

DONALD BRADEN "BRAD" SCHALL of Lincoln, California was elected Commander-in-Chief at the 129th National Encampment of the Sons of Union Veterans of the Civil War in Overland Park, Kansas on August 14, 2010. He is the fourth Californian to be elected Commander-in-Chief, and the first since 1966.

Brad's eligibility for membership in the SUVCW comes from his two great-grandfathers, Sgt. William Braden Schall of the 11th Illinois Cavalry and Willis Reed, a Private in the 107th Illinois Infantry and Sergeant in the 1st Illinois Light Artillery.

Three uncles also served in the Union Army, namely: Capt. Absalom Schall of the 11th Pennsylvania Infantry, Corp. Andrew Jackson Schall of the 79th Pennsylvania Infantry, who was killed at the battle of Fair Oaks, and Pvt. Albert G. Schall of the 67th Pennsylvania Infantry. William Braden Schall and Absalom Schall were both members of the Grand Army of the Republic (GAR). Brad has also identified an additional twenty-two relatives who fought for the Union.

Brad is the oldest son of Donald Braden Schall, Sr. and Anna Mae (Griggs) Schall, and has one brother and five sisters. He was born in Hutchinson, Kansas where his "Nana Schall" introduced him to the Civil War history of his family and the Joseph Hooker Post of the GAR. Among his prize possessions are his great grandparents' GAR and Woman's Relief Corps (WRC) encampment ribbons and badges. Both his grandmother and great-grandmother were members of the WRC. His brother **WILLIAM**, son **BRADEN** and grandson **CHRISTOPHER** are also members of the SUVCW.

His interest in the Civil War goes back to his childhood, when he lived one block from the Lincoln Civil War Memorial in Hutchinson, Kansas. As a child, his family participated in Memorial Day services with descendants of members of the Joseph Hooker Post No. 17, GAR, of which his great-grandfather had been a

member. Brad's family decorated the graves of their great-grandfather and other Civil War soldiers at East Side Cemetery in Hutchinson with flags and flowers.

Brad joined the Phil Sheridan Camp No. 4 in San José, California in the mid-1990s, and over the years has held nearly every position in the several Camps to which he has belonged. He was the organizer of the Gen. Alfred Pleasonton Camp No. 24 in 1999.

He was elected Commander of the Department of California and Pacific in 2002 and 2003.

At the national level Brad has served as a member of the following committees: Civil War Memorials, eBay Surveillance, Constitution & Regulations, and Civil War Sesquicentennial; and as Chairman of the Civil War Memorial Grant Fund, Fraternal Relations, and Life Membership Committees. He has also served as National Patriotic Instructor, National Chief of Staff, Junior Vice Commander-in-Chief, and was twice elected to the National Council of Administration. Brad has also served as the co-chair of the SUVCW Charitable Foundation.

Brad continues to remain active in the Sacramento and San Francisco Bay areas with the Gen. George Wright Camp No. 22 and the Gen. Alfred Pleasonton Camp No. 24.

In 2002, Brad sold his meat brokerage business and retired to Lincoln, California. His business career in the food industry started at Safeway while in school, and he spent seventeen years at the Quaker Oats Company in sales, sales management and sales promotion. He left Quaker Oats to spend ten years in the export/import business and then as general manager of a Con Agra Distribution Company in California. He went to the meat industry after that and finally ended his career by owning his own business for the last eight years.

Brad belongs to the California Historical Society, Kansas State Historical Society, Derry Pennsylvania Historical Society, Genealogical Society of Pennsylvania, Fort Larnard Old Guard, Friends of Gettysburg, Gettysburg Battlefield Association, Lincoln Forum, California State Military Museum, Sacramento and San Francisco Civil War Roundtables, Co-Chairman of the Friends of Civil War Alcatraz, Volunteer National Park Service Docent at Alcatraz Island in San Francisco, National Eagle Scout Association, manager of the Sun Eagles senior softball team, Fellowship of Christian Athletes and is a veteran of the United States Army.

In addition to his family heritage, Brad is particularly proud of his wife, Patti, his five children, twelve grandchildren, and one great-grandchild.

Brad has dedicated his year of service as Commander-in-Chief to his two great-grandfathers who served in the Civil War, to his parents who taught him the love of country, respect for family members who came before, the love of God and the exciting history of the American Civil War, and to his mentor, the late Bob Lowe, PDC.

The following summary was provided by Past Commander-in-Chief **JAMES B. PAHL** of Michigan:

“Very productive Encampment, but mixed news for the brothers of the Order. Interest income from our investments is very low. After much cutting, the budget was still coming up almost \$40,000.00 in the red. Brothers voted to increase national per capita by \$5.00. We realize this will be tough on many Brothers, but the Encampment felt this was necessary . . . We are forming committees to see if we can shift investments for a higher yield (anyone with investment experience is asked to contact **RICHARD ORR**, so the special committee can call upon them. Another special committee is being formed to study the whole financial situation and come up with longer-term solutions. If every Brother recruited and brought one new member into the Order, our financial woes would be so relieved. One thing considered by the Brothers was no longer print *The Banner*, but publish on the web site and send e-mail to the Brothers when posted. This was rejected, as it is one of our best recruiting tools and one thing every brother of the Order can hold in their hand, to see their per capita to National at work.

**D. BRAD SHALL** from California is the new Commander-in-Chief. **DR. DON PALMER** from Missouri is the Senior Vice Commander-in-Chief, **PERLEY MELLOR** from Massachusetts is the Junior Vice Commander in Chief. **GENE MORTORFF** from the Maryland Department is National Secretary. **RICH ORR** [of Pennsylvania] is still National Treasurer and **DANNY WHEELER** [of New York] is still National Quartermaster. **BILL VIEIRA** from Rhode Island was reelected to National Council of Administration, as was **BOB PETROVIC** from Missouri. **ALAN RUSS** from Kansas was elected to finish out the last year of Perley Mellor's term on the Council of Administration.”

## Department Charter & Banner Conservation Donation Request

Phil Sheridan Camp No. 4 is accepting donations to support its pledge of \$300 that was approved during the June 26th Camp meeting for the acquisition and conservation of the 1890's Department Charter and Department Banners.

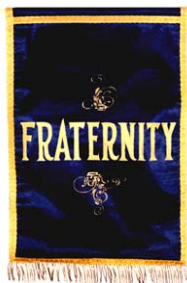
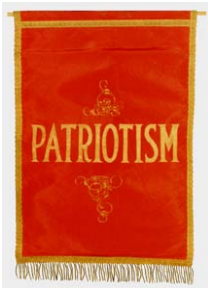
Department Commander Charlie Mabie advised that Department Brothers were recently able to recover the 1890's Department Charter that was about to go up for sale on eBay. The Charter, and Department Banners, went missing a number of years ago when a Department officer passed away and the Department property in his possession was inadvertently lost when his estate was liquidated. The Department Brothers were able to negotiate the purchase of the Charter for \$750 to avoid any potential lengthy and costly legal procedure to recover the SUVCW property.

In 1994, a member of Phil Sheridan Camp No. 4 living in Nevada spotted the Department Banners in an antique store in Reno. He notified the Department Secretary-Treasurer who in turn notified the owner of the antique store that the Banners were Department property and would have to be returned. The owner of the store was unwilling to turn it over for free. Fearing that it would disappear before legal action was effective, the Department purchased the Banners for between \$500 and \$750.



Both the Charter and the Department Banners are deteriorating rapidly and will need restoration/conservation. The cost for this may exceed several hundred dollars. The Department will be sponsoring the 2012 National Encampment which will be extremely expensive and is therefore not in a position to reimburse the Brothers who recovered this historic property. Therefore, the Department is soliciting donations to cover the expenses for the acquisition and conservation of the 1890's Department Charter and Banners.

During the Camp meeting on Saturday, June 26, 2010, the membership approved the allocation and sending of \$300 to the Department as a combined Camp and membership contribution toward the cost of recovery and conservation of these items. Because this is an unbudgeted Camp expense, the Camp is soliciting donations from its membership to help in covering this expense. Therefore, should you be willing and able to support this effort, it is requested that you send a donation to the Camp (in any amount) for which you will receive an official letter of gratitude along with documentation to support a deduction on your 2010 tax return.

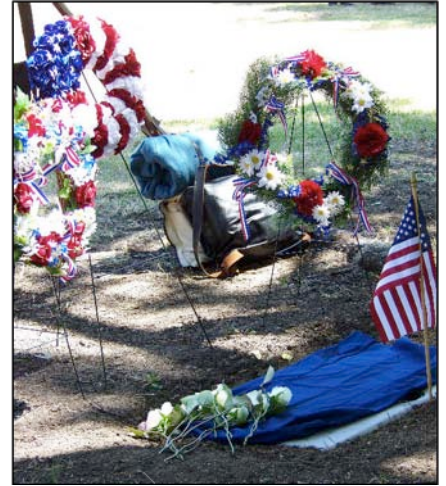

# TOMBSTONE ERROR CORRECTED

For over 85 years, Pvt. Samuel Brown, an African-American member of the 137th U.S. Colored Infantry, a former slave, and a Comrade of the Grand Army of the Republic, had been resting under a headstone stating his service was for the Confederacy. Through the efforts of Brother **JOE MARTI** of the Phil Sheridan Camp No. 4 the mistake was corrected on July 24, 2010, with about 100 members of the soldier's family present for the re-

Brother Marti and the SUVCW were featured prominently in a television news segment, which aired throughout the San Francisco Bay Area. The event was also

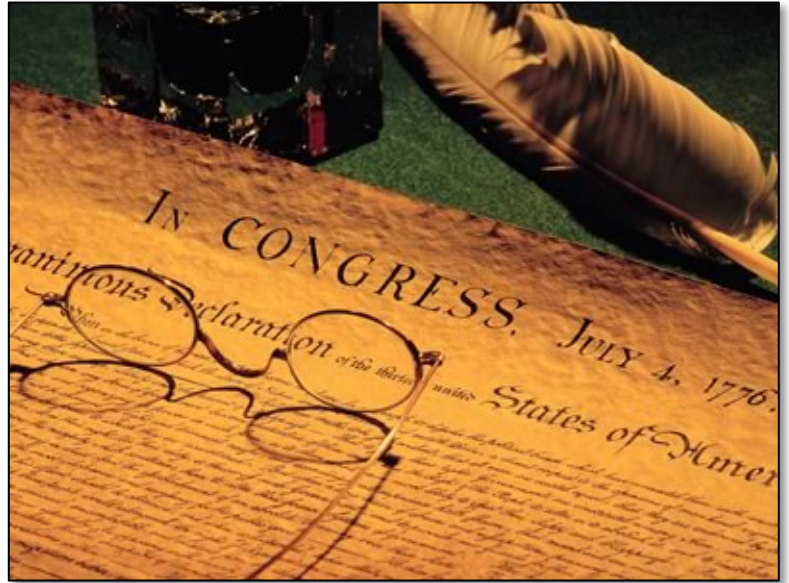


**Dept. President Rachele Campbell talks to Pvt. Brown's granddaughter after the ceremony.**

## **Did You Know?**

### **Kansas in the Civil War**

Kansas entered the Union as the thirty-fourth state on January 29, 1861. Less than three months later, on April 12, Fort Sumter was attacked by Confederate troops and the Civil War began. In Washington rumors were afloat that President Abraham Lincoln was to be kidnapped or assassinated. James H. Lane, a senator from Kansas, recruited 120 Kansas men who were in the city and organized them into the "Frontier Guard." For nearly three weeks they were billeted in the White House to protect the President.

Most Kansans strongly favored the cause of the Union. Governor Charles Robinson at once began recruiting troops for the Union armies, and Senator Lane returned from Washington to do the same. Before the war ended the federal government issued several calls for troops, asking Kansas for a total of 16,654. More than 20,000 "Jayhawkers" enlisted, however, and the state contributed 19 regiments and four batteries to the Union forces. Although many of these volunteer soldiers hailed from states other than Kansas, this was a remarkable showing for an infant state with only 30,000 men of military age. Kansas soldiers suffered nearly 8,500 casualties.

More devastating than any battle between regular troops in Kansas were the raids and pillaging of guerilla bands. Such raids and atrocities were committed by both sides, but by far the most heinous came on August 21, 1863. William Clark Quantrill and several hundred followers hit Lawrence at dawn, before they left much of the town had been destroyed and nearly 200 men and boys lay dead.

#### ***SUVCW Membership Eligibility***

A male descendant, whether through lineal (direct ancestor) or collateral line (uncle) and not less than 14 years of age (6 to 14 years for Juniors), who: (1) is a blood relative (descendant or nephew) of a Soldier, Sailor, Marine or member of the Revenue Cutter Service, who was regularly mustered and served honorably in, was honorably discharged from or died in the service of the Army, Navy, Marine Corps or Revenue Cutter Service of the United States of America or in such state regiments called to active service and was subject to orders of United States general officers, between April 12, 1861 and April 9, 1865; (2) has never been convicted of any infamous or heinous crime and (3) has, or whose ancestor through whom membership is claimed has, never voluntarily borne arms against the government of the United States.
