For the first time in 39 years, the Department of California and Pacific was honored to host the annual National Encampments of the Allied Orders of the Grand Army of the Republic. The Encampments took place at the Los Angeles Airport Marriott on August 9-11, 2012. All of the Allied Orders were present with the exception of the Woman's Relief Corps, which was previously committed to meet in Springfield, Illinois.

The strong Camp No. 4 contingent consisted of TODD ARMSTRONG, CHRIS AVILA, FRANK AVILA, DAN BUNNELL, TAD CAMPBELL, DAN EARL, DEAN ENDERLIN, JOE FERMAN, DICK FERMAN, ADAM GAINES, TOM GRAHAM, BOB KADLEC, RICK LAROSA, PAUL LAVRISCHEFF, LINN MALAZNIK, JOE MARTI, and DAVE SCHLEETER. There were actually more Camp Brothers in attendance than the number of delegates allotted to the entire Department!

Auxiliary No. 52 members in attendance included RACHELLE CAMPBELL, DEBBIE EARL, CINDY EDDY, BEV FERMAN, BEV GRAHAM, KATHY MABIE, and ROBYN REESE.

These numbers are even more impressive when one considers the travel involved. The distance from the base of the Camp to the Encampment hotel is equivalent to driving from Baltimore, Maryland to either Providence, Rhode Island or Cleveland, Ohio. Many Camp and Auxiliary members travelled even farther!

The following highlights of the SUVCW business sessions were compiled by James B. Pahl, PCinC:

- Ninety-nine brothers were present on the floor of the National Encampment at the time the doors were closed for election of National Officers.
- PERLEY MELLOR of the Department of Massachusetts was elected Commander-in-Chief.
- KEN FRESHLEY of the Department of Ohio was elected Senior Vice Commander-in-Chief.
- TAD CAMPBELL of the Department of California and Pacific was elected Junior Vice Commander-in-Chief.
- National Council of Administration: **STEVE HAMMOND** of the Department of the Chesapeake was reelected to a three-year term, and **DON SHAW** of the Department of Michigan was elected for a three-year term to the position vacated by Tad Campbell.
- A new Life Member Program was adopted, creating five brackets. There is no payout to the Camps, however, the plan allows for interest and principal payments to National's General fund of \$23.00 per year. The breakdown is as follows:

Age under 40 = \$1,000.00 Age 61 to 70 = \$300.00 Age 41 to 50 = \$700.00 Age 71+ = \$200.00

- The Ritual was amended to allow veterans of the U.S. Armed Forces to render a hand salute rather than removing the hat or cap during the playing of the National Anthem, *The Star Spangled Banner*.
- A special committee was formed for the purpose of examining the proposed fundraising plan submitted by Glenn Knight PDC, consider other options and recommend a plan at the 132nd National Encampment.
- The Patriotic Instructor's recommendation to develop a visual/audio program for Camps and Departments was approved. Memorial University is to be redesigned to a simpler, more user-friendly format.
- The National Civil War Memorials Committee is almost ready to place their new database online.
- The National Organization relinquished any claim they might have upon the published works of the Grand Army of the Republic contained in the HathiTrust Digital Library and requested the HathiTrust Digital Library open said works up for access by the general public.
- A proposal to waive National Per Capita dues for a dual member for other than his primary Camp was resoundingly defeated.
- A new GAR Records Project Plan was adopted, which includes: consolidating information into Microsoft Excel spreadsheets, expanding the spreadsheets to allow for additional information, converting those spreadsheets into a web-ready format, placing this data into a separate internet domain specifically for the GAR Records Project, launching a new GAR Records Project information web site and standardizing forms for public use in submitting information on the whereabouts of GAR records.
- Approved the purchase of a commercial pop-up tent to be donated to the Lincoln Monument Association, for use during ceremonies at the Lincoln tomb during inclement weather.



Did You Know?

150 Years Ago — 1862

- July 1 Battle of Malvern Hill, the last of the Seven Days' Battle. The Confederates suffered more than 5,300 casualties without gaining an inch of ground. Despite his victory, Maj. Gen. George B. McClellan withdrew to entrench at Harrison's Landing on the James River, where his army was protected by gunboats, ending the Peninsula Campaign.
- **July 2** Lincoln issues a call for 300,000 three-year enlistments.
- **July 11** President Lincoln names Henry Halleck General-in-Chief.
- **July 12** Congress authorizes the Medal of Honor for gallantry in action for non-commissioned officers and privates.
- **July 14** U.S. Senate passes a bill creating West Virginia.
- **August 2** The U. S. Congress passes the first federal income tax, 3% on earnings greater than \$800 dollars.
- August 14 Under orders from Halleck, McClellan withdraws from the Peninsula.
- August 22 General Benjamin Butler authorizes the enlistment of "free Negroes".
- **August 28** The Federal Bureau of Printing and Engraving begins operations.
- August 28-30 Second Battle of Bull Run. Gen. Pope blamed the Union defeat on Gen. Fitz John Porter, who Pope believed had failed to carryout orders. Porter was cashiered and not vindicated until 1886, but Pope himself was never again trusted with field command.

SUVCW Membership Eligibility

A male descendant, whether through lineal (direct ancestor) or collateral line (uncle) and not less than 14 years of age (6 to 14 years for Juniors), who: (1) is a blood relative (descendant or nephew) of a Soldier, Sailor, Marine or member of the Revenue Cutter Service, who was regularly mustered and served honorably in, was honorably discharged from or died in the service of the Army, Navy, Marine Corps or Revenue Cutter Service of the United States of America or in such state regiments called to active service and was subject to orders of United States general officers, between April 12, 1861 and April 9, 1865; (2) has never been convicted of any infamous or heinous crime and (3) has, or whose ancestor through whom membership is claimed has, never voluntarily borne arms against the government of the United States.
