

UNITED SPANISH AMERICAN WAR VETERANS BURIAL PLOT TO BE REDEDICATED

On September 6, 2014 the Camp and Auxiliary will be rededicating the Spanish-American War plot, almost forty years to the day that Wheaton Camp No. 8, United Spanish American War Veterans (USWV), was formally disbanded.

In 2012 the signage for the Span-Am veterans plot was damaged and Oak Hill has graciously replaced this marker at no cost to us. With our ongoing history of cooperation, we will serve to rededicate this plot to the memory of those who served during 1898-1901 campaigns.

A special thanks goes to **Father William J. Stout**, who most generously bestowed the Wheaton Camp No.8, USWV records to our Camp. **Bro. Tad D. Campbell, PDC** had spoken with him concerning these records several years ago, and this discussion was renewed during the Memorial Day exercise at Oak Hill this year. Father Stout's father was one of the last four surviving members of Wheaton Camp, and had tasked his

son to find a safe repository for their materials. We will remember - we will not let them be forgotten!

Did You Know?

150 Years Ago — 1864

July 30 – Union troops besieging Petersburg, Virginia use a mine to blow a hole in the Confederate defenses. However the troops sent in cannot advance further and many are slaughtered at the bottom of the "Crater" in what one officer later described as a "turkey shoot". Rather than retreat, General Burnside sends in a division of the U. S. Colored Troops who are also trapped. Many are killed even after surrendering. Also among the outfits taking heavy casualties is Co. K, First Michigan Sharpshooters, men who are mostly Ottawa and Chippewa or Oiibwa Indians. As a result of this debacle. Burnside will never command troops again. The siege will continue for 8 more months.

August 5 – As Union ships enter Mobile Bay, Admiral David Glasgow Farragut on board the USS Hartford cannot see what is happening because of the thick smoke so he climbs the rigging with his telescope. Worried about commander's safety, the captain sends a man up to tie Farragut to the rigging. As the battle continues, Farragut, warned of dangerous mines [then called torpedoes] ahead, cries, "Damn the torpedoes, full speed ahead." The Union fleet makes it through the minefield and past 2 forts to defeat the Confederate fleet.

SUVCW Membership Eligibility

A male descendant, whether through lineal (direct ancestor) or collateral line (uncle) and not less than 14 years of age (6 to 14 years for Juniors), who: (1) is a blood relative (descendant or nephew) of a Soldier, Sailor, Marine or member of the Revenue Cutter Service, who was regularly mustered and served honorably in, was honorably discharged from or died in the service of the Army, Navy, Marine Corps or Revenue Cutter Service of the United States of America or in such state regiments called to active service and was subject to orders of United States general officers, between April 12, 1861 and April 9, 1865; (2) has never been convicted of any infamous or heinous crime and (3) has, or whose ancestor
