Remembrance Day

Phil Sheridan Camp No. 4 held its sixth annual Remembrance Day Ceremony at the Camp owned Grand Army of the Republic (GAR) plot at Oak Hill Memorial Park in San Jose, California on November 16th. This year's service was conducted by the Camp Guard, as many of the Camp's members were in Gettysburg, Pennsylvania to participate in the annual Remembrance Day Ceremony and Parade there on the occasion of the 151st anniversary of the dedication of the Gettysburg National Cemetery. Camp Senior Vice Commander (SVC) JOHN E. STOLP led the service at the GAR plot containing over 400 Union Civil War Veterans. Brother RICHARD FERMAN fulfilled the role of Chaplain while Brother JOSEPH FERMAN acted as Color Bearer for the Pledge of Allegiance and National Anthem. Camp Junior Vice Commander (JVC) PAUL LAVRISCHEFF recited President Lincoln's Gettysburg Address.



The service remembered and honored all those who served at Gettysburg in 1863 and gave specific recognition to three veterans of the battle buried in the GAR plot at the Oak Hill. While the Camp Guide, Brother Joe Ferman, identified the locations of each Gettysburg veteran, SVC John E. Stolp presented their individual service records, as follows:

- Samuel Kingston, enlisted as a Private in Company K of the 13th Pennsylvania Reserve Infantry (also known as the 42nd Pennsylvania Infantry and the 1st Pennsylvania Rifles) on July 31, 1861, was seven times wounded and captured and paroled twice. At the Battle of Gettysburg he received his last two wounds, which resulted in his discharge in September 1863 due to his being crippled for life. He was a member of San Jose's John A. Dix GAR Post and passed away in January 1907 and was buried in the GAR Plot at Oak Hill.
- George Washington Lee enlisted in Company M of the 2nd Massachusetts Cavalry, the "California Battalion", on January 19, 1863. He was captured the following year and survived Andersonville Prison. Upon release at the end of the war, Lee returned to California and joined San Jose's John A. Dix GAR Post. He died on June 20, 1923 and was buried in the GAR Plot at Oak Hill.
- Albert B. Cash enlisted in 1862 as a Sergeant in Company L, 6th Michigan Cavalry. He served in General Custer's Brigade and later served under General Philip Sheridan. He was wounded at Gettysburg in July 1863. Cash participated

in over eighty engagements and was discharged in December of 1865. He was a prominent citizen and farmer in Santa Clara County and Captain-General of the San Jose Commandery No. 10 of the Knights Templar in California. Cash passed away on June 3, 1926 and is buried in the GAR Plot at Oak Hill.

For the fourteenth year in a row, members of the two Department of California & Pacific Camps, along with members of Company C of the 8th California Volunteer Infantry Regiment of the Sons of Veterans Reserve, participated in the parade in downtown San Jose, California. Dr. Walker's Remedies

News from Dr. Mary E. Walker Auxiliary No. 52

FIGHTING FOR THE UNION

With the outbreak of war in 1861, women and men alike eagerly volunteered to fight for the cause. In the Northern states, women organized ladies' aid societies to supply the Union troops with everything they needed, from food (they baked and canned and planted fruit and vegetable gardens for the soldiers) to clothing (they sewed and laundered uniforms, knitted socks and gloves, mended blankets and embroidered quilts and pillowcases) to cash (they organized door-to-door fundraising campaigns, county fairs and performances of all kinds to raise money for medical supplies and other necessities).

But many women wanted to take a more active role in the war effort. Inspired by the work of Florence Nightingale and her fellow nurses in the Crimean War, they tried to find a way to work on the front lines, caring for sick and injured soldiers and keeping the rest of the Union troops healthy and safe.

In June 1861, they succeeded: The federal government agreed to create "a preventive hygienic and sanitary service for the benefit of the army" called the United States Sanitary Commission. The Sanitary Commission's primary objective was to combat preventable diseases and infections by improving conditions (particularly "bad cookery" and bad hygiene) in army camps and hospitals. It also worked to



provide relief to sick and wounded soldiers. By war's end, the Sanitary Commission had provided almost \$15 million in supplies—the vast majority of which had been collected by women—to the Union Army.

Nearly 20,000 women worked more directly for the Union war effort. Working-class white women and free and enslaved African-American women worked as laundresses, cooks and "matrons," and some 3,000 middle-class white women worked as nurses. The activist Dorothea Dix, the superintendent of Army nurses, put out a call for responsible, maternal volunteers who would not distract the troops or behave in unseemly or unfeminine ways: Dix insisted that her nurses be "past 30 years of age, healthy, plain almost to repulsion in dress and devoid of personal attractions." (One of the most famous of these Union nurses was the writer Louisa May Alcott.)

Army nurses traveled from hospital to hospital, providing "humane and efficient care for wounded, sick and dying soldiers." They also acted as mothers and housekeepers—"havens in a heartless world"—for the soldiers under their care.

Did You Know?

150 Years Ago — 1864

November 5 – The Confederate government dumps some 8,000 Union prisoners on the prison at Salisbury, North Carolina. Eventually more than 10,000 men will be confined in a hellhole even worse than Andersonville.

- November 8 Lincoln, running against Gen. George B. McClellan, is re-elected by more than 400,000 popular votes including votes by soldiers in the armies. This move by several states to allow the men in the field to vote while away from home is a first in U. S. history. Andrew Johnson of Tennessee is the new Vice President.
- November 15 Sherman issues orders to destroy everything of military value in Atlanta.
- **November 16** Sherman leaves Atlanta with 62,000 men and begins his 300-mile "March to the Sea".
- November 30 The Battle of Franklin in Tennessee is a disaster for the Confederates. In a head-on attack over a mile of open ground, the Confederates lose 6,200 men.
- **December 7-27** The Union launches a combined land-sea attack on Fort Fisher, which defends the approaches to Wilmington, North Carolina, which ultimately fails.
- December 15-16 In Tennessee Confederate General John Bell Hood with 31,000 men waits outside Nashville, held by General George H. Thomas and 55,000 troops: Hood hopes to lure Thomas into an attack outside the city. Thomas finally attacks on the 15th and the Confederates are pushed back onto a new line. In the morning another Federal attack forces Hood to retreat, having lost about half of his men.
- **December 21** Sherman's march to the sea concludes with the capture of Savannah.

SUVCW Membership Eligibility

A male descendant, whether through lineal (direct ancestor) or collateral line (uncle) and not less than 14 years of age (6 to 14 years for Juniors), who: (1) is a blood relative (descendant or nephew) of a Soldier, Sailor, Marine or member of the Revenue Cutter Service, who was regularly mustered and served honorably in, was honorably discharged from or died in the service of the Army, Navy, Marine Corps or Revenue Cutter Service of the United States of America or in such state regiments called to active service and was subject to orders of United States general officers, between April 12, 1861 and April 9, 1865; (2) has never been convicted of any infamous or heinous crime and (3) has, or whose ancestor
