

# Camp Members Elected to Head of MOLLUS Commandery

On June 11, 2022, Camp Brother **TAD D. CAMPBELL** was unanimously elected Commander of the California Commandery of the Military Order of the Loyal Legion of the United States (MOLLUS). The California Commandery was established on April 12, 1871 and includes Alaska, Arizona, California, Hawaii, Idaho, Nevada, Oregon, Utah, and Washington.

Camp Brother LINN W. MALAZNIK, who had previously held the office, was elected Treasurer of the Commandery. Other officers elected were RANDY DHINDSA of Clovis, California as Vice Commander and WAYNE ROGERS of Menifee, California as Registrar.

### History of MOLLUS

On April 15, 1865, as word of President Abraham Lincoln's death spread throughout the country, three Union Army officer friends met in Philadelphia to discuss the tragic news. Rumors from Washington of a conspiracy to destroy the Federal government by assassination of its leaders prompted the three officers to call other officers and ex-officers together to form an organization that could help thwart future threats to the national government. A mass meeting of Philadelphia veterans was held on April 20, 1865 to pledge renewed allegiance to the Union and to plan for participation in the funeral arrangements for the President. The Philadelphia officers, who served as an honor guard for President Lincoln's funeral cortegé, met again after the funeral was over to establish a permanent organization of officers and exofficers patterned after the Society of the Cincinnati established after the Revolutionary War. The name they chose, The Military Order of the Loyal Legion of the United States, first appeared in a notice calling for a meeting on May 31, 1865 at Independence Hall. By 1899, the Loyal Legion has more than 8,000 Civil War officer members, known as Original Companions, on its roster. At its zenith, the Loyal Legion counted practically every prominent officer among its ranks. Among them were Generals Ulysses S. Grant and William T. Sherman; Lieutenant Generals Philip H. Sheridan, Nelson A. Miles and John M. Schofield; Major Generals George Armstrong Custer, Winfield Scott Hancock, George B. McClellan, Rutherford B. Hayes, David McMurtrie Gregg and Grenville M. Dodge; Real Admirals Bancroft Gherardi and George W. Melville. In addition to Ulysses S. Grant and Rutherford B. Hayes, Original Companions Chester A. Arthur, Benjamin Harrison and William McKinley served as President of the United States. MOLLUS ultimately adopted provisions for hereditary membership, permitting descendants of eligible officers to become members.

Specifies that a member of multiple Allied Orders, while under suspension from one of the Allied Orders, may not attend SUVCW functions while representing themselves as a member of the order from which they are under suspsension, but may attend if representing themselves as a member of an Allied Order of which they are in good standing.

#### GENERAL ORDER No. 16 (21 Jun 2022)

#### **Suspension of the Department of Kentucky**

Suspends the Department of Kentucky for failure to file required annual reports.

#### **GENERAL ORDER No. 17** (23 Jun 2022)

#### **Revocation of General Order 16**

Revokes General Order No. 16 and lifts the suspension of the Department of Kentucky.

# 160 Years Ago — Civil War Anniversaries

### January 1862

• **January 30** – The first U.S. ironclad warship, USS *Monitor*, is launched.

### February 1862

- **February 1** Julia Ward Howe's "Battle Hymn of the Republic" is published for the first time in the *Atlantic Monthly*.
- **February 6** Gen. Grant gives the U.S. its first victory of the war, by capturing Fort Henry, Tennessee.
- **February 11-16** Gen. Grant attacks Fort Donelson, Tennessee, capturing it on the last day.
- February 21 Battle of Valverde Confederate forces defeat Union troops near Fort Craig, in New Mexico Territory.
- **February 22** Jefferson Davis is officially inaugurated in Richmond, Virginia, to a 6-year term as president of the Confederate States of America.

### March 1862

- March 7 Battle of Pea Ridge The Confederates are shut out of Missouri.
- March 8 Ironclad CSS Virginia (formerly USS Merrimack) is launched at Hampton Roads, Virginia; the Battle of Hampton Roads starts the same day.



- March 13 The U.S. federal government forbids all Union army officers from returning fugitive slaves, thus effectively annulling the Fugitive Slave Act of 1850, and setting the stage for the Emancipation Proclamation.
- March 26-28 Battle of Glorieta Pass In New Mexico, Union forces succeed in stopping the Confederate invasion of New Mexico Territory.

### April 1862

 April 5 – Battle of Yorktown - The battle begins when Union Army forces under Gen. McClellan close in on the Confederate capital of Richmond, Virginia. • **April 6-7** – Battle of Shiloh - The Union Army, under Gen. Grant, defeats the Confederates near Shiloh, Tennessee.



- April 12 Great Locomotive Chase (Andrews' Raid) - Union volunteers steal Confederate steam railroad locomotive *The General* in an attempt to sabotage the rail network.
- April 25 Capture of New Orleans Forces under Union Admiral David Farragut occupy the Confederate city of New Orleans, securing access to the Mississippi River.
- **April 26** Siege of Fort Macon The besieged Confederate garrison in North Carolina surrenders.

### May 1862

- May 11 Ironclad CSS Virginia is scuttled in the James River northwest of Norfolk, Virginia.
- May 15 U.S. President Abraham Lincoln signs a bill into law creating the U.S. Bureau of Agriculture (later renamed U.S. Department of Agriculture).
- May 20 U.S. President Abraham Lincoln signs the Homestead Act into law.

### June 1862

- **June 1** Battle of Fair Oaks Both sides claim victory.
- **June 4** Confederate troops evacuate Fort Pillow on the Mississippi River, leaving the way clear for U.S. Army troops to capture Memphis, Tennessee.
- **June 6** First Battle of Memphis U.S. Army troops capture Memphis, Tennessee.
- June 8 Battle of Cross Keys Confederate troops under Gen. Stonewall Jackson save the Army of Northern Virginia from a U.S. Army attack on the James Peninsula that is led by Gen. McClellan.
- June 26 Battle of Mechanicsville Confederate Gen. Robert E. Lee defeats the troops of Gen. McClellan in the first of the Seven Days Battles.

#### SUVCW Membership Eligibility

A male descendant, whether through lineal (direct ancestor) or collateral line (uncle) and not less than 14 years of age (6 to 14 years for Juniors), who: (1) is a blood relative (descendant or nephew) of a Soldier, Sailor, Marine or member of the Revenue Cutter Service, who was regularly mustered and served honorably in, was honorably discharged from or died in the service of the Army, Navy, Marine Corps or Revenue Cutter Service of the United States of America or in such state regiments called to active service and was subject to orders of United States general officers, between April 12, 1861 and April 9, 1865; (2) has never been convicted of any infamous or heinous crime and (3) has, or whose ancestor through whom
