The whole event was on Zoom and lasted about 2 hours. Kudos to the amazing teachers who allowed us to do this event with them. Hopefully we can do more of this in the coming months and next year.

## **Juneteenth**

Juneteenth (short for "June Nineteenth") marks when federal troops in Galveston, Texas in 1865 to take control of the state and ensure that all enslaved people be freed. The troops' arrival came a full two and a half years after the signing of the Emancipation Proclamation. Juneteenth honors the end to slavery in the United States and is considered the longest-running African American holiday. On June 17, 2021, it officially became a federal holiday. Confederate General Robert E. Lee had surrendered at Appomattox Court House two months earlier in Virginia, but slavery had remained relatively unaffected in Texas—until U.S. General Gordon Granger stood on Texas soil and read General Orders No. 3: "The people of Texas are informed that, in accordance with a proclamation from the Executive of the United States, all slaves are free."In Texas, slavery had continued as the state experienced no large-scale fighting or significant presence of Union troops. Many enslavers from outside the Lone Star State had moved there, as they viewed it as a safe haven for slavery. After the war came to a close in the spring of 1865, General Granger's arrival in Galveston that June signaled freedom for Texas's 250,000 enslaved people. Although emancipation didn't happen overnight for everyone—in some cases, enslavers withheld the information until after harvest season—celebrations broke out among newly freed Black people, and Juneteenth was born. That December, slavery in America was formally abolished with the adoption of the 13th Amendment.

#### General W S Rosecrans Camp 2



In addition to Camp 2's very active Memorial Day weekend, there are a couple of things that may be of interest.

Camp 2 was given a certificate of appreciation from the L.A. County Assessor, for our "contributions to restore and preserve Woodlawn Memorial Park." Unfortunately, when the volunteer organization, One Section At A Time (OSAAT,) tried to get support from the National SUVCW, the man they talked to blew them off, and did not even take a moment to direct them to Camp 2. They got the Walker Family Foundation involved, and the foundation's founder actually did all of the work on the GAR cannon. flagpole. Through Br. Glen Roosevelt's contacts in L.A. County, we got brought in after the fact. Glen is now working on getting a retroactive grant for monument preservation, to reimburse the two nonprofits for their expenses. I got Camp 2 to approve a \$100 donation, and I matched it with a personal donation. So, Camp 2 has contributed \$200 to partially offset their expenses, and Glen also gave them a donation, which I believe is from Camp 17, but I do not know the amount. Glen is now working with the Walker Family Foundation to restore a flagpole/monument to Spanish American War Veterans buried there.

So far, and I expect it will be all for this year, I have sent out **seven** JROTC awards to Cadets at area high schools, and **two** awards to Cadets in the Army, and Air Force, ROTC program at UCLA. I was able to attend the UCLA Air Force ROTC virtual awards ceremony to present our award, as well as the virtual awards ceremony at Garfield H.S. (Photos attached.) I may attend an in-person awards ceremony, this Friday, at North Torrance H.S., if no other Brother volunteers to be our presenter.

#### **Generals Sedgwick-Granger Camp 17**



May 31, 2021 marked the 106<sup>th</sup> Anniversary of "The Soldiers' Monument" that was dedicated at Santa Ana Cemetery in 1915. The Daughters of Union Veterans (DUV) dedicated this monument "To the Unknown Dead of the Civil War 1861-65".

Because of the Covid-19 restrictions, there is no public ceremony held at Santa Ana Cemetery this year. Camp Commander Wayne Eder, Department JVC and 6th MD SVR Commander, led the ceremony and discussed the practice of placing coins on veterans graves as members of the local historical society questioned the practice. All members of Camp 31 are also members of Battery A, 3rd US Artillery, SVR of the 6th Military District SVR. A three gun salute was fired from a reproduction 12-pound Model 1841 Coehorn Mortar. The Camp's newest addition, Junior Member Wayne L. Eder II participated and fired his first artillery (blank) round from the mortar.
