Memorial Day

Camp 25 had a good turnout for our participation in Memorial Day Services at the Reno GAR Cemetery, along with American Legion Post 1, their associated Boy Scouts of America Troup, and members of the Battle Born Chapter of the SAR. We formed up to fire a rifle salute in honor of our fallen Civil War brothers. Afterwards we fired a salute in the Hill Top Cemetery over a group of Civil War Veterans and by invitation at the adjacent the Knights of Pythias Cemetery for their Memorial Day service. Several Civil War veterans are also interred there.

Cancellation of 20th Anniversary Dinner

Unfortunately, in the judgment of our Commander and Vice Commander the interest was not there to hold a 20th Anniversary Dinner, so it has been canceled. If brothers wish to propose alternative events, they should bring their ideas to the upcoming meeting.

Nevada Veteran's Memorial Plaza Brick

OUR CIVIL WAR ANCESTORS

Private George O Johnson

George O Johnson was born to John and Frances (Peterson) Johnson, Corinth, Maine in 1841. George

served as a Private in the Maine 11th Infantry, H Company. A book written in 1896 entitled "The Story of One Regiment, The 11th Maine Infantry" compiled by a committee of the Regimental Association, goes into great detail about the regiment and their activities. They were organized and mustered on 12 November 1861 and began their move to Washington. On the way, they drafted a song which included their desired mission to "Hang Jeff Davis to a sour apple tree". They arrived in Washington on the 16th of November and camped at Fort Knox.

In March 1862, they advanced to Manassas, Va., on March 10th to 15th, then Newport News on March 28th. They fought at the siege of Yorktown from April 5th to May 4th and the Battle of Williamsburg on May 5th. The participated in operations about Bottom's Bridge on May 20th to 23rd, the the Battle of Fair Oaks and Seven Pines on May 31st and June 1st, and Guard Bottom's Bridge from June 13th to 26th. They destroyed a railroad bridge over Chickahominy on June 27th, the Bottom's Bridge June 28th and 29th. They were at White Oak Swamp on June 30th, Malvern Hill on July 1st and at Harrison's Landing until August 15th.

They moved to Yorktown August 16–22, and performed garrison duty there until December 26, with an expedition to Matthews County from December 11–15. They moved further south to Morehead City, N.C., December 26-January 1, 1863, and then to Port Royal, S.C., January 28–31. They were on to St. Helena Island February 10, and served duty there until April 4. Expedition against Charleston April 4–12. At Beaufort, S.C., until June. Moved to Fernandina, Fla., June 4–6, and duty there until October 6. (A detachment acting as artillery on Morris Island, S.C., during siege of Fort Wagner, and operations against Charleston, July to October 1863.)

The regiment moved to Morris Island October 6 and conducted siege operations against Charleston until April 1864, then were ordered to Gloucester Point, Va. Butler's operations on south side of James River and against Petersburg and Richmond May 4-June 15. Occupation of City Point and Bermuda Hundred May 5. Port Walthal May 6–7. Ware Bottom Church May 9. Swift Creek or Arrowfield Church May 9–10. Operations against Fort Darling May 12–16. Drury's Bluff May 14–16. Bermuda Hundred May 17-June 20. Action at Bermuda Hundred June 2 and 14. Port Walthal, Bermuda Front, June 16–17. Siege operations against Petersburg and Richmond June 16, 1864, to

April 2, 1865. Deep Bottom June 20 and 25. Grover House, Deep Bottom, July 21. New Market Heights, Deep Bottom, July 27–28. Strawberry Plains August 14–18.

In trenches before Petersburg August 27-September 26. New Market Heights September 28-29. Chaffin's Farm September 29-30. Darbytown and New Market Roads October 7. Darbytown Road October 13. Fair Oaks October 27–28. Chaffin's and Johnson's Farms October 29. Non-veterans left front for muster out November 7. Duty on north side of James River before Richmond until March 27, 1865. (Detached for duty at New York City during election of 1864, November 5– 17, 1864.) Moved to Hatcher's Run March 27-29. Appomattox Campaign March 28-April 9. Assault and capture of Forts Gregg and Baldwin and fall of Petersburg April 2. Pursuit of Lee to Appomattox April 3–9. Rice's Station April 6. High Bridge April 7. Clover Hill, Appomattox Court House, April 9. Surrender of Lee and his army. Duty at Richmond, Va., April 24 to November 24, and at Fredericksburg, Va., until January 19, 1866. Mustered out at City Point, Va., February 2, 1866.

George married Clara Hamilton on January 1, 1867 in Corinth. Unfortunately,

George only lived 8 more years, and died on 17 Feb 1875. Clara's death would follow just months later, on 18 January 1876. This left their 4 children, all under 10 years without old, their One parents.



daughter, Anna, my Great Grandmother, was adopted by her aunt. Her name became Anna May (Johnson) Allen, and she would marry Nathan Clifford Grover of Bethel, Maine on 12 June 1900. They lived in Washington DC where Nathan worked as a civil engineer.

SUVCW

Founder Augustus P. Davis

A.P. Davis was born in Gardiner, Maine and was the son of Anthony and Mary Davis, and at the age of 14 Davis left home and travelled to San Francisco as part of the 1849 California Gold Rush. His



dreams of finding a fortune did not come to pass and he renewed his career as a sailor in 1850. He worked on various ships and eventually enlisted in the Royal Navy for four years during the Crimean War. He was discharged from the Royal Navy, and in 1860 he returned home to his family in Maine.



Shortly after the attack on Fort Sumter. Davis volunteered serve in the 11th Maine Volunteer Infantry Regiment and was elected as captain of Company F on May 11, 1861. Shortly afterwards, they were sent south to serve with Army of the James,

and in April 1862 Davis was detached from the 11th Maine and detailed as Provost Marshal of the division commanded by Major General Silas Casey, where he was wounded in action at the Battle of Fair Oaks and spent several weeks recovering in the hospital.

On March 7, 1863, Davis resigned from the Army and returned to Maine. The resignation was accompanied by a surgeon's certificate dated the same day that stated, "he has tubercular deposits in the right lung,

with pleuritic adhesions on that side. In consequence, I believe the exposure incident to field service will very soon assuredly break down his health." Soon after Davis' arrival in Maine, on April 24, 1863, he was appointed as Provost Marshal for the 3rd District of Maine and re-commissioned as captain. He held this position until he was honorably discharged on August 15, 1865. On June 22, 1867 Davis received a brevet to the rank of major to date from March 15, 1865.

After the war, in 1866, Davis married Mary Ann Gilpatrick, and they had one son, Herbert Anthony Davis, before she died in 1872. Three months later, Davis married Lizzie E. Parks, and on advice of his doctor they moved to Pittsburgh, Pennsylvania to live in a drier climate. In Pittsburgh, Davis pursued a career as an insurance executive. Davis' second son, Charles K. Davis, was born in Pittsburgh shortly after his arrival.

He joined Alexander Hays Post 3 of the Grand Army of the Republic in Pittsburgh. On January 14, 1880, and he was elected as a Veteran Companion of the First Class of the Pennsylvania Commandery of the Military Order of the Loyal Legion of the United States (MOLLUS), and assigned MOLLUS insignia number 1981.

On November 12, 1881, Davis organized the first camp of the Sons of Veterans of the United States of America (SV) which would later be renamed as the Sons of Union Veterans of the Civil War (SUVCW). In his original conception, the SV was to be a military training program for young men aged 14 and above. In addition to instilling discipline and patriotism, the SV was also intended to be a military reserve force which could be called on in time of war.

Although Davis was ineligible for membership in the SV, in August 1884 Davis was declared by the SV's Commander-in-Chief to be a Past Commander-in-Chief and a Past Grand Division Commander and was given the privilege of joining the camp of the SV of his own choosing.

In the first two decades since its founding, the SV grew to have departments in most states other than those which were part of the Confederacy. Its membership peaked in 1904 when it had about 200,000 members. Today there are over 6,000 members.

Although Grand Army of the Republic (GAR) never allowed an officially affiliated with the SUVCW, the ties between the two organizations were strong, and on

February 13, 1954, Albert Woolson, the last surviving member of the GAR, signed a deed of conveyance giving all remaining GAR property to the SUVCW.

- I. Opening
 - 1. Meeting call to order by Commander Davis at 1308 hours
 - 2. Pledge of Allegiance was led by Commander Davis
 - 3. Invocation was given by Chaplain Donn Dalton
 - 4. Roll Call: D. Dalton, D. Davis, J. Dickey, C. Ehlers, D. Hess, D. Perdue, F. Wood

- II. Commander's Report
 - 1. Commander Davis introduced guests Jenny Davis and Monica Moriarty.
 - The Department Encampment was March 17-18, 2023, at the Four Points by Sheraton in Bakersfield. Info is on Dept. website. New Dept. Commander is Stephen Doyle of the Inland Empire's Stoneman Camp 18. The DSVC is our very own Dr. Wayne Eder. I

- am still the Dept. Historian and GAR Records Officer. See Dept. website for more details.
- 3. We did a full-page advertisement in the Encampment program. The cost was \$25.
- 4. As part of TMCC's general interest courses called EPIC (Educational Programs Inspiring the Community), I will be teaching a 3-hour class on Nevada's Military Role in the Civil War on June 19 and conducting a cemetery tour on June 3.
- 5. Patriots' Day, April 19, 8:30-10:30 a.m. at Biscotti's Restaurant in the Peppermill American Heritage Partnership and Battle Born Patriots Chapter, SAR, will have an event at Biscotti's Restaurant in the Peppermill for \$15. There will be breakfast and a Zoom talk about the favored meeting place of the Sons of Liberty, the Green Dragon Tavern of Boston.

III. Secretary's Report.

- Secretary Hess referred the members to the Minutes published in the last edition of the Camp 25 Dispatch and asked for any changes. Being none there was a MOTION TO APPROVE (M/S Lorenz/Dalton). THE MOTION PASSED UNANIMOUSLY.
- 2. Secretary Hess reported two new applications in that have been received and are in the review process. Those applications are from STAN RAHN and BERNIE HAMM.

IV. Treasurer's Report.

- Treasurer Hess presented the Financial Statement for Camp 25 as of March 31, 2023 (SEE EXHIBIT 1). MOTION TO APPROVE(Perdue/Dickey). MOTION PASSED UNANIMOUSLY.
- 2. In completing the Camp's Annual Report (Form 27), the form indicated that the Department per capita was increased from \$3 to \$10. Treasurer Hess, however, was verbally assured by Department Secretary Randy Dhinsa that the Department per capita remains at \$3. It still remains that the national organization increased their dues to \$33 (formerly \$23). MOTION TO raise the dues to \$50 beginning in 2024 (Hess/Perdue). THE MOTION PASSED UNANIMOUSLY.
- 3. Fundraisers. The consensus is that we do that with fundraisers. Some ideas were discussed

but the issue remains open for further discussion. [ADDED COMMENT: Treasurer Hess knows of a consultant who specializes in helping small nonprofits raise funds. Should he make contact?]

V. Senior Vice Commander's Report

- 1. Brick. We approved \$200 for the brick but the price went up to \$300. From Camp 25-\$100, from Donn Dalton--\$150, from David Perdue--\$50. Dave Perdue has ordered the brick and asked that we be present when the brick is laid.
- 2. Member Certificates: David Perdue passed out several different versions that he designed. The consensus was to grant Brother Perdue permission to proceed with the design of a certificate based on the examples shown. There was some discussion on how to pay for it. It was felt that the cost could be covered by Rob Stoecklin's donation which was restricted to buying medals and certificates for new members.
- 3. Brother Perdue also circulated examples for a Certificate of Ancestors and a Certificate of Commendation.
- 4. Dinner in June chaired by SVC Purdue with Commander Davis on the committee. Purdue asked who could make a committee meeting next week to work out all the details.

Don contacted the Army. The request went to Program Manager Sarah N. Parsons, of the U.S. Army Criminal Investigation Laboratory. She then sent the request to Physical Science Technician Lisa Abreu with a CC to Assistant Director Michael Hill. On March 7, Lisa contacted Don asking if anyone had contacted him yet. Since then no response.




